WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

That for and in consideration of **FIVE HUNDRED THOUSAND AND NO/100 (\$500,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **RODNEY W. ANNIS and CAROLYN J. ANNIS, husband and wife, and PATRICIA A. ANNIS, an unmarried woman,** (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **ERIC ROBERT BROWN and PAMELA SUSAN DIETLEIN-BROWN,** (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

Lot 24, in Block 7, according to the Amended Map Woodford, as recorded in Map Book 8, Page 51 A, B, C & D, in the Probate Office of Shelby County, Alabama.

Subject to:

The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


