**FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of May, 2007, Sheila Alldredge Odom, Single, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, at Document Number 20070613000277810, said mortgage having subsequently been modified and transferred to Nationstar Mortgage LLC D/B/A Mr. Cooper (“Transferee”); and


