\$0.00 (zero) of the consideration was paid from a mortgage loan.

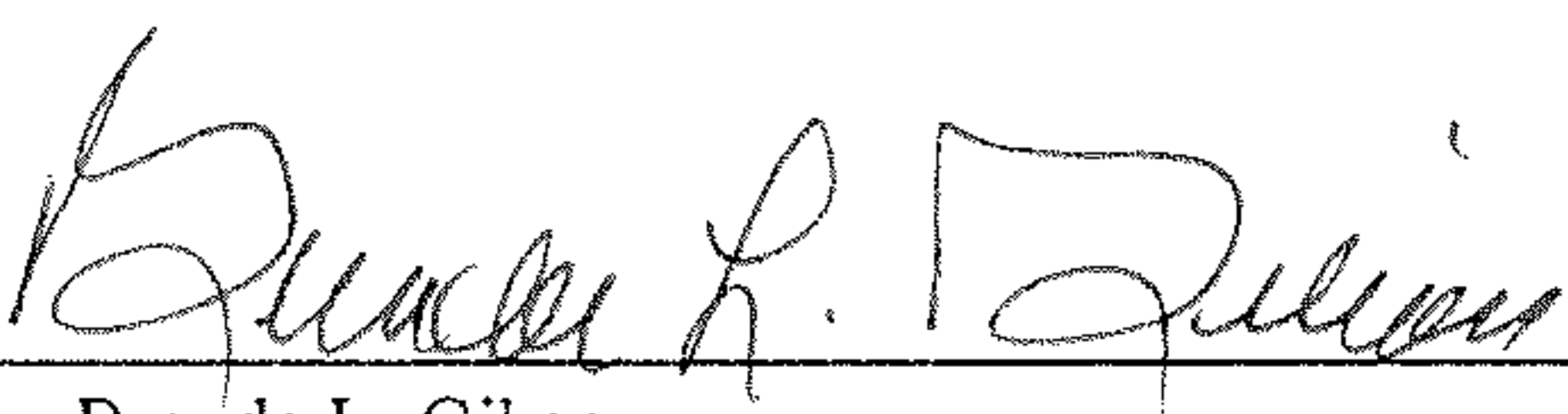

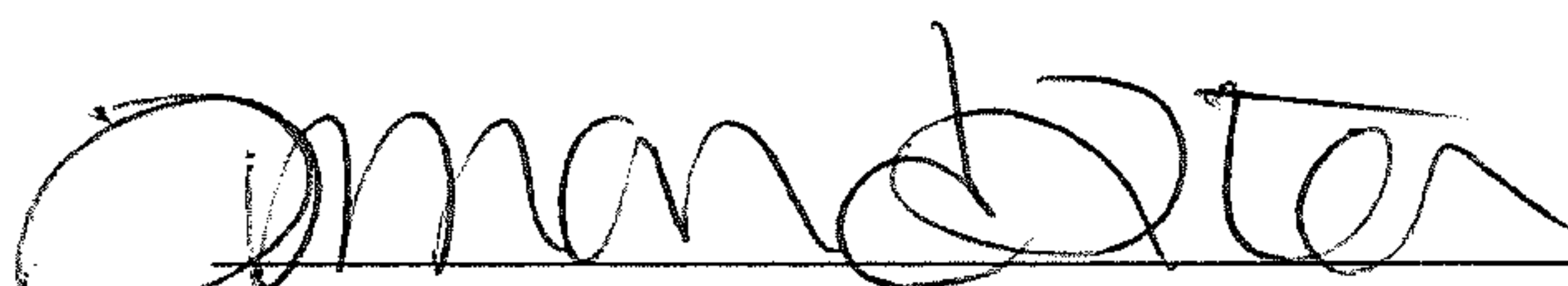

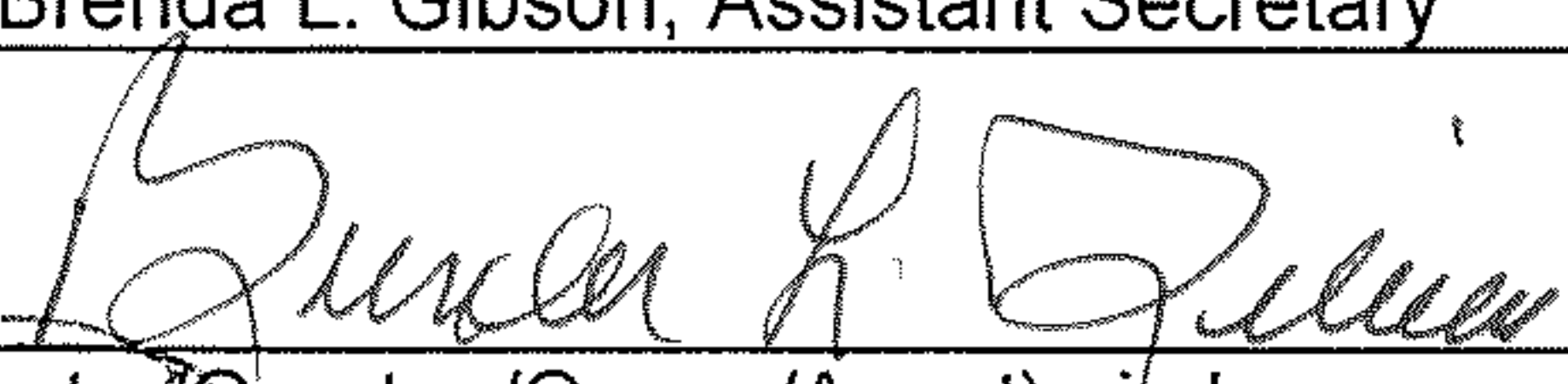
