LAST WILL AND TESTAMENT OF LEIGH LEBOFF FARRIS

I, Leigh LeBoff Farris, of SHELBY, Alabama, revoke my former Wills and Codicils and declare this to be my Last Will and Testament.

ARTICLE I IDENTIFICATION OF FAMILY

I am married to Billy Ralph Farris II and the failure of this Will to provide for any distribution to Bill Ralph Farris II is intentional.

The names of my children are Billy Farris III, Sydney Farris James and Lame Leboff Durst. All references in this Will to "my children" are references to the above-named children.

ARTICLE II PAYMENT OF DEBTS AND EXPENSES

I direct that my just debts, funeral expenses and expenses of last illness be first paid from my estate.

ARTICLE III DISPOSITION OF PROPERTY

Residuary Estate. I direct that my residuary estate be distributed to my children in equal shares. If a child of mine does not survive me, such deceased child's share shall be distributed in equal shares to the children of such deceased child who survive me, by right of representation. If a child of mine does not survive me and has no children who survive me, such deceased child's share shall be distributed in equal shares to my other children, if any, or to their respective children by right of representation. If no child of mine survives me, and if none of my deceased children are survived by children, my residuary estate shall be distributed to my heirs-at-law, their identities and respective shares to be determined under the laws of the State of Alabama, then in effect, as if I had died intestate at the time fixed for distribution under this provision.

ARTICLE IV NOMINATION OF INDEPENDENT EXECUTOR

I nominate Lame LeBoff Durst, of Pelham, Alabama, as my Independent Executor, to serve without bond, surety, or other security. If such person or entity does not serve for any reason, I

nominate Jennie Winger, of Mobile, Alabama, to serve as my Independent Executor, to serve without bond, surety, or other security.

ARTICLE V EXECUTOR POWERS

A. <u>Power to Administer Estate</u>. My Independent Executor, with respect to my estate, in addition to other powers and authority granted by law or necessary or appropriate for proper administration, shall have the following rights, powers, and authority without order of court and without notice to anyone: to identify, gather, value, secure, manage and distribute assets, to maintain records, to settle and wind up business affairs, to pay just debts, to file necessary tax returns, to redirect mail, to cancel services, to establish trusts, and to carry out my wishes as set forth in this Will.

B. <u>Independent Administration</u>. My Independent Executor shall have the right to administer my estate using "informal", "unsupervised", or "independent" probate or equivalent legislation designed to operate without unnecessary intervention by the probate court.

ARTICLE VI SPECIAL DIRECTIVES

I hereby state, that in addition to the directives and bequests as set forth in this Will, it is my desire and wish to include the following special directives and last wishes: To be cremated and ashes scattered in the ocean at a location chosen by my children

ARTICLE VII MISCELLANEOUS PROVISIONS

- A. <u>Paragraph Titles and Gender</u>. The titles given to the paragraphs of this Will are inserted for reference purposes only and are not to be considered as forming a part of this Will in interpreting its provisions. All words used in this Will in any gender shall extend to and include all genders, and any singular words shall include the plural expression, and vice versa, specifically including "child" and "children", when the context or facts so require, and any pronouns shall be taken to refer to the person or persons intended regardless of gender or number.
- B. Thirty Day Survival Requirement. For the purposes of determining the appropriate distributions under this Will, no person shall be deemed to have survived me unless such person is also surviving on the thirtieth day after the date of my death.
- C. <u>Liability of Fiduciary</u>. No fiduciary who is a natural person shall, in the absence of fraudulent conduct or bad faith, be liable individually to any beneficiary of my estate, and my estate shall indemnify such natural person from any and all claims or expenses in connection with or arising out of that fiduciary's good faith actions or nonactions of the fiduciary, except for such actions or nonactions which constitute fraudulent conduct or bad faith. No successor trustee shall be

obliged to inquire into or be in any way accountable for the previous administration of the trust property.

- D. Compensation. The Executor is entitled to receive reasonable compensation for their services under this Will and be exonerated from and to pay all reasonable expenses and charges of the estate and trust.
- E. Intentional Exclusion. The failure of this Will to provide for any distribution to the following person(s) or organization(s) is intentional: Billy Ralph Farris II
- F. Beneficiary Disputes. If any bequest requires that the bequest be distributed between or among two or more beneficiaries, the specific items of property comprising the respective shares shall be determined by such beneficiaries if they can agree, and if not, by my Independent Executor.
