KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two Hundred Nine Thousand Five Hundred And No/100 Dollars (\$209,500.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Gabriel D. Robbins, a married person (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Thomas G. Hall and Jamie Hall (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

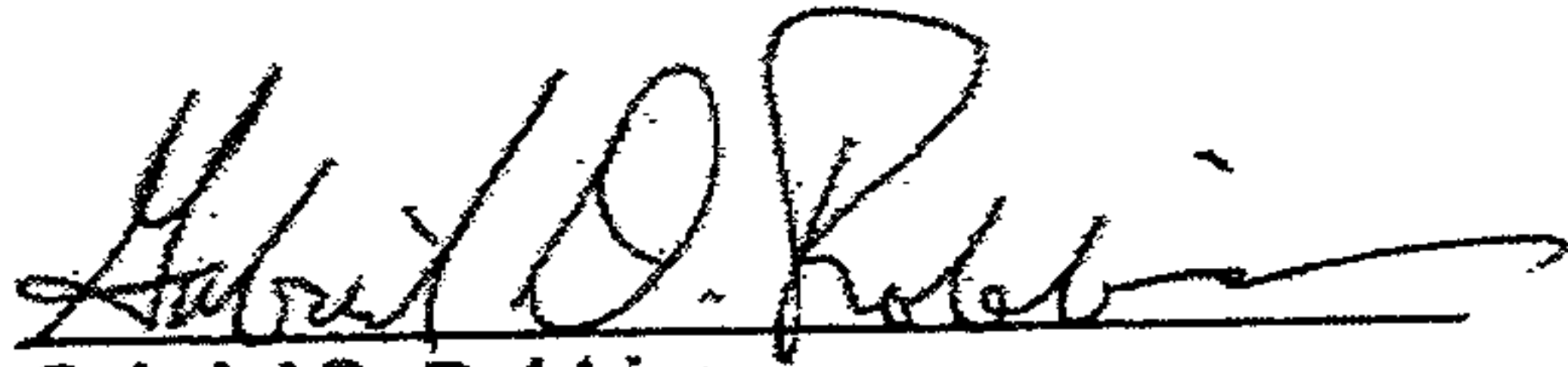
The property herein conveyed does not constitute the Homestead of the Grantor nor that of his/her spouse.

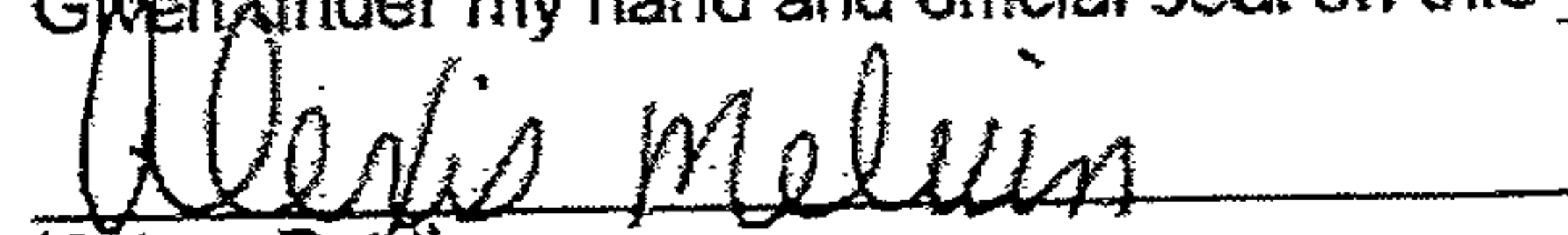

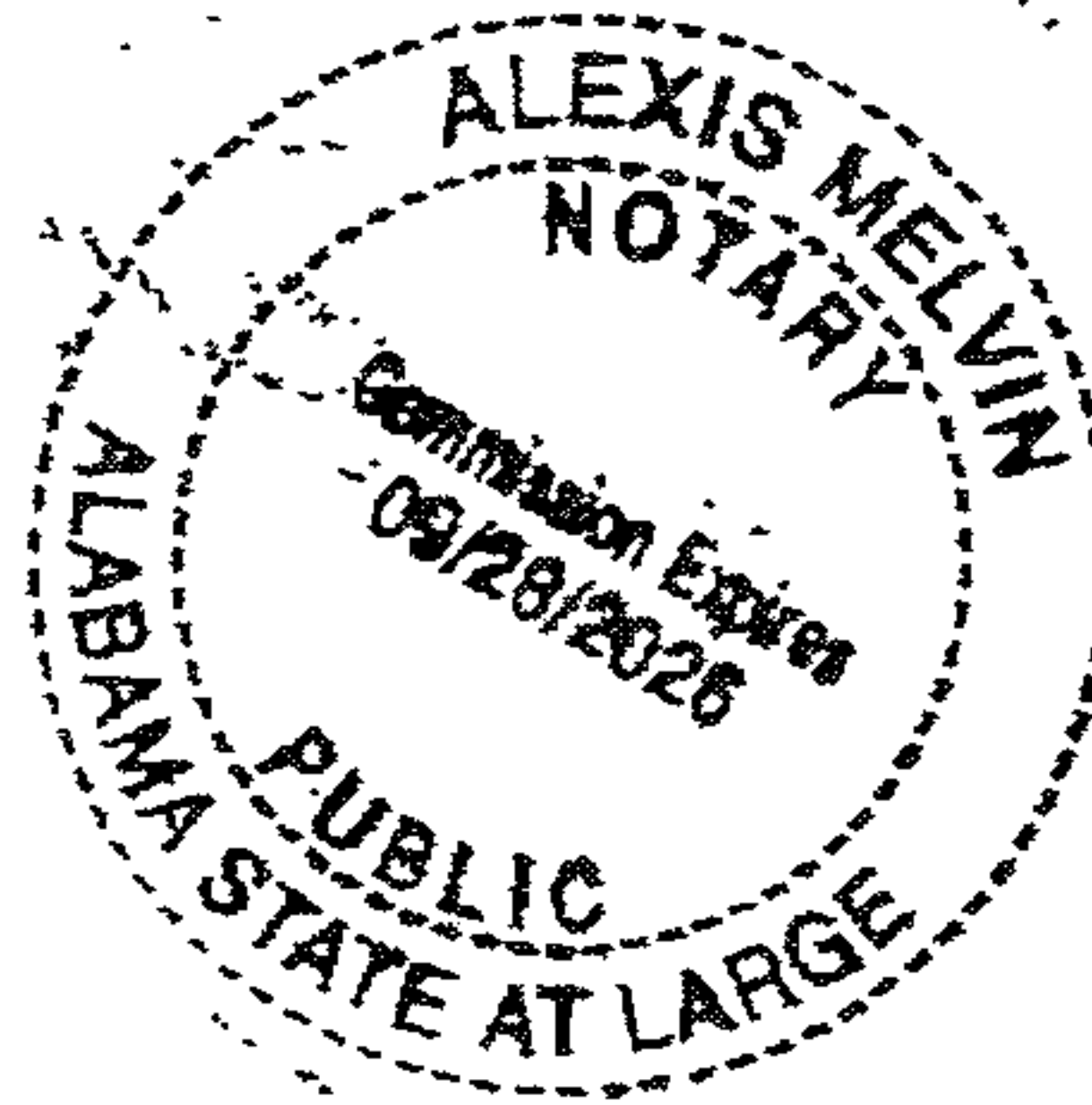

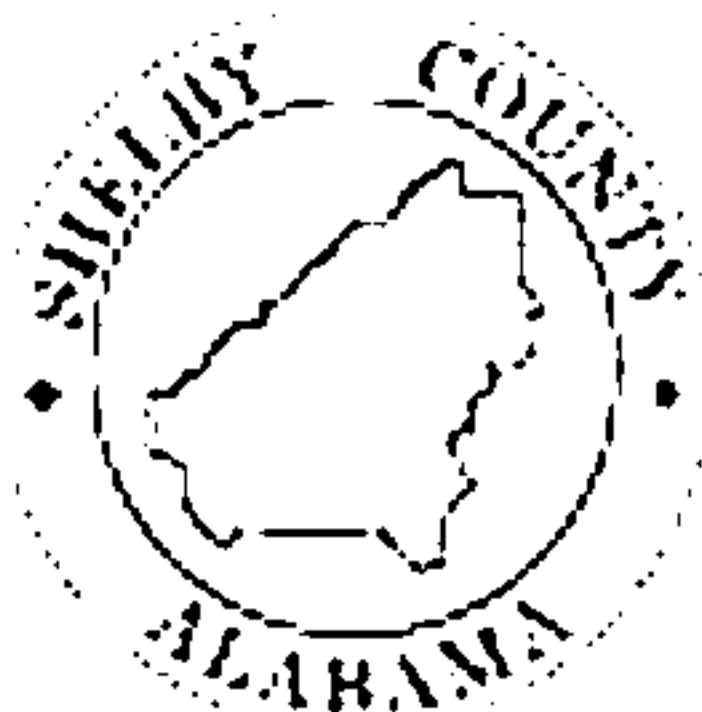
