KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Four Hundred Thirty-Five Thousand And No/100 Dollars (\$435,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Janice Goldstein, an unmarried person (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Nell Parks Haley and George Dunn Haley, Jr. (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

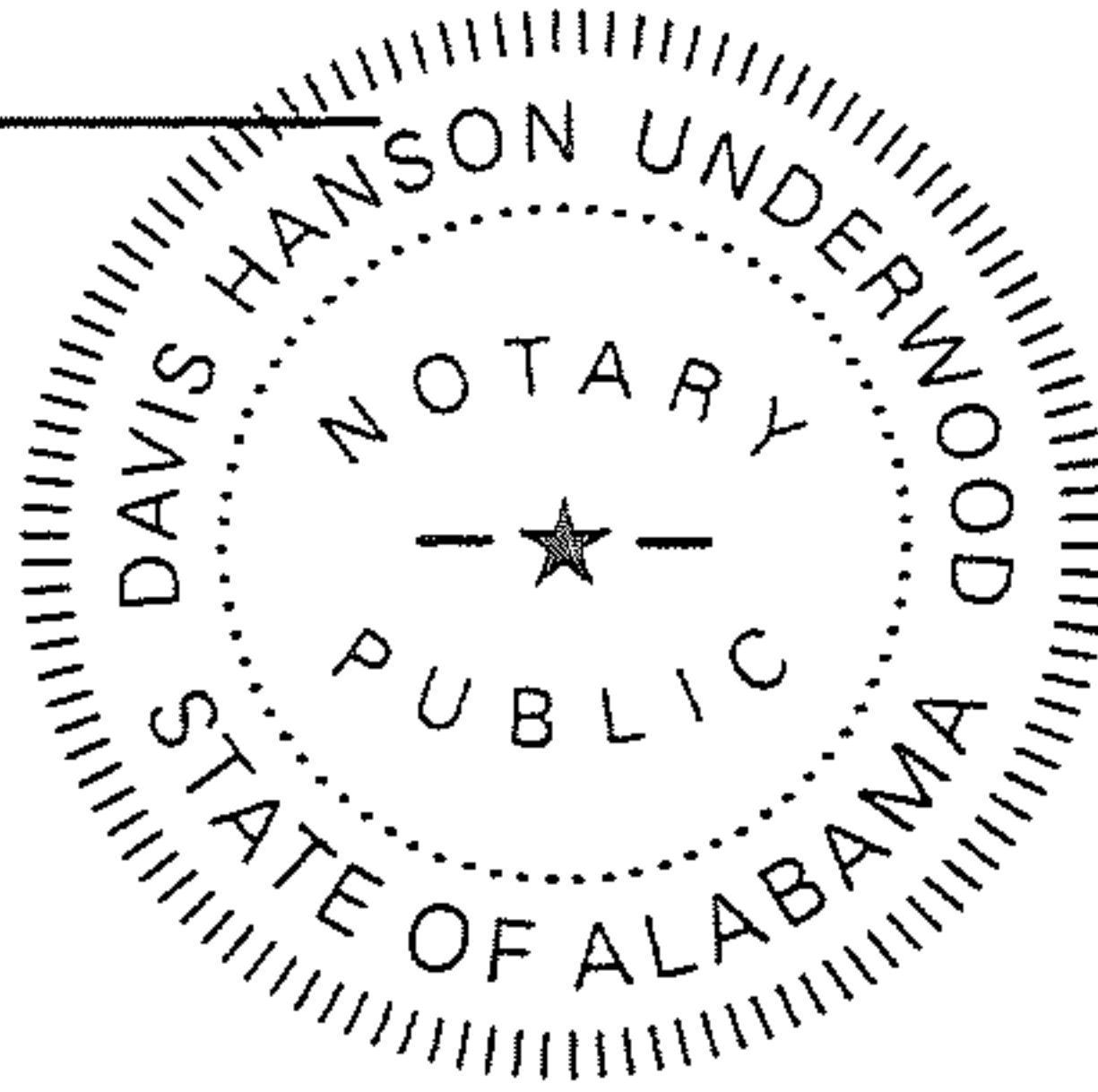


