KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, 04/21/2009, Patrice M. WHEREAS, Denise Koen, was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said Mortgagee; and,



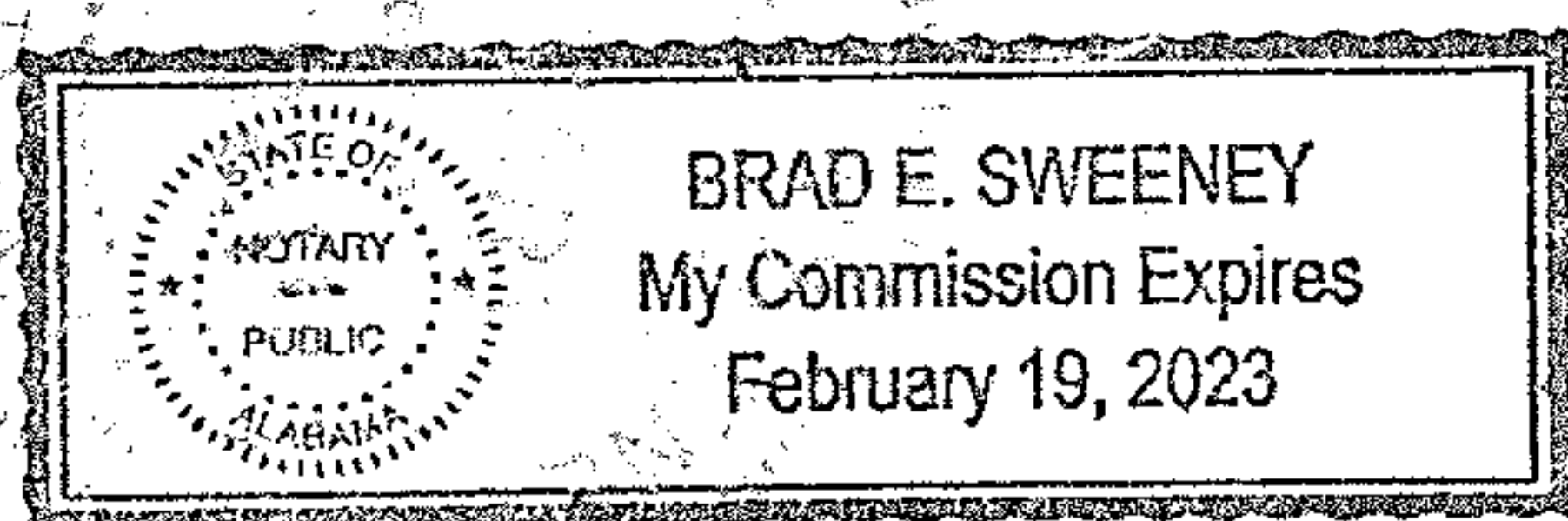


