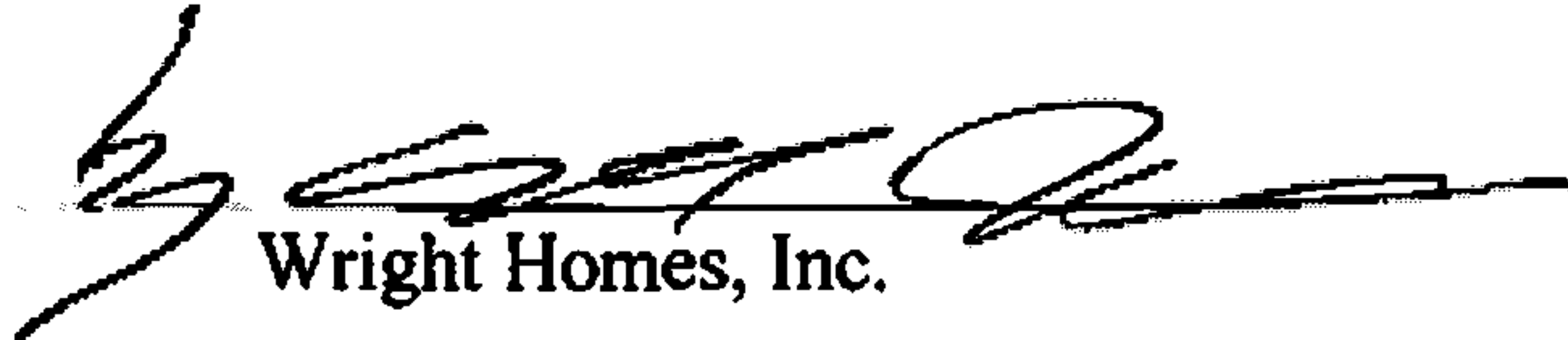
Be it known that \$350,000.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

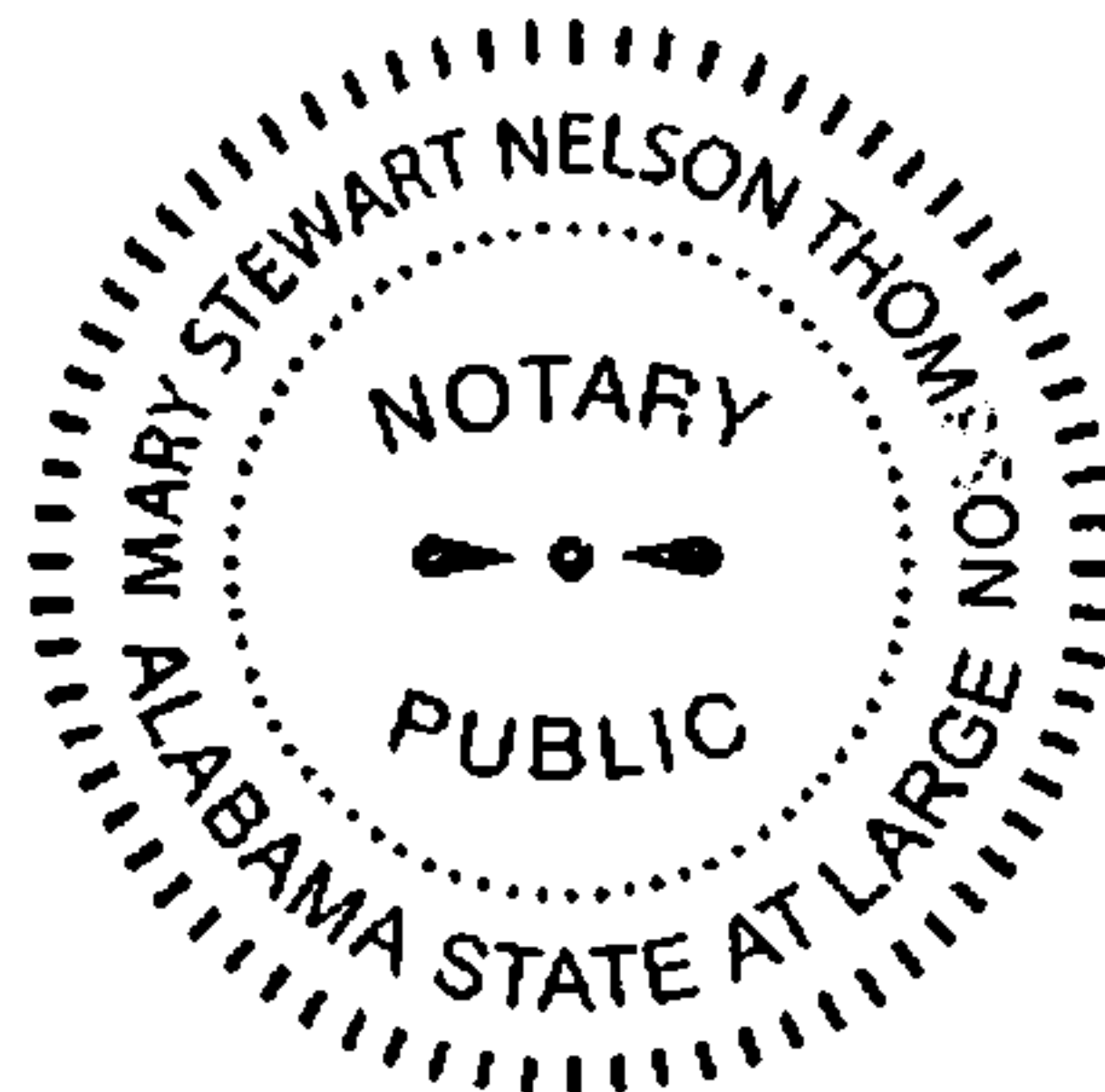

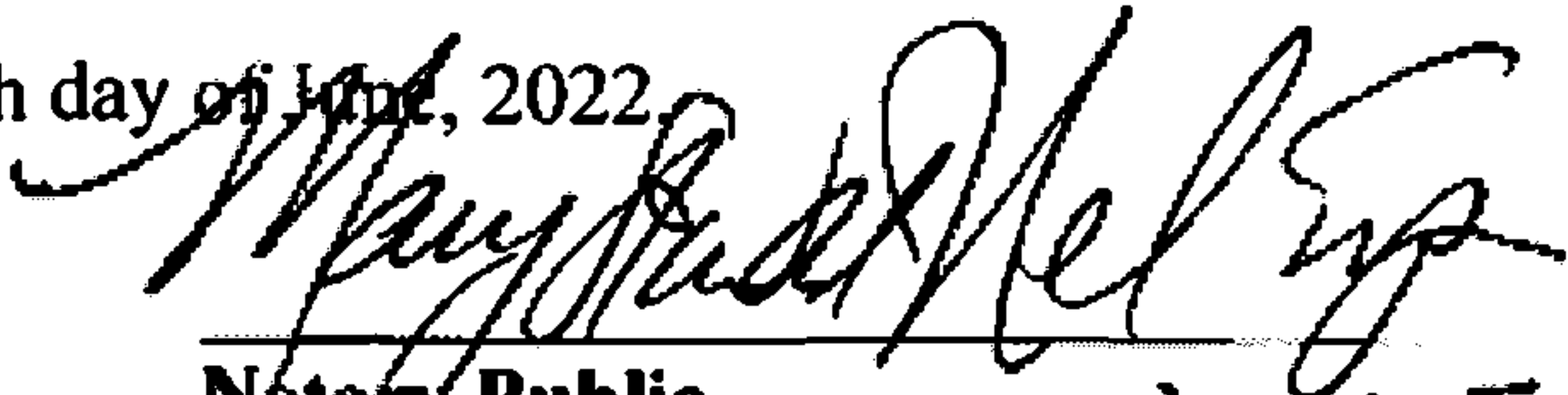
