KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, July 19, 2013, Phylisha D. 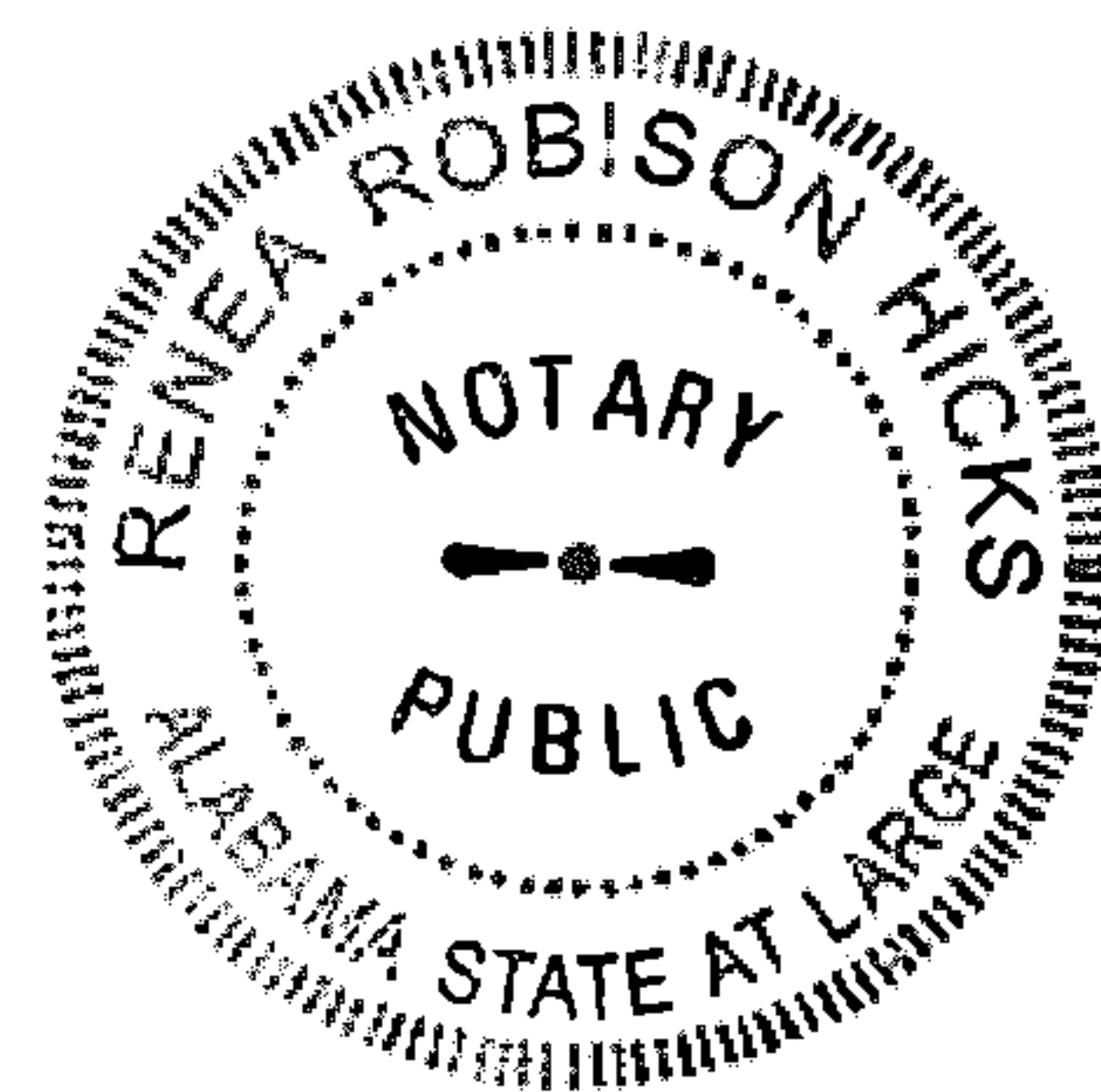

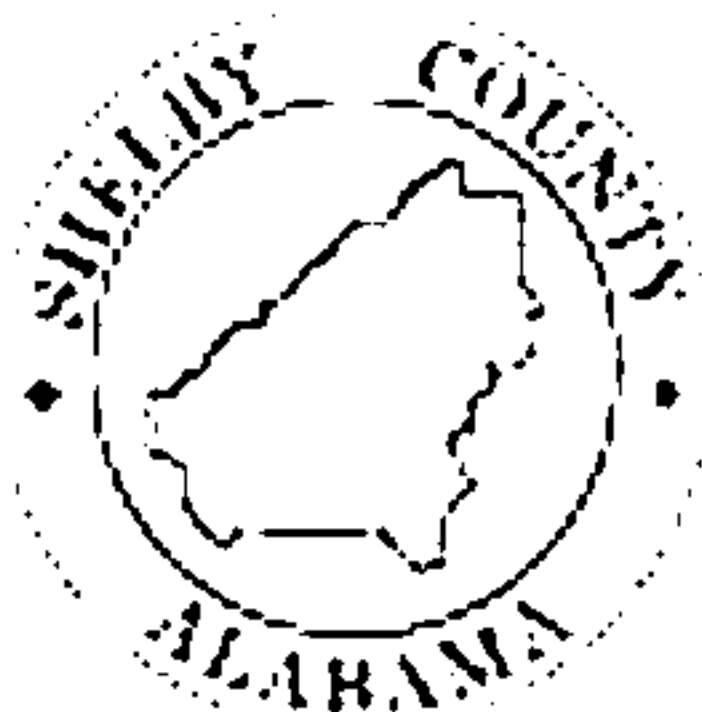
