**CERTIFICATION OF TRUST

1. The original settlors are Edith E. Halvorson and Donald O. Halvorson. The trust is revocable by the Grantors, acting jointly and not separately. —

2. The Trustees of the trust are Donald O. Halvorson and Edith E. Halvorson, and their address is 1068 South Hampton Place, Birmingham, Alabama 35242. The signatures of both Trustees are required to conduct business on behalf of the trust unless one Trustee explicitly grants signatory authority to the other in writing.

3. The tax identification number of the trust is the social security number of either Edith E. Halvorson or Donald O. Halvorson.

4. Title to assets held in trust may be taken as “Donald O. Halvorson and Edith E. Halvorson, Trustees of The Halvorson Living Trust dated July 23, 2013, and any amendments thereto.” An alternative description, however, will be effective to vest title to assets in the name of the trust or to designate the trust as a beneficiary of the description includes the name of at least one initial or successor Trustee, any reference indicating that property is held in a fiduciary capacity, and the date of trust.

5. The powers of the Trustee include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests.

6. The terms of the trust provide a third party may rely upon this Certification of Trust as evidence of the trust’s existence and is specifically relieved of any obligation to inquire into the terms of this trust or the authority of its Trustee, or to see to the application the Trustee makes of funds or other property received by the Trustee.

7. The trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.
