KNOW ALL MEN BY THESE PRESENTS, That in consideration of **THIRTY NINE THOUSAND THREE HUNDRED SEVENTY DOLLARS AND NO CENTS (\$39,370.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I, **Sandra Kay Boykin, a single woman** (herein referred to as **Grantors**) grant, bargain, sell and convey unto **Matthew T. Boykin and Sandra Kay Boykin** (herein referred to as **Grantees, as joint tenants with right of survivorship**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

Lot 7, according to the Map of Rice Acres, Sector Two, as recorded in Map Book 5, Page 87, in the Probate Office of Shelby County, Alabama, being situated in Shelby County, Alabama.




