**MORTGAGE FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 22nd day of May, 2007, GLORIA A. ROBINSON, DIVORCED AND ERNEST ROBINSON, DIVORCED, J/T/R/S executed that certain mortgage on real property hereinafter described to HOUSEHOLD FINANCE CORPORATION OF ALABAMA, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on May 31, 2007, at Instrument Number 2007053100253290, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **U.S. BANK TRUST NATIONAL ASSOCIATION AS TRUSTEE OF CABANA SERIES V TRUST**, by instrument recorded in at Instrument Number 20220317000109970, in the aforesaid Probate Office ("Transferee"); and

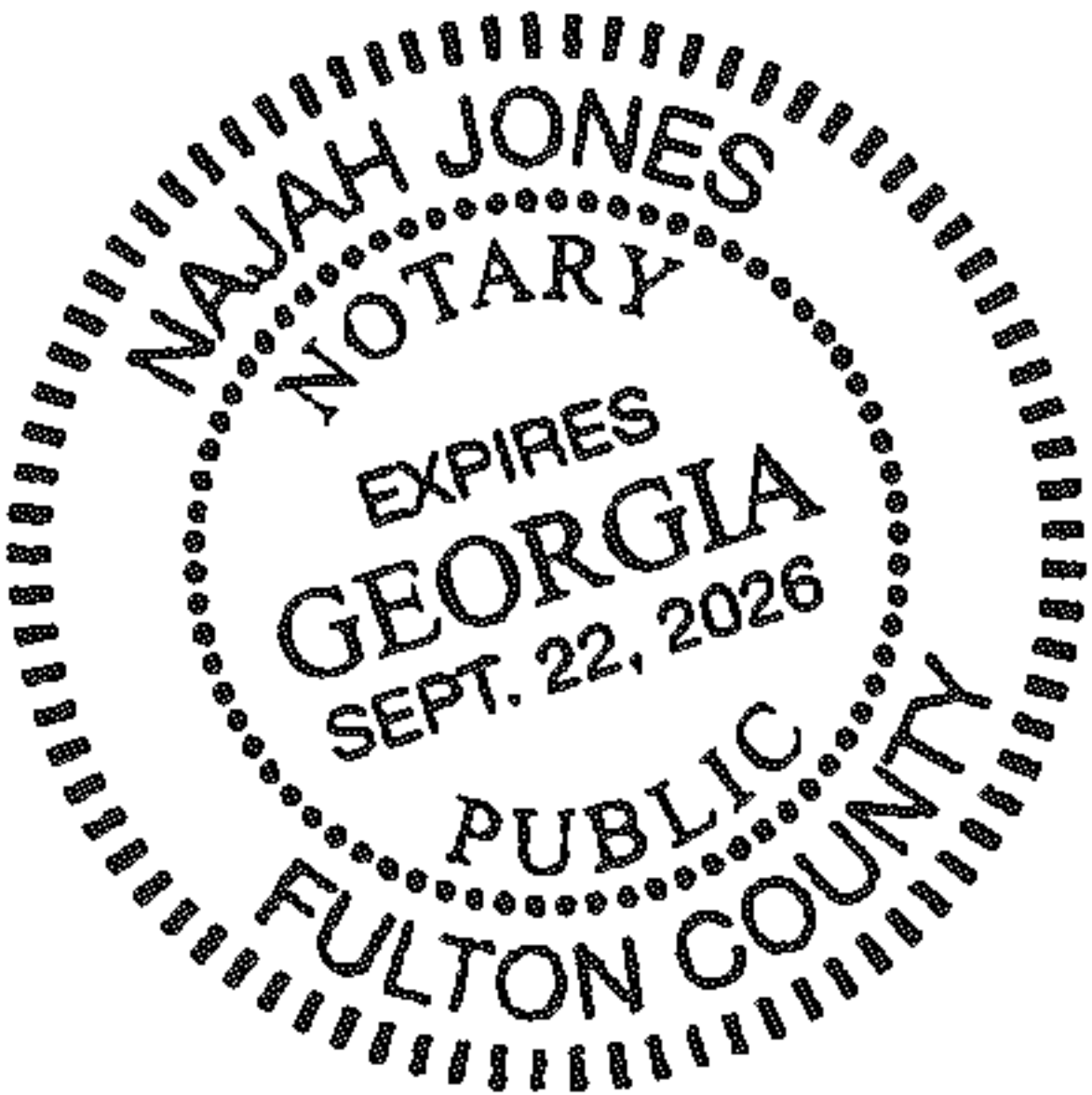
