Know All Men by These Presents: That in consideration of **Five Hundred Eighteen and 00/100 Dollars (\$518,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **EDDIE L. 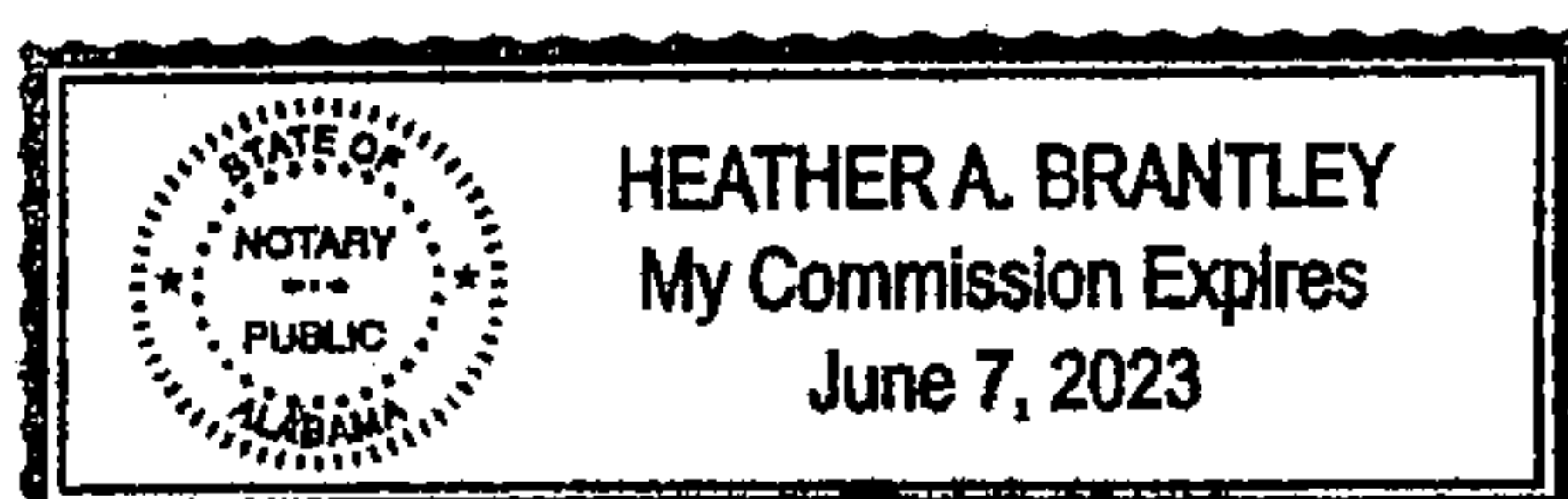

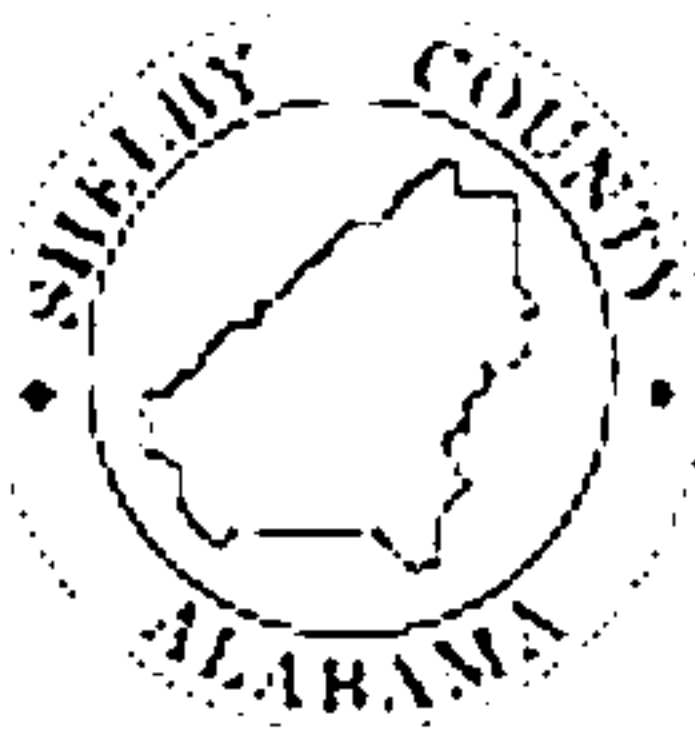
