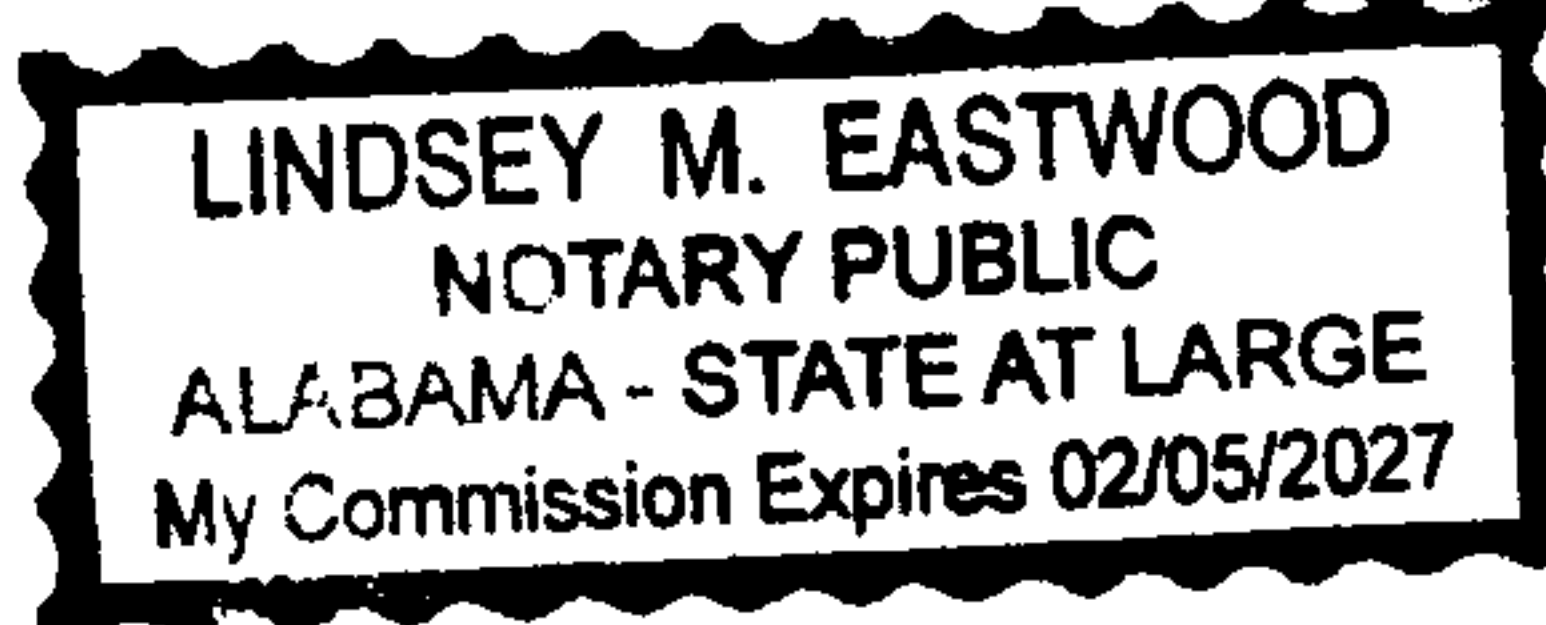
OATH OF OFFICE

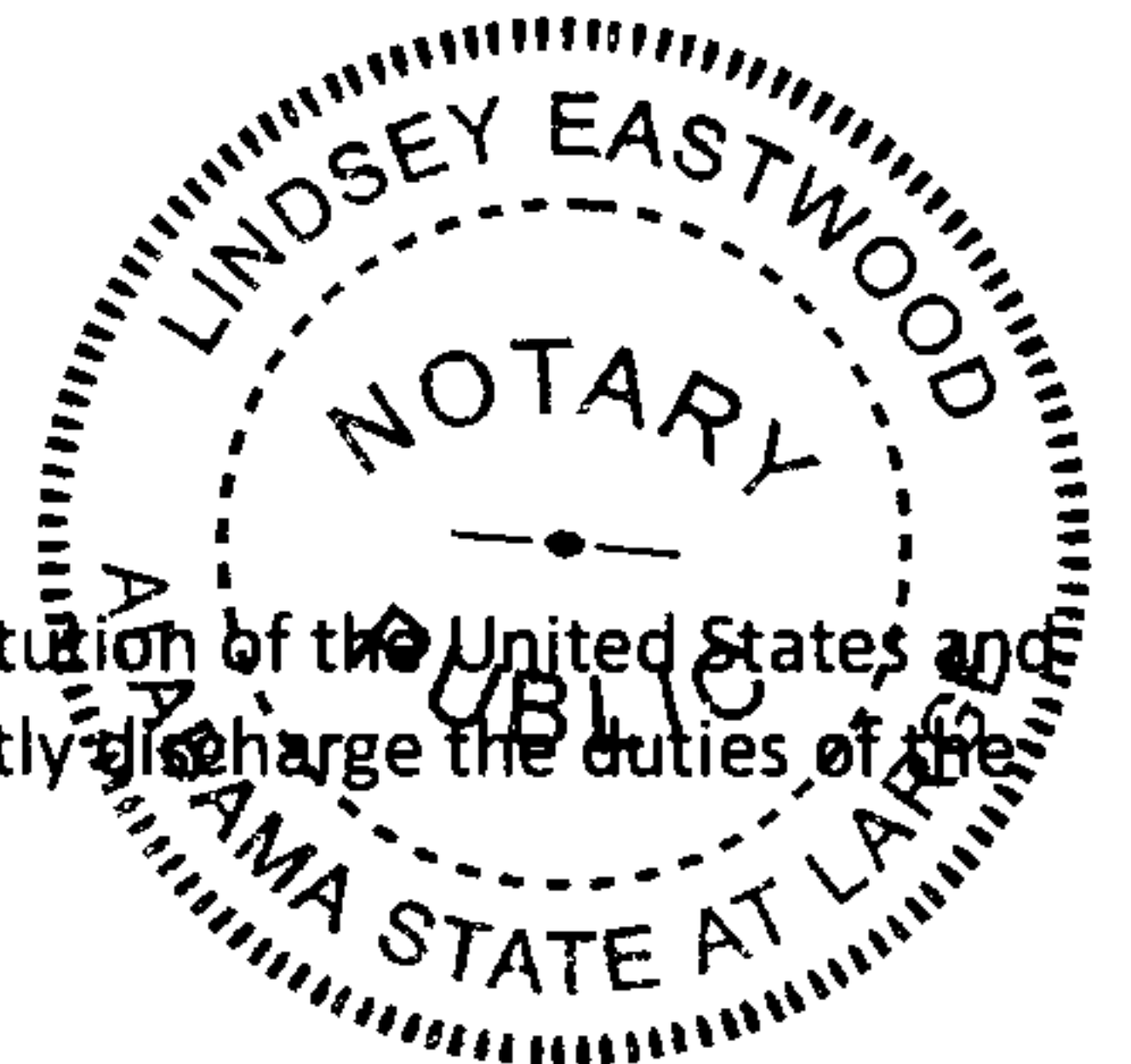

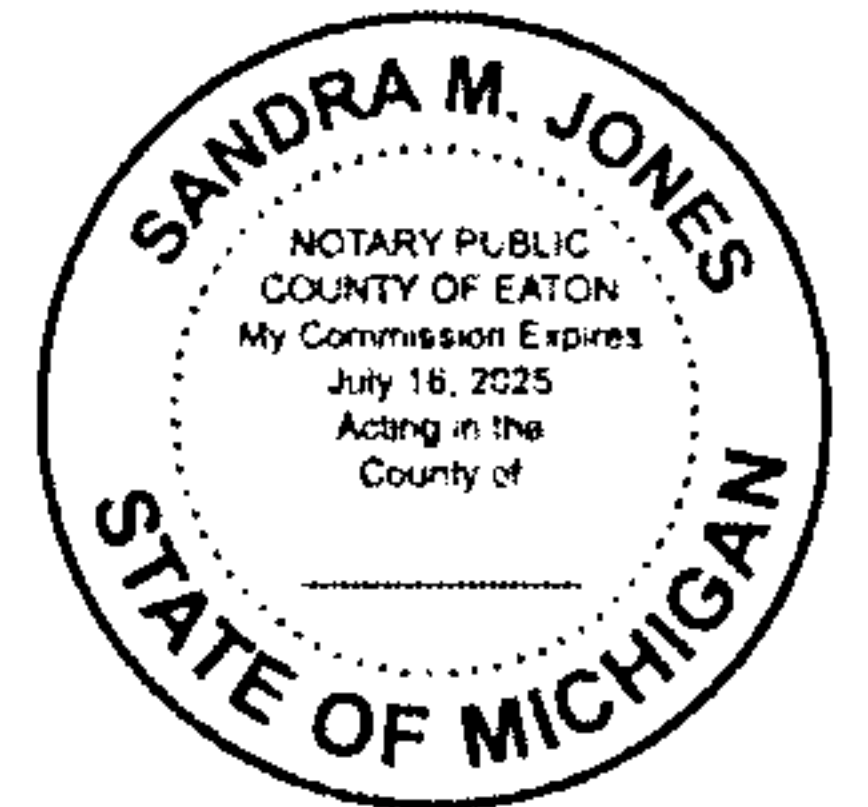


