GENERAL WARRANTY DEED
With Right of Survivorship

That in consideration of the sum of TWO HUNDRED FORTY FIVE THOUSAND AND 00/100 (\$245,000.00) and other good and valuable consideration to the undersigned grantor, Hunter McCoy Properties, LLC, an Alabama Limited Liability Company (herein referred to as Grantor) in hand paid by the grantees herein, the receipt of which is hereby acknowledged, the said Grantor does hereby these presents, grant, bargain, sell, and convey unto William Kirill Bledsoe and Sarah Knight (herein referred to as Grantees whether one or more, for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lots 1 and 2, Block 109, according to J.H. Dunstan's Map of the Town of Calera, Alabama, as recorded in Probate Office of Shelby County, Alabama.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

\$245,000.00 of the above consideration was secured by and through the purchase money mortgage closed herewith.

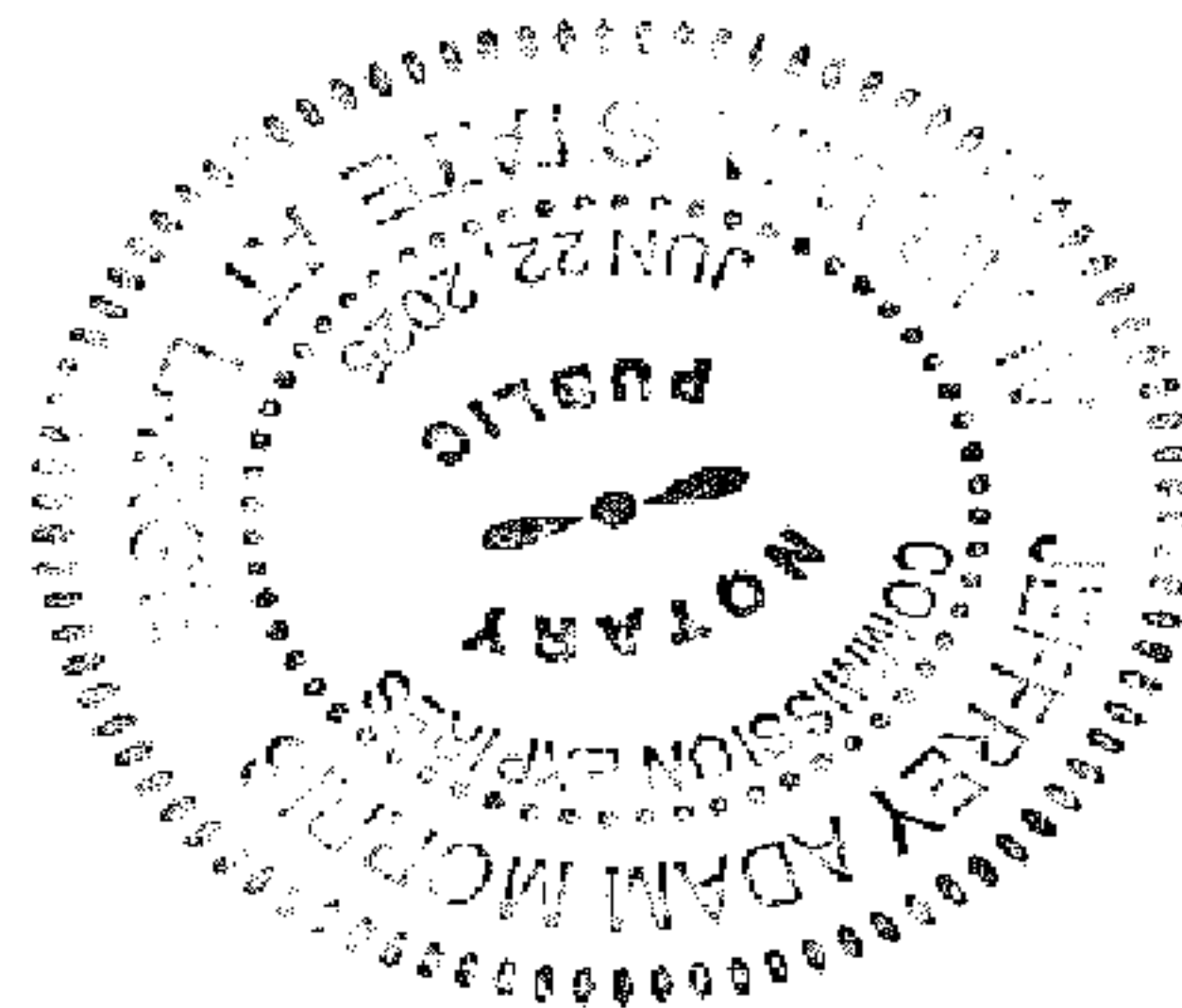
