(hereinafter referred to as "Grantee") the following described real estate situated in Shelby County, Alabama to-wit:



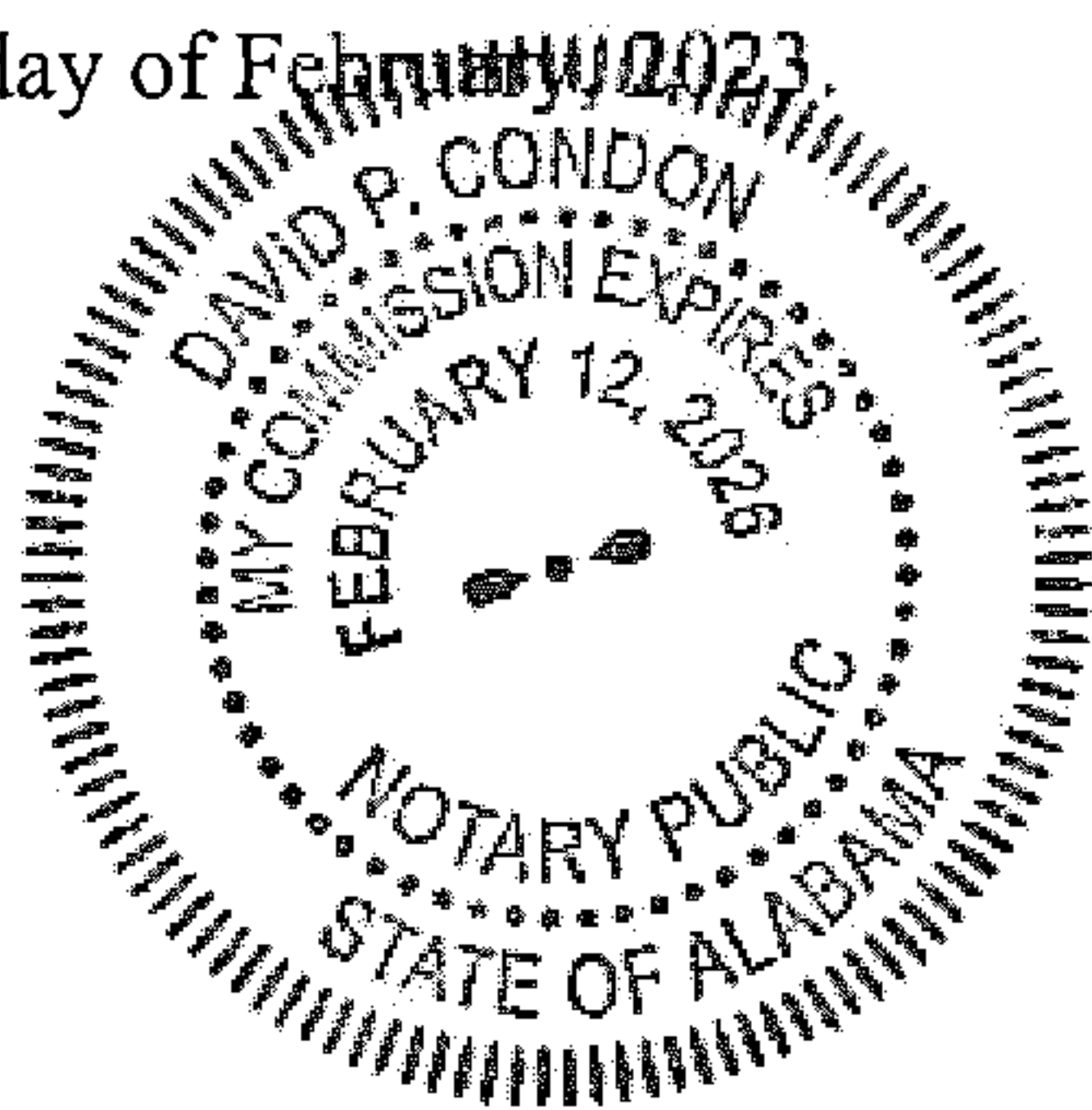
