That in consideration of the sum of **One Hundred Twenty Six Thousand Dollars and No Cents (\$126,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Carolyn B. Burkhalter**, a single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Chase Andre Lauzon and Stephanie Plyler Lauzon**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit,

The South Half of the Northwest Quarter of Northeast Quarter, Section 23, Township 21, Range 1 West, Shelby County, Alabama, less and except a tract lying in the Southeast corner, being a square with dimensions of 420 feet on each side.

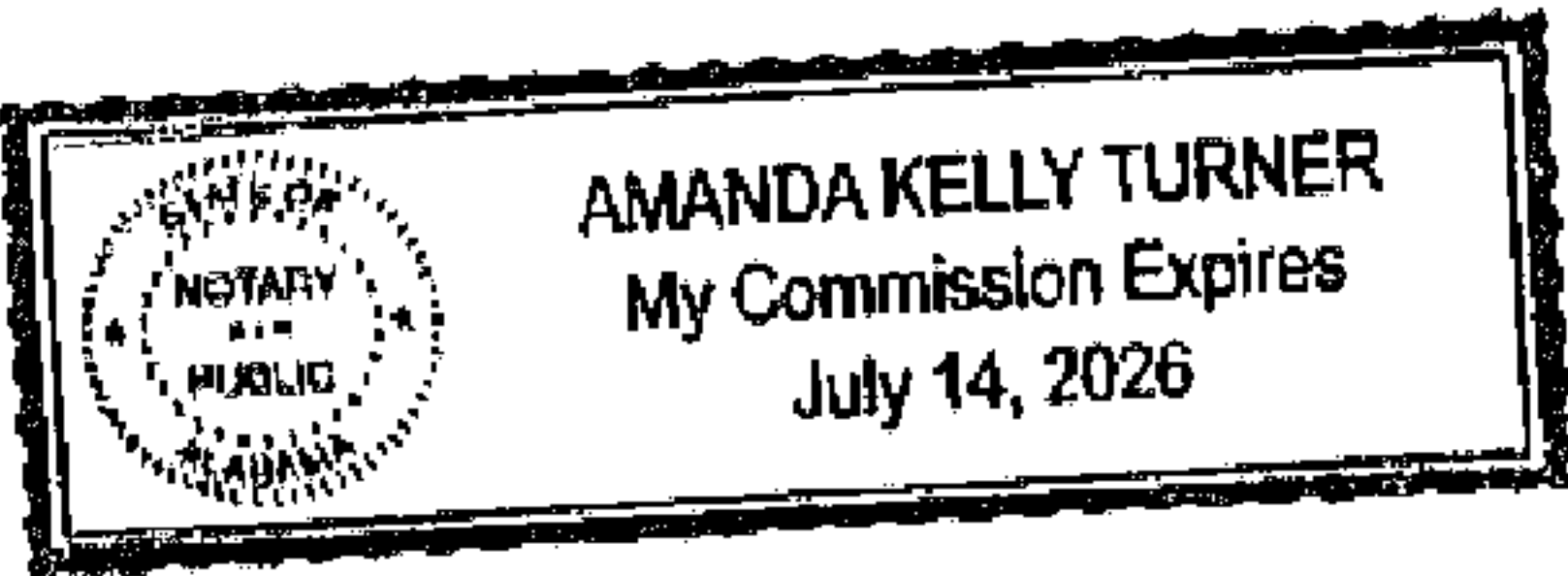
