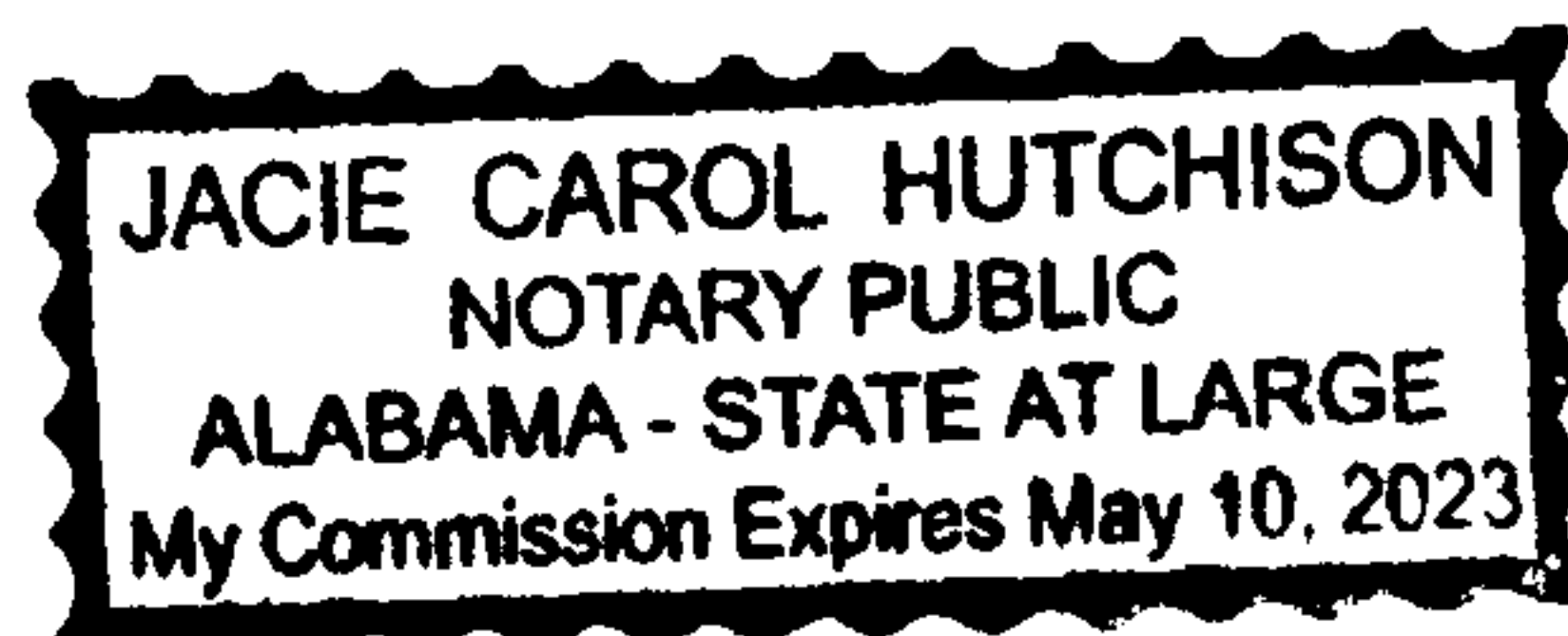
OATH OF OFFICE

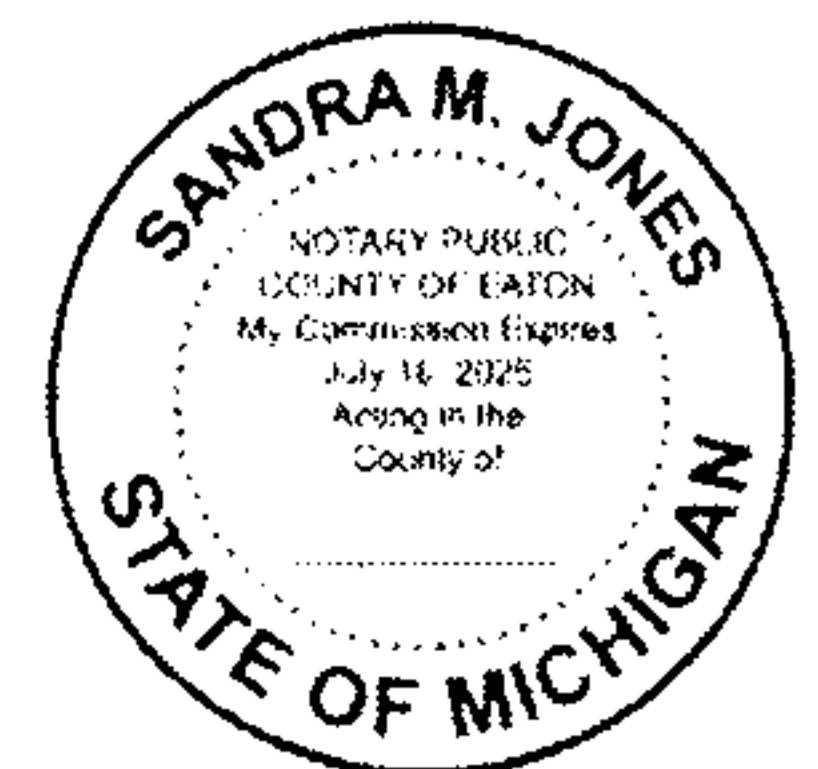


