The undersigned hereby certify as follows:

1. The Kennedy Joint Management Trust Originally Dated October 22, 2021 (the "Trust") was validly created on October 22, 2021 and is in existence as of the date of this Certificate.
2. Gayle Hundley Kennedy and Richard Thomas Kennedy are the Grantors of the Trust.
3. Gayle Hundley Kennedy and Richard Thomas Kennedy are the initial and currently serving Trustees of the Trust. In the event of the death, incapacity, inability or unwillingness to serve as Trustee of either Gayle Hundley Kennedy or Richard Thomas Kennedy, then the other or the survivor of them shall serve as Trustee. In the event of the death, incapacity, inability or unwillingness to serve as Trustee hereunder of both Gayle Hundley Kennedy and Richard Thomas Kennedy, then Comerica Bank & Trust, N.A. shall serve as Trustee.
4. The address of the Trustees is 1143 Riverchase Parkway W., Hoover, Alabama 35244.
5. The signatures of both of the trustees are required to exercise the powers of the Trustee unless agreed to in writing by the Trustees. In the event there are more than two trustees serving, signatures of a majority of the trustees are required. In the event a sole Trustee is serving, only that serving Trustee is required to sign.
6. The Trust is revocable and amendable by the Grantors. The Trust has not been amended since it was created on October 22, 2021.
7. The tax identification number of the Trust will be provided to necessary parties upon request.
8. Title to assets in the Trust shall be taken as follows:

Gayle Hundley Kennedy and Richard Thomas Kennedy, Trustee of the Kennedy Joint Management Trust Originally Dated October 22, 2021, and any amendments thereto.

In addition, for titling purposes, any description referring to the Trust shall be effective if it includes the name of the Trust, the name of at least one Trustee or successor Trustee and any reference indicating that property is being held by the Trustee in a fiduciary capacity.

9. The Trustees under the Trust are authorized to establish bank accounts, broker accounts, acquire, sell, convey, encumber, lease, borrow, manage and otherwise deal with interests in real and personal property in the Trust name. The Trustee is duly authorized under the Trust document and applicable law to execute any necessary contracts or conveyances to implement transactions for the Trust.
10. The Kennedy Joint Management Trust Originally Dated October 22, 2021 has not been revoked, modified or amended in any way that would cause the representations in this Certification of Trust to be incorrect.

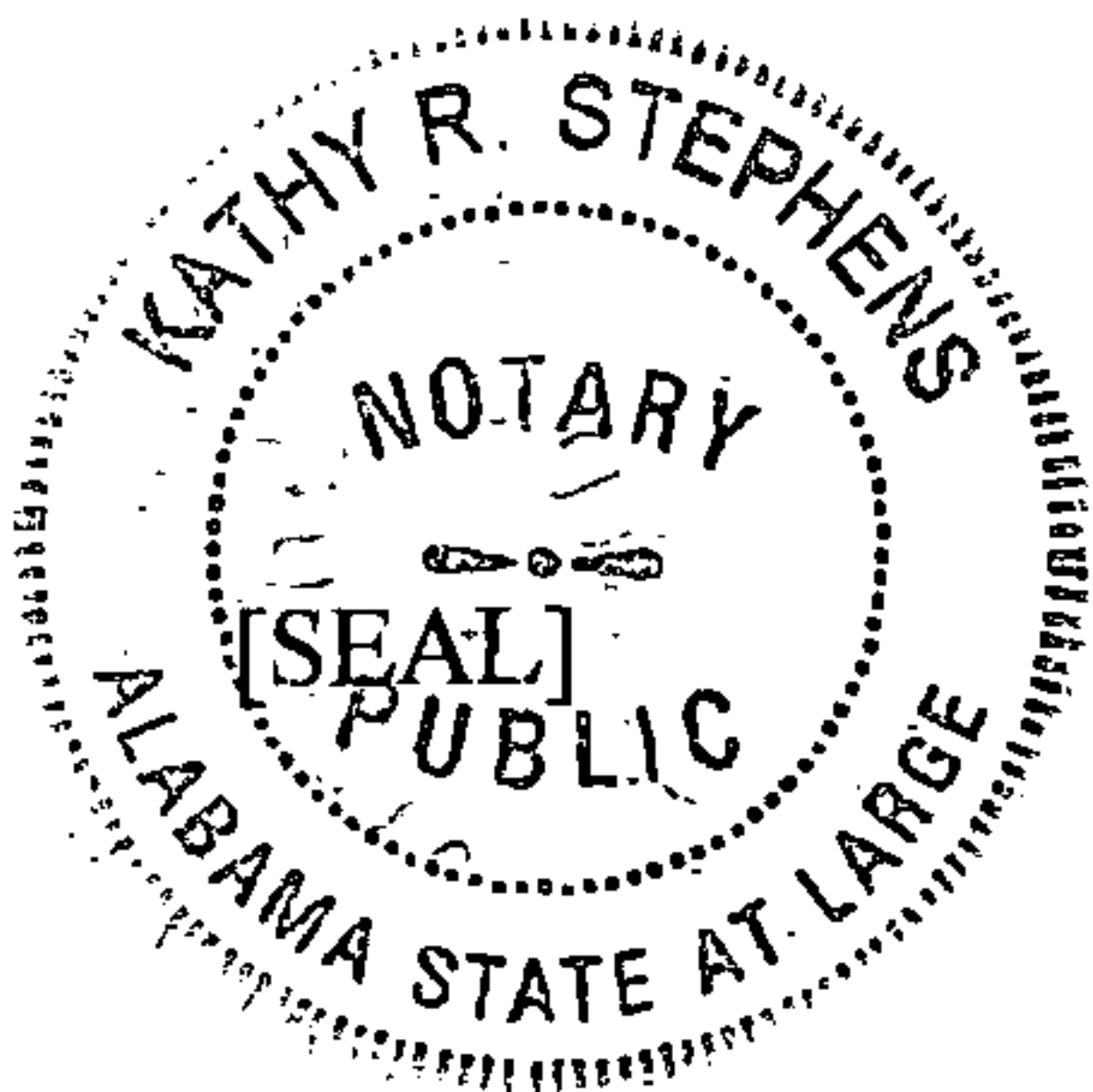
