Anthony Booker, son, over the age of 19 and of sound mind.

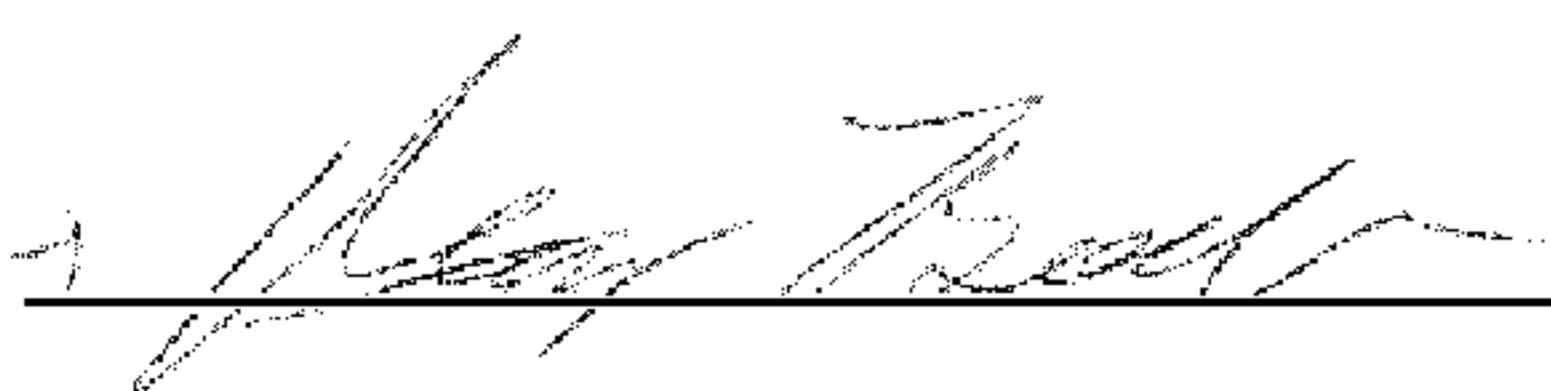
Steven Booker, son, over the age of 19 and of sound mind.

At the time of her death, Amos Booker and Ella Bell Booker had no other heirs at law. Further, there are no other children or children of deceased children.

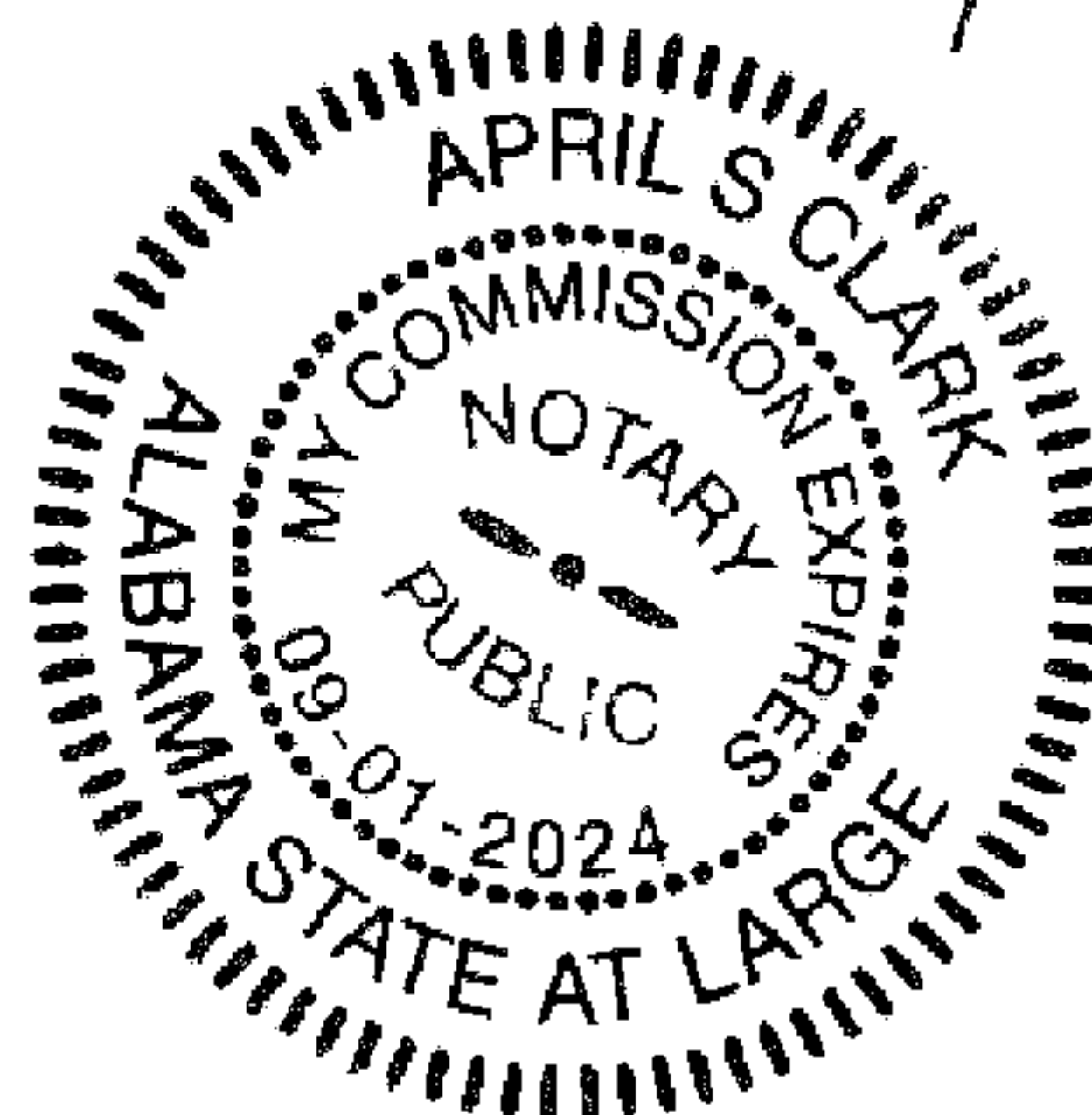

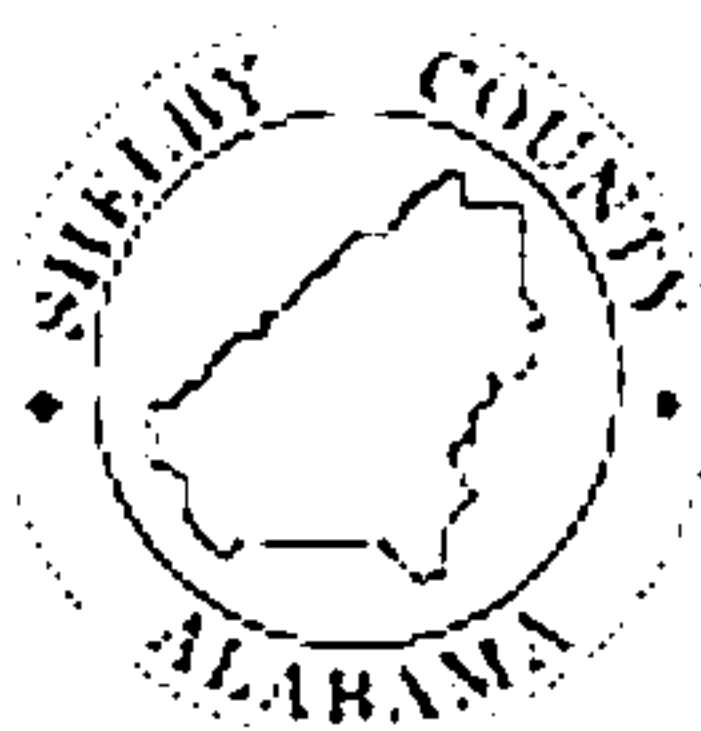

LEGAL DESCRIPTION
