That in consideration of the sum of **Five Hundred Twenty Thousand Dollars and No Cents (\$520,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Denise Smith and Todd Smith**, wife and husband (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Michael Ray Barrett and Jaimee Kayati Barrett**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 7, according to the Survey of Shelby Shores, 1977 Addition, as recorded in Map Book 7, Page 87, in the Office of the Judge of Probate of Shelby County, Alabama.



\$390,000.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.


