PROVIDED.

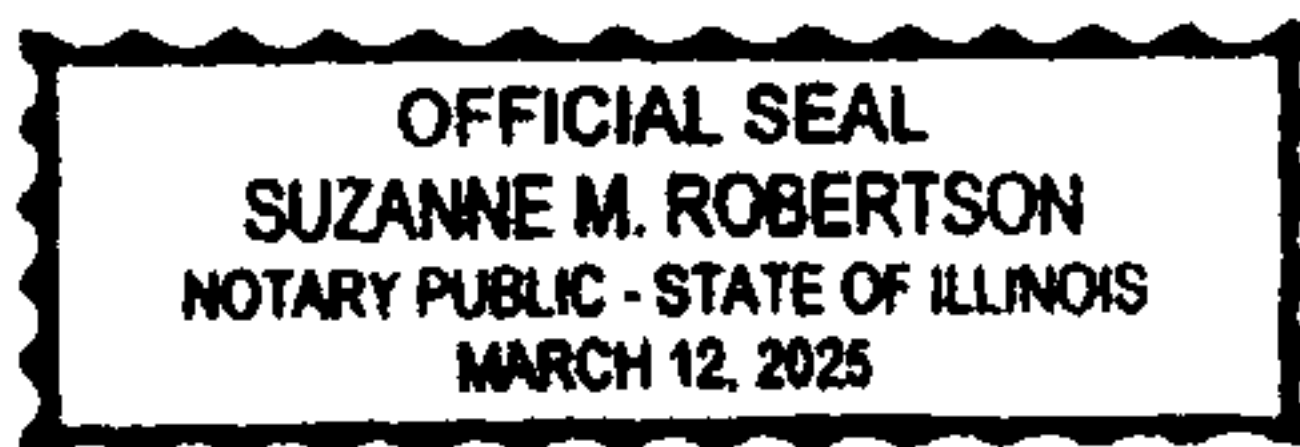
