} Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Sixty Five Thousand Dollars and No Cents (\$65,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Henry E. Raymond, Jr. and Janet K. Raymond, husband and wife** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Matthew Parker and Erin Parker**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 1-A and Lot 1-B, according to the Survey of Clearview Estates, as recorded in Map Book 54, Page 73, in the Probate Office of Shelby County, Alabama.



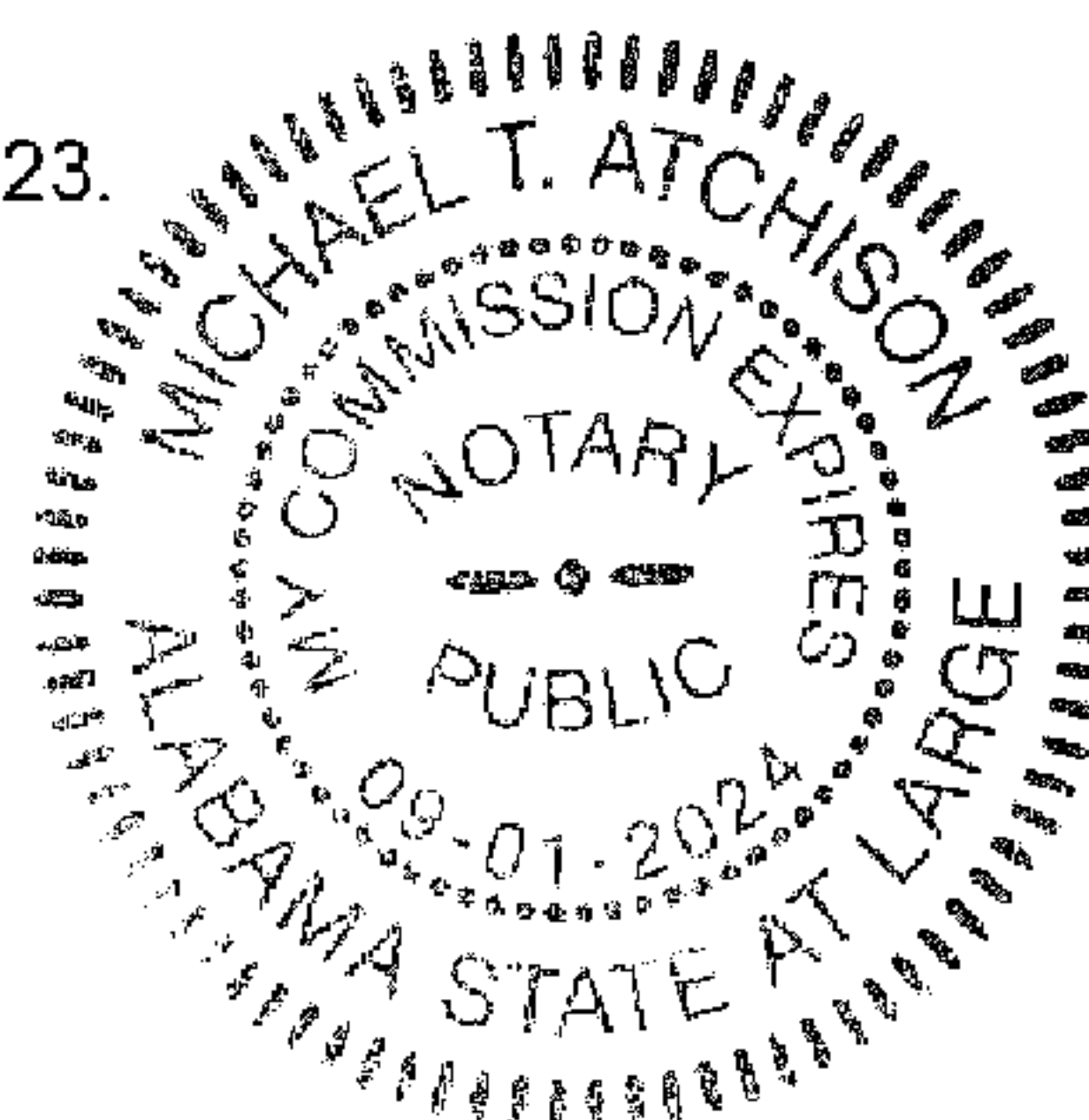
