That in consideration of Two Hundred Seventy-Nine Thousand Nine Hundred and 00/100 (\$279,900.00) Dollars and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Emmanuel Armah Long-Hesse and Maelin Ranae Trammell (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 41, as shown on the Amended Final Plat of Koslin Farms Phase 1, according to the map or plat thereof, recorded in Plat Book 56, Page 51, in the Office of the Judge of Probate of Shelby County, Alabama.

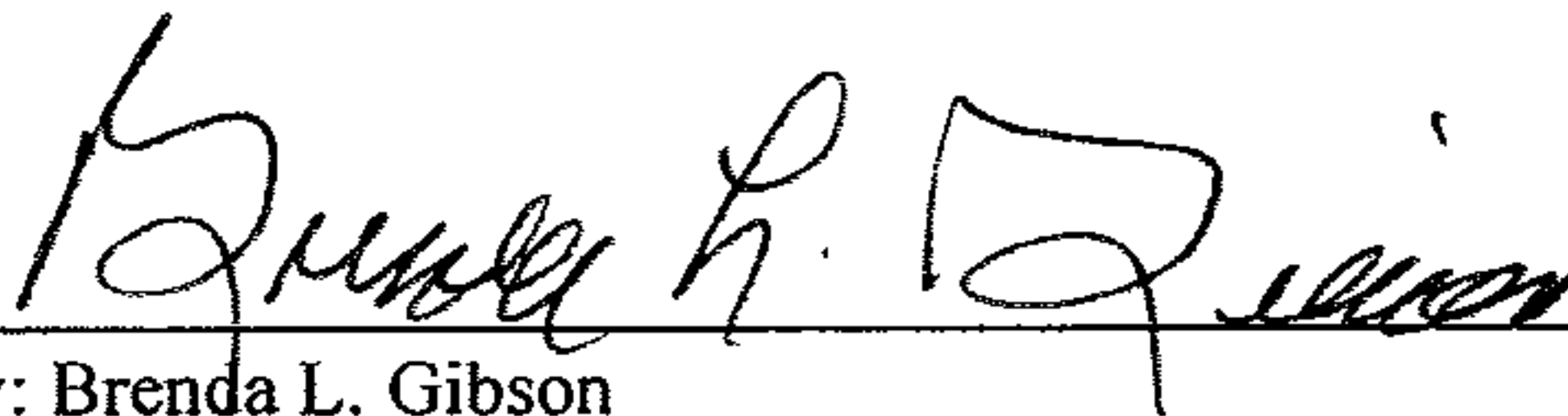

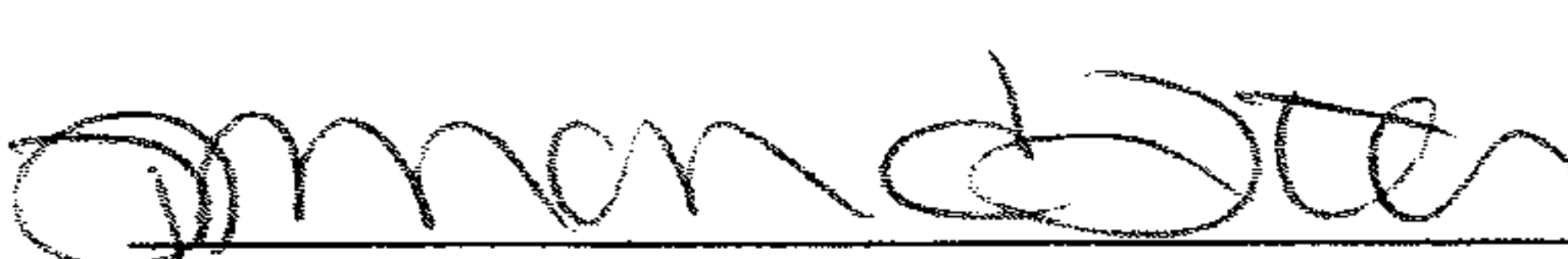

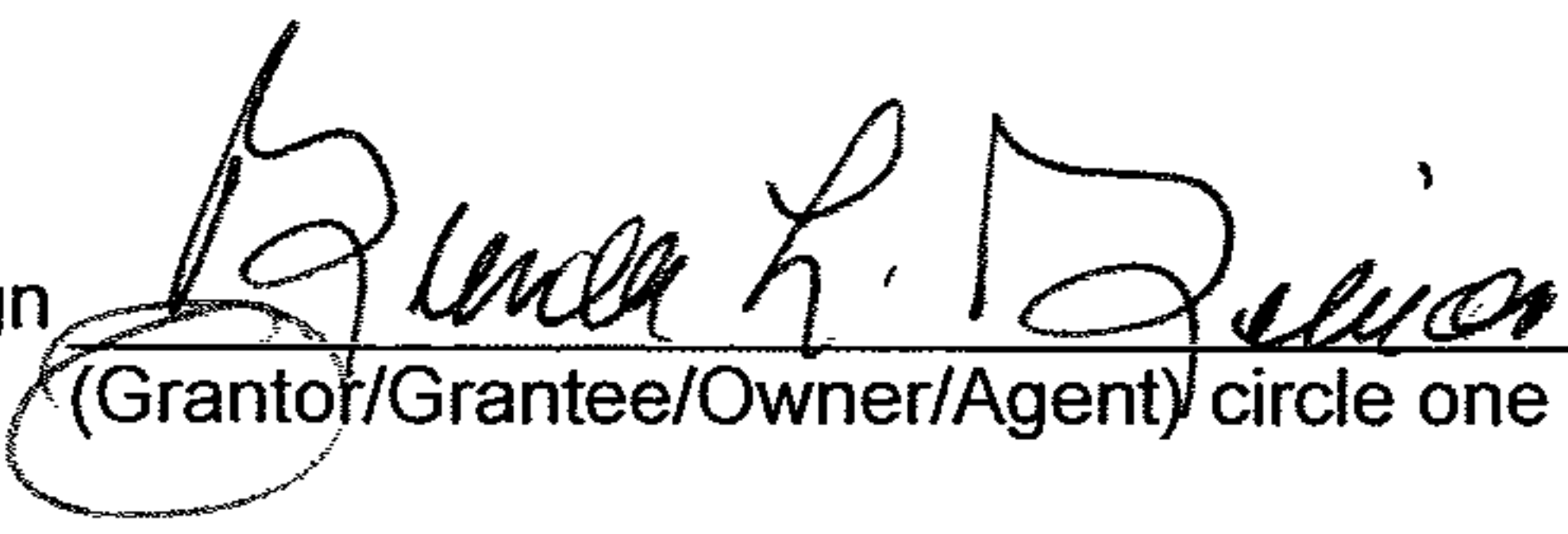
