Lot 1 according to the Survey of Spring Creek, as recorded in Map Book 24, Page 115, in the Probate Office of Shelby County, Alabama.

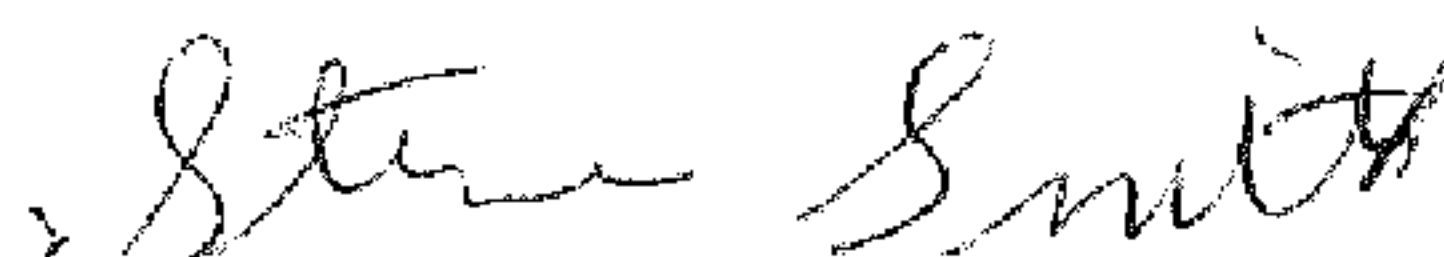

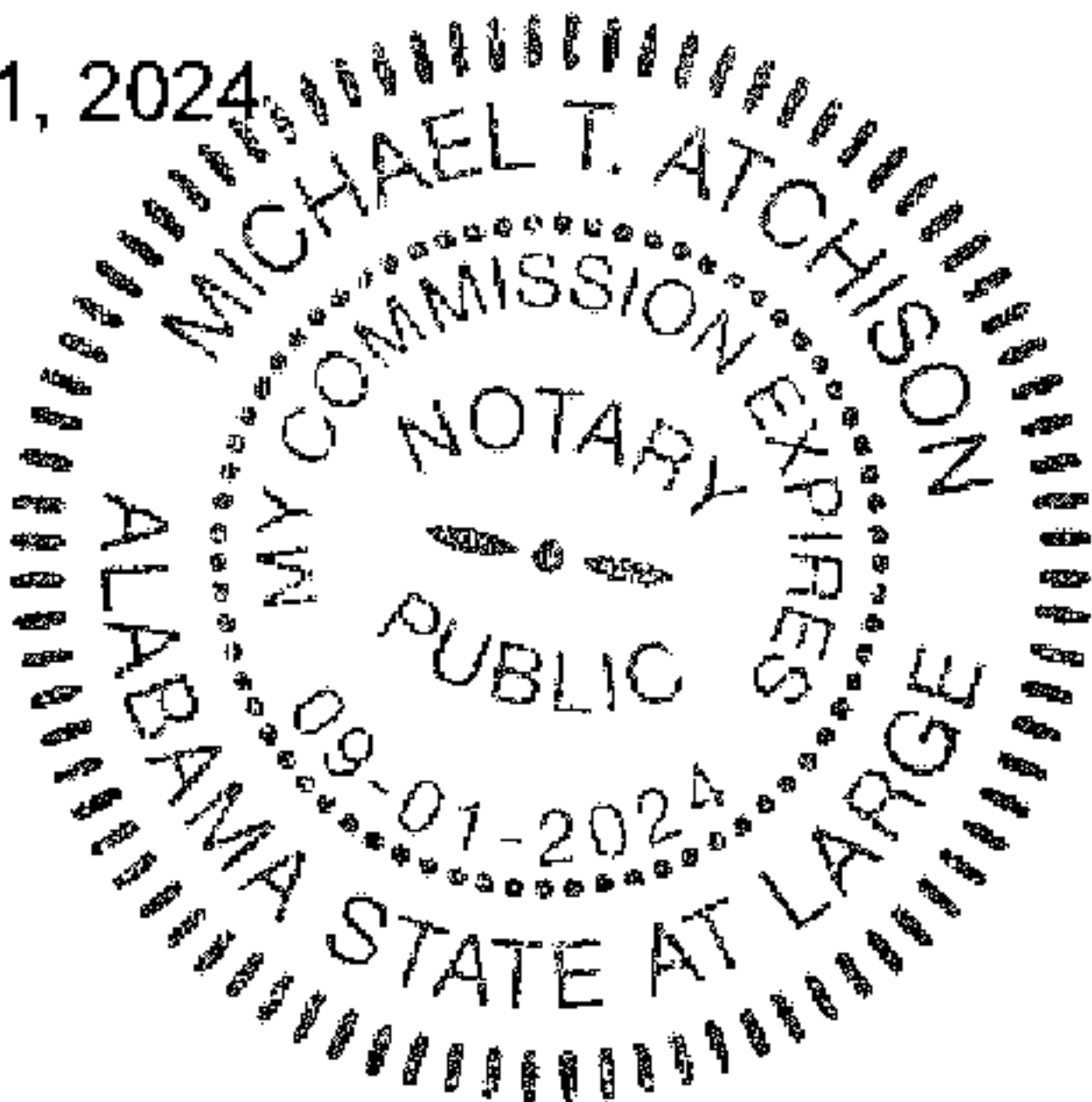
