A purchase money and construction mortgage filed simultaneously herewith in the amount of \$551,986.00


This instrument is executed as required by the Articles of Organization and Operating Agreement and same have not been modified or amended.

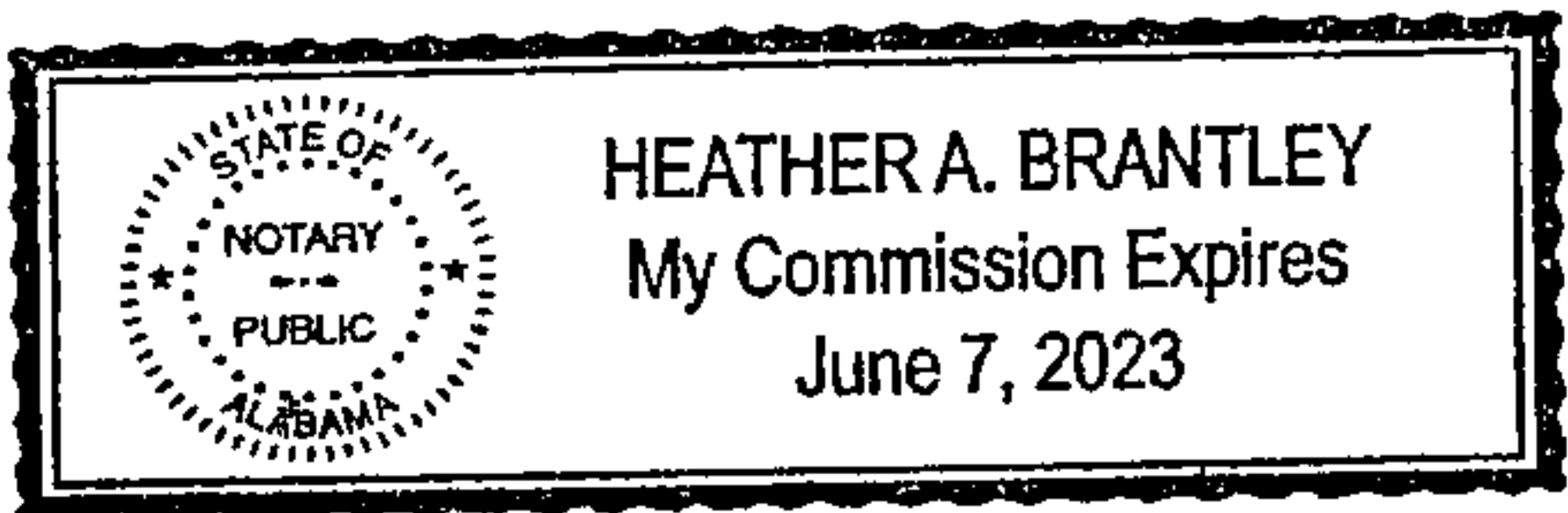


