Dawkins, a single woman (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:


Note: \$286,135.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.



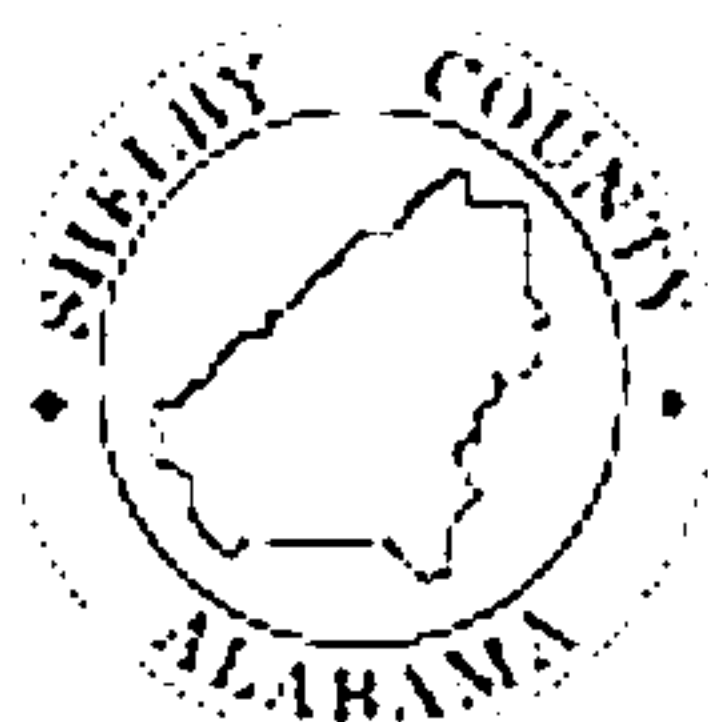
