Whidby and wife, Sherry L. Whidby, Milton E. Weathers and wife, Sharon S. Weathers and Harold C. Gray and wife, Kathy S. Gray* (herein referred to as *Grantor*) grant, bargain, sell and convey unto *Jeff L. Whidby and Sherry L. 

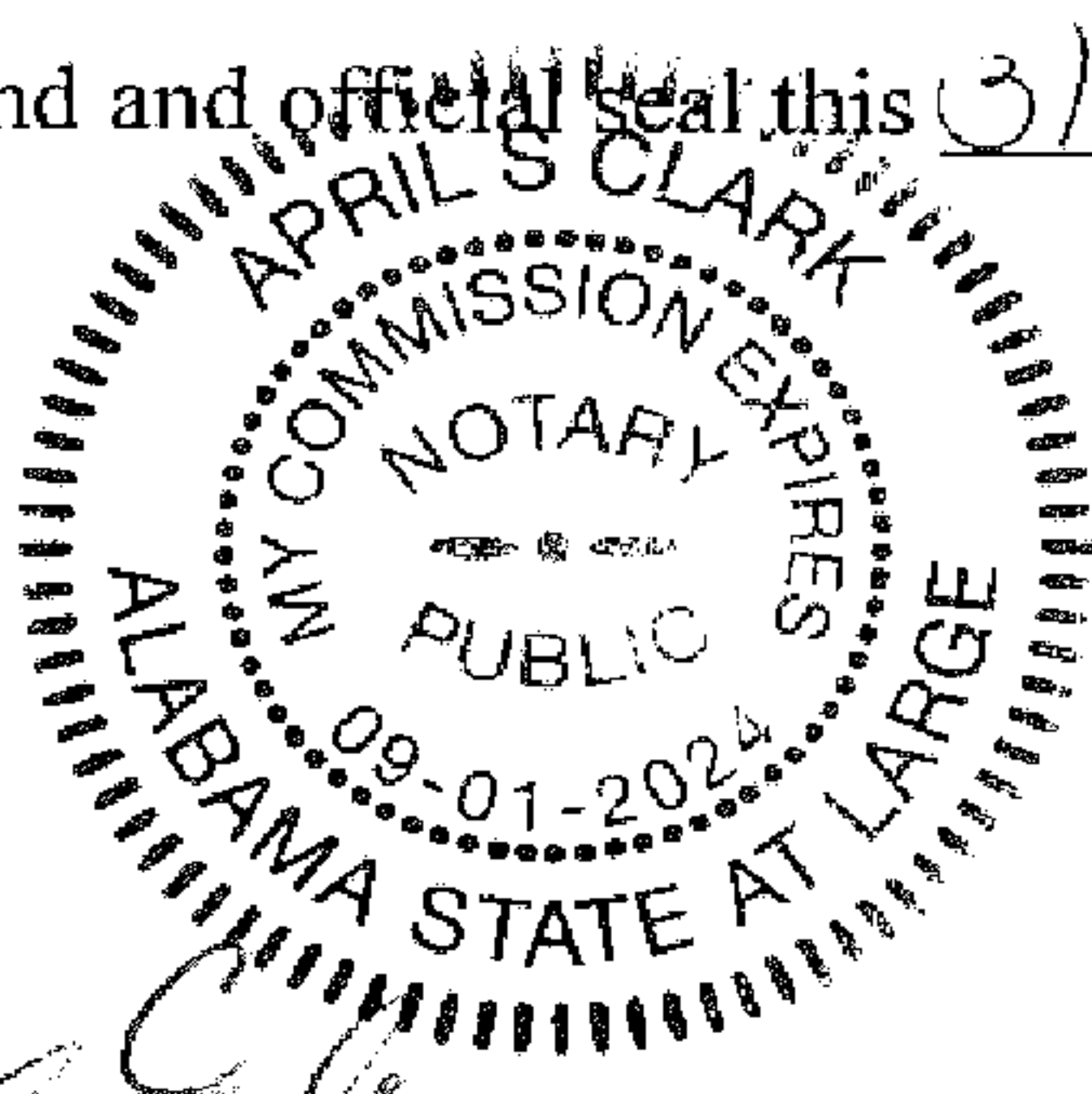

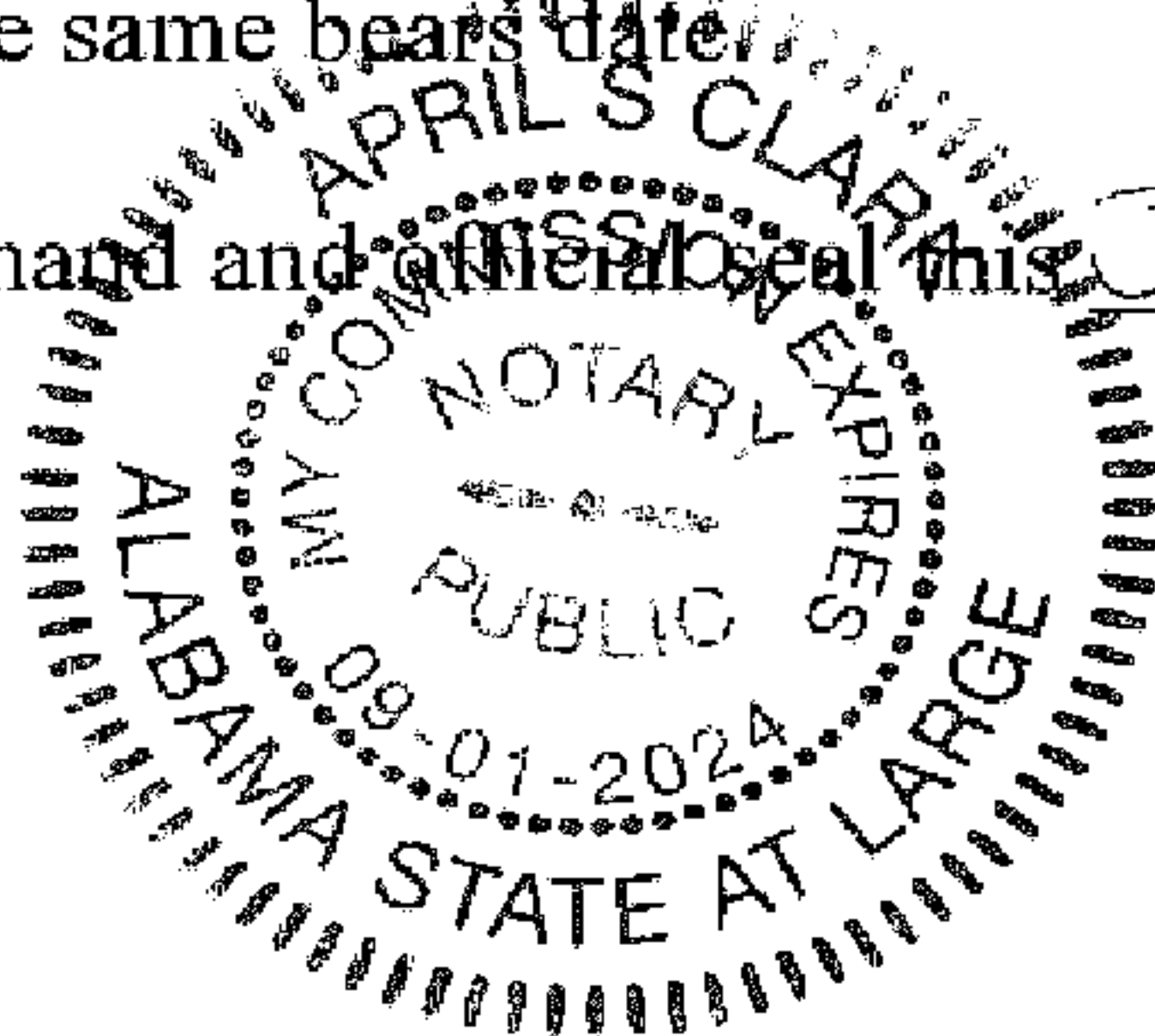
