That in consideration of **Three Hundred Thirty-Two Thousand Three Hundred Seventeen and 00/100 (\$332,317.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

**D.R. Horton, Inc. – Birmingham** (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

**Alnisha Roshell Ramsey** (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

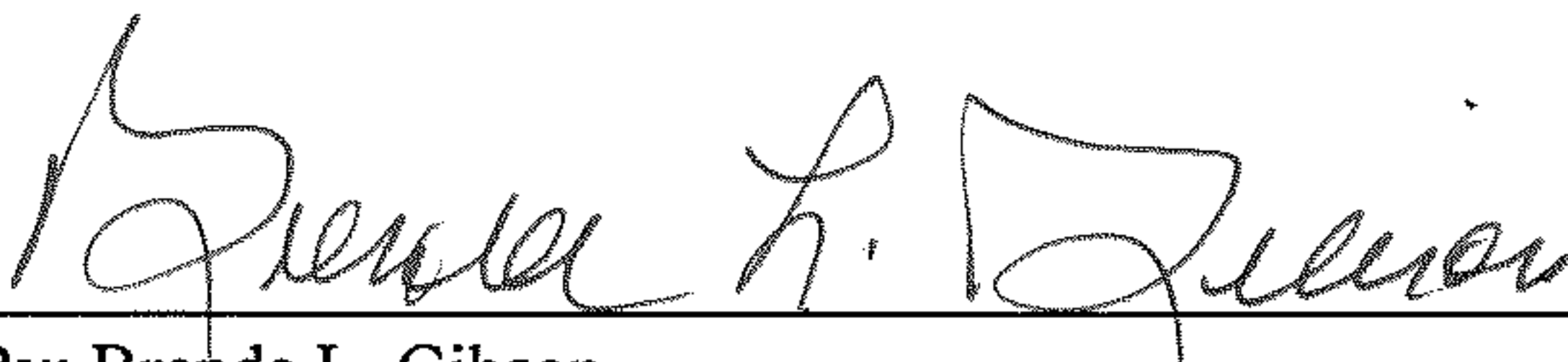
**TO HAVE AND TO HOLD**, unto the said GRANTEE, her/his heirs and assigns forever.

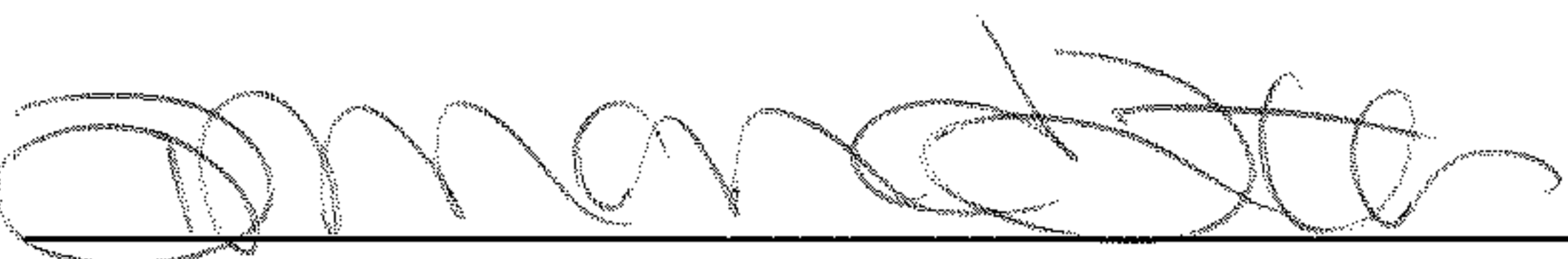

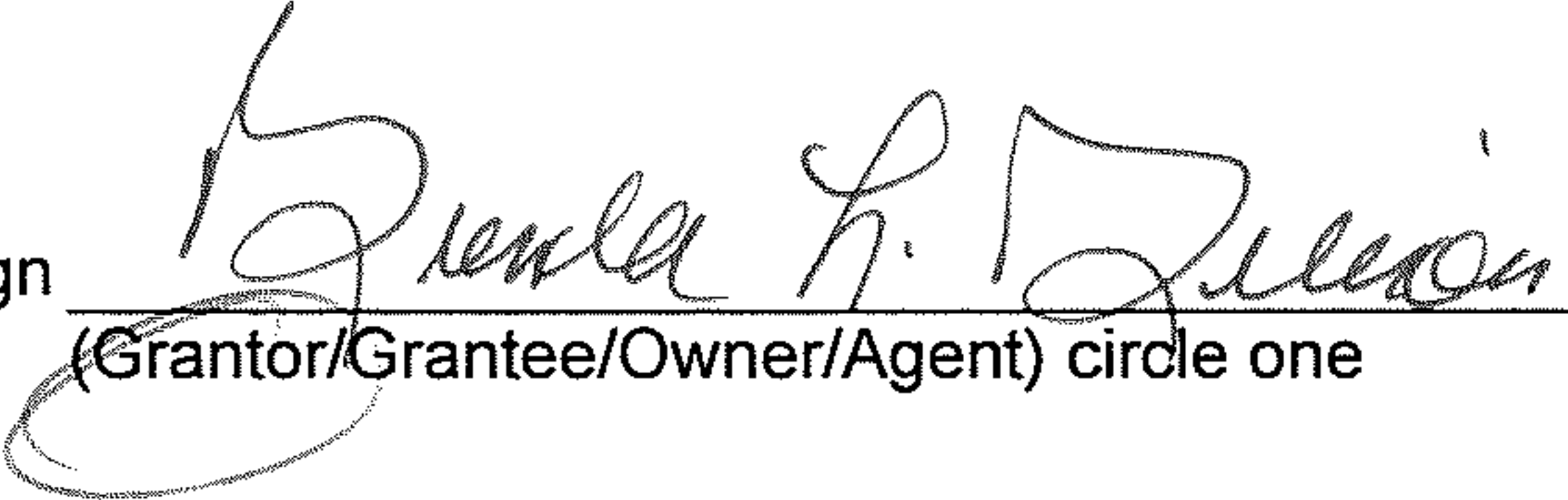

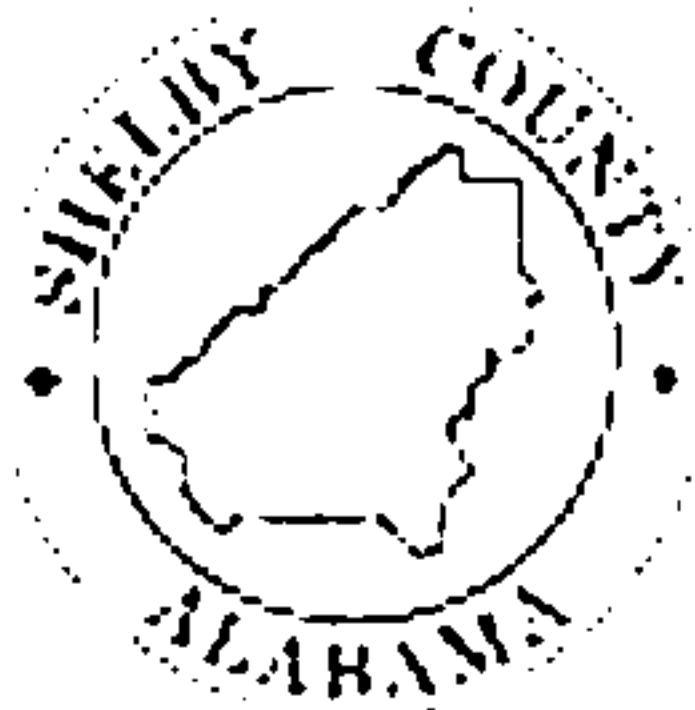
