
No part of the homestead of the grantor herein or spouse.

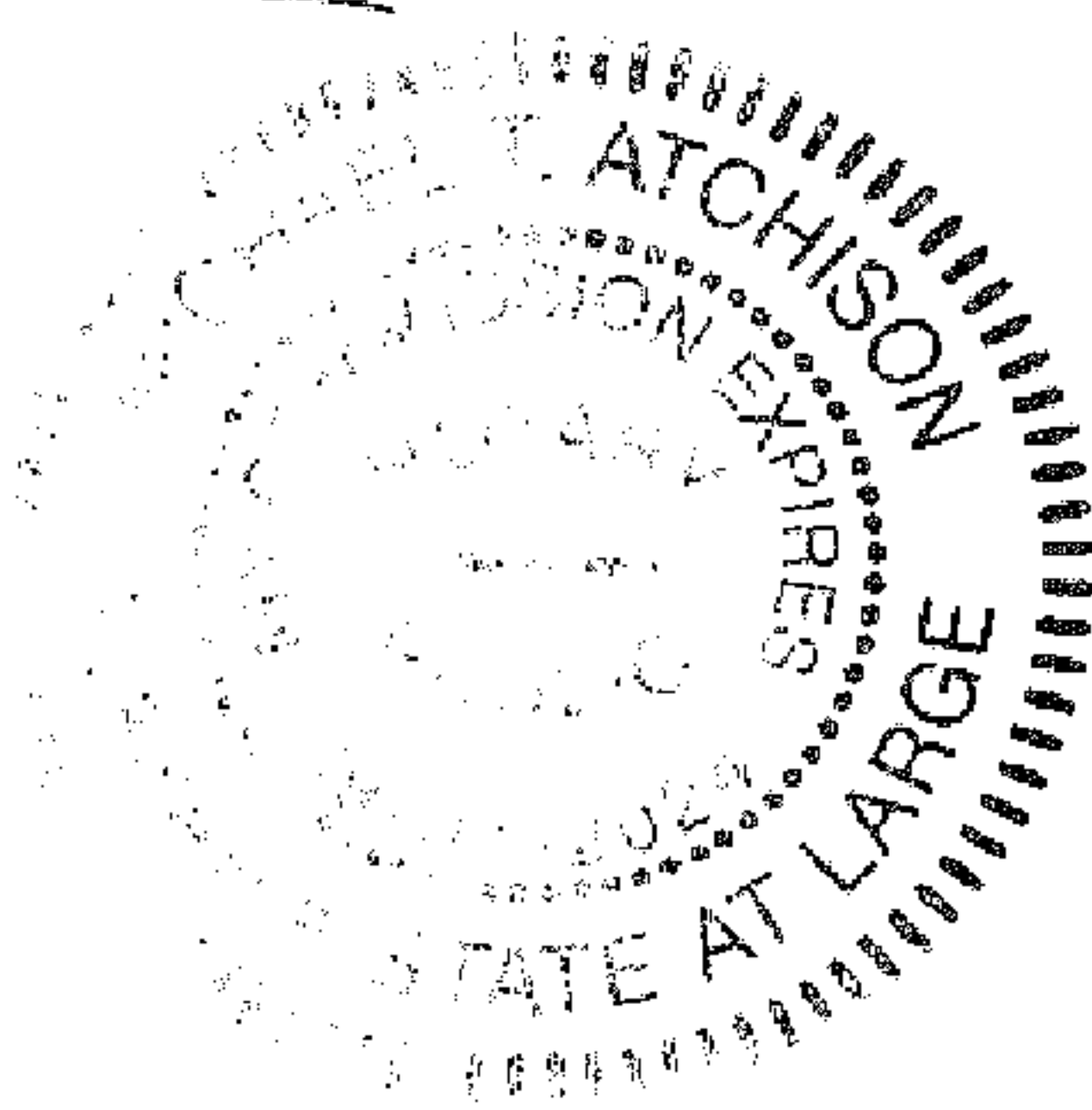
