Know All Men by These Presents: That in consideration of **Three Hundred Sixty Thousand and 00/100 Dollars (\$360,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **KENNETH E. GRAVES and spouse, KIMBERLY B. GRAVES** (herein referred to as Grantors) grant, bargain, sell and convey unto **JAVIER CANALES, JR. and JAZMIN ARCEO** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

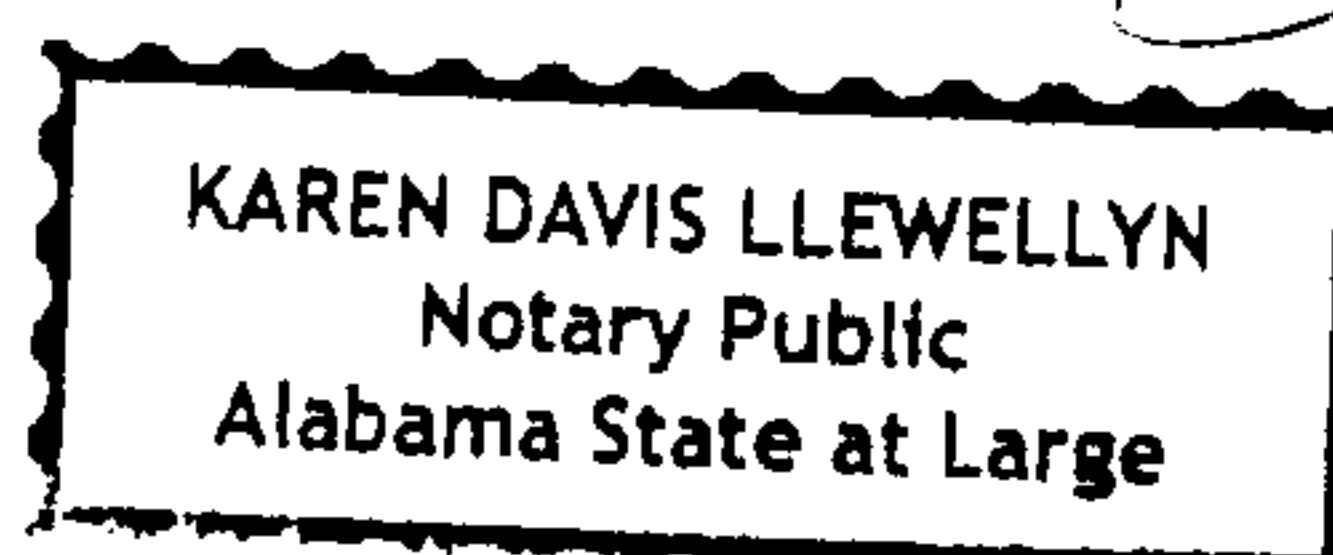



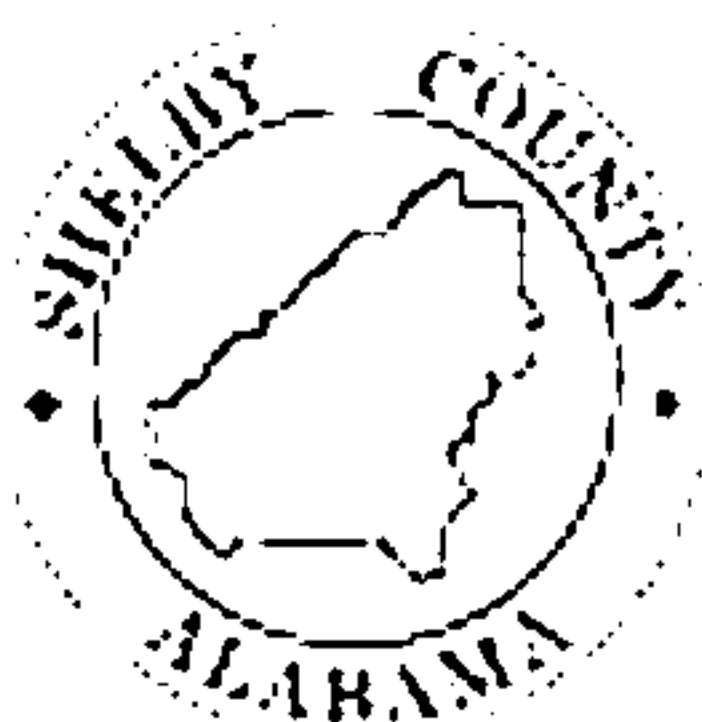
