**JOINT ACCESS AND MAINTENANCE AGREEMENT**

The Shared Roadway and Maintenance Agreement dated this 14th day of July, 2022 by and between **The City of Alabaster, Alabama**, 1953 Municipal Way, Alabaster, Alabama, 35007 (City), and **River & Cape Montessori Nursery School, LLC**, 534 Industrial Road, Alabaster, Alabama 35007 (Montessori School), collectively referred to as **Parties**.

**Background of Agreement**

Parties are owners of adjacent properties on Industrial Road, Alabaster, Alabama, namely, Patriots Park and the Montessori School, in Shelby County, Alabama. The Parties own properties that abut each other and have access from Industrial Road. Due to improvements being made to the City's property, the Parties are desirous of one ingress egress path that would serve both properties. The Parties have determined that it is in their mutual interest to have executed and recorded an agreement for concerning the costs of construction and maintenance and repair of the entrance and roadway. The purpose of this Agreement is the place into writing the mutual rights and obligations the Parties of the jointly used entry.

**Agreement**

**NOW THEREFORE**, in consideration of their mutual promises and intending to be legally bound, the parties agree as follows:

1. **Grant of Easement.** Each party grants to the other a permanent easement over and across their respective properties for the purpose in ingress and egress to their adjoining properties.


2. **Temporary Construction Easement.** The Montessori School hereby grants to the City for the benefit of the Parties, a temporary, non-exclusive grading and construction easement ("Temporary Construction Easement") over that portion of the School Property, as may be reasonably necessary for purposes of constructing the Joint Access Driveway. The Temporary Construction Easement shall terminate upon the completion of construction.

3. **Sharing of Costs and Expenses.** The parties shall share the expenses as follows:  
The City and its successors and assigns shall pay for the cost of construction of the new entrance, together with as much necessary of the Montessori School's drive to connect the school to the new entrance. Thereafter, the City shall be responsible for the repair and maintenance of the City's portion of the driveway, and the Montessori School shall be responsible for the school's portion of its drive from the point of connection to the City's driveway to its parking facilities.


4. **Binding Effect.** This Shared Driveway Agreement shall not be modified except in writing signed by the parties, their successors, or assigns. This Agreement and its obligations and benefits shall run with the land and shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.




