That in consideration of the sum of **Two Hundred Twenty Eight Thousand Dollars and No Cents (\$228,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Jason L. Leake, a married man** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **William Brasher and Jeannie Brasher**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

Jason L. Leake and Jason Leake are one in the same person.

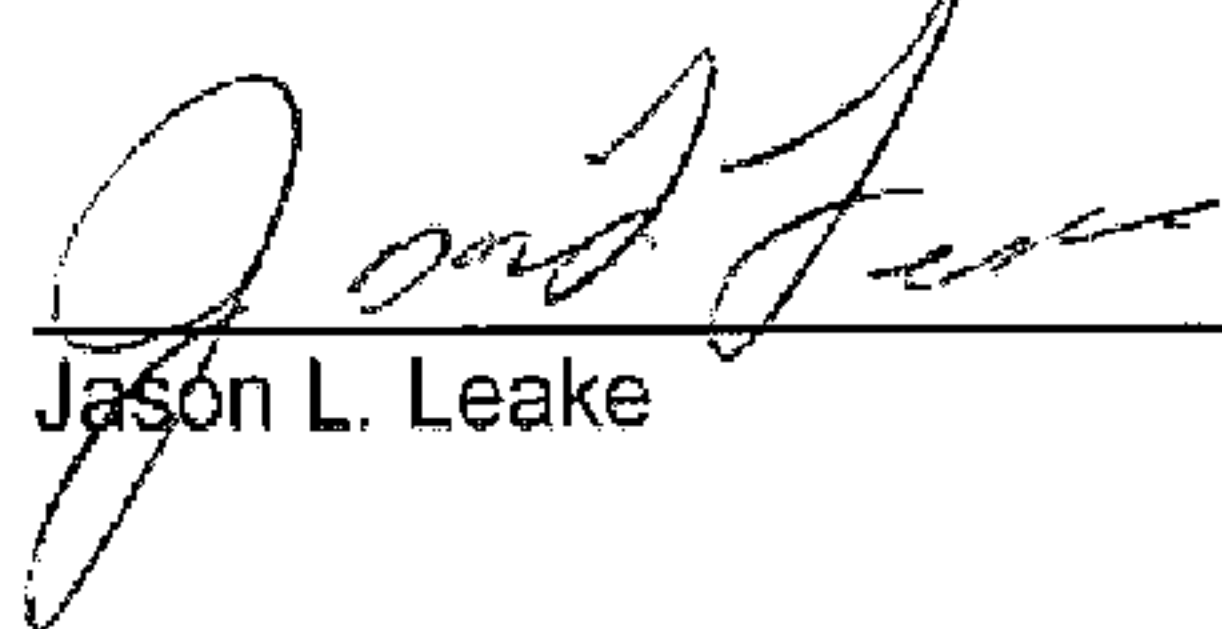
No part of the homestead of the Grantor herein or spouse.

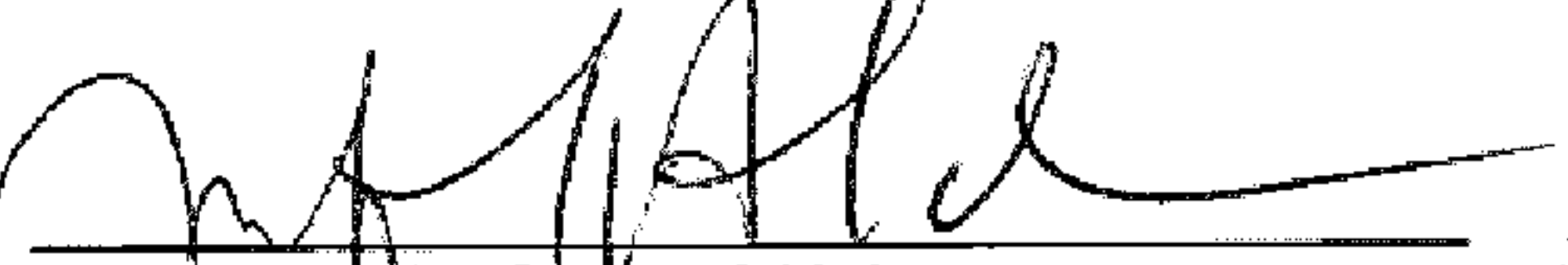

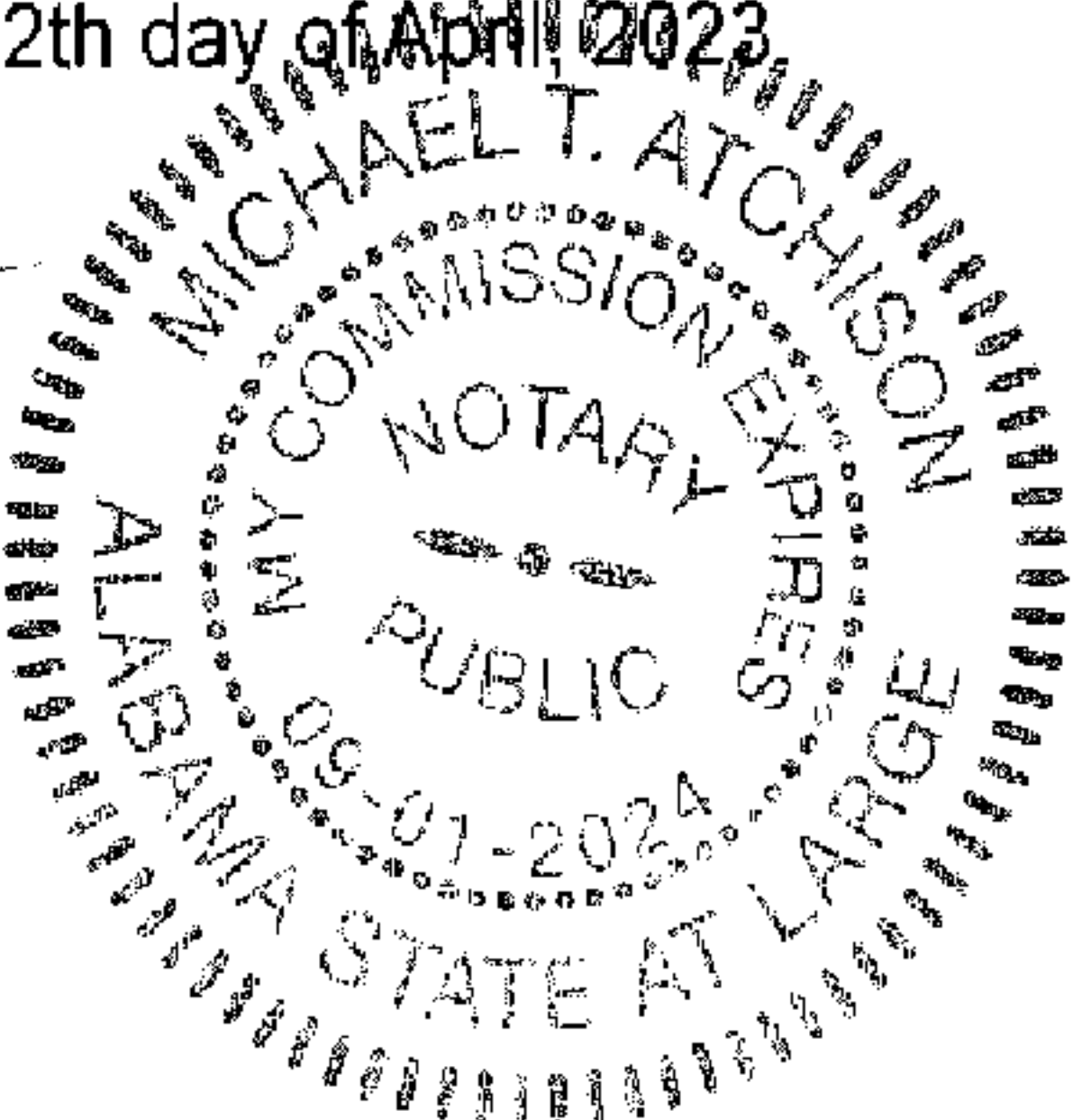
