KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TEN (\$10.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Janice Savage Edwards, an unmarried woman, the surviving grantee in that certain joint survivorship deed recorded in Instrument No. 20190812000291650 in the Office of the Judge of Probate of Shelby County, Alabama, the other grantee, George Lawrence Edwards, Jr., having died on or about December 8, 2022** (hereinafter referred to as GRANTOR whether one or more), the receipt whereof is hereby acknowledged, it is the intention of the GRANTOR to reserve to himself/herself during the full term of his/her natural life the right of possession and occupancy in and to the real estate and the rents and profits arising from it, and to convey unto the GRANTEE **Robert R.
