Page 76 A&B, in the Probate Office of Shelby County, Alabama.



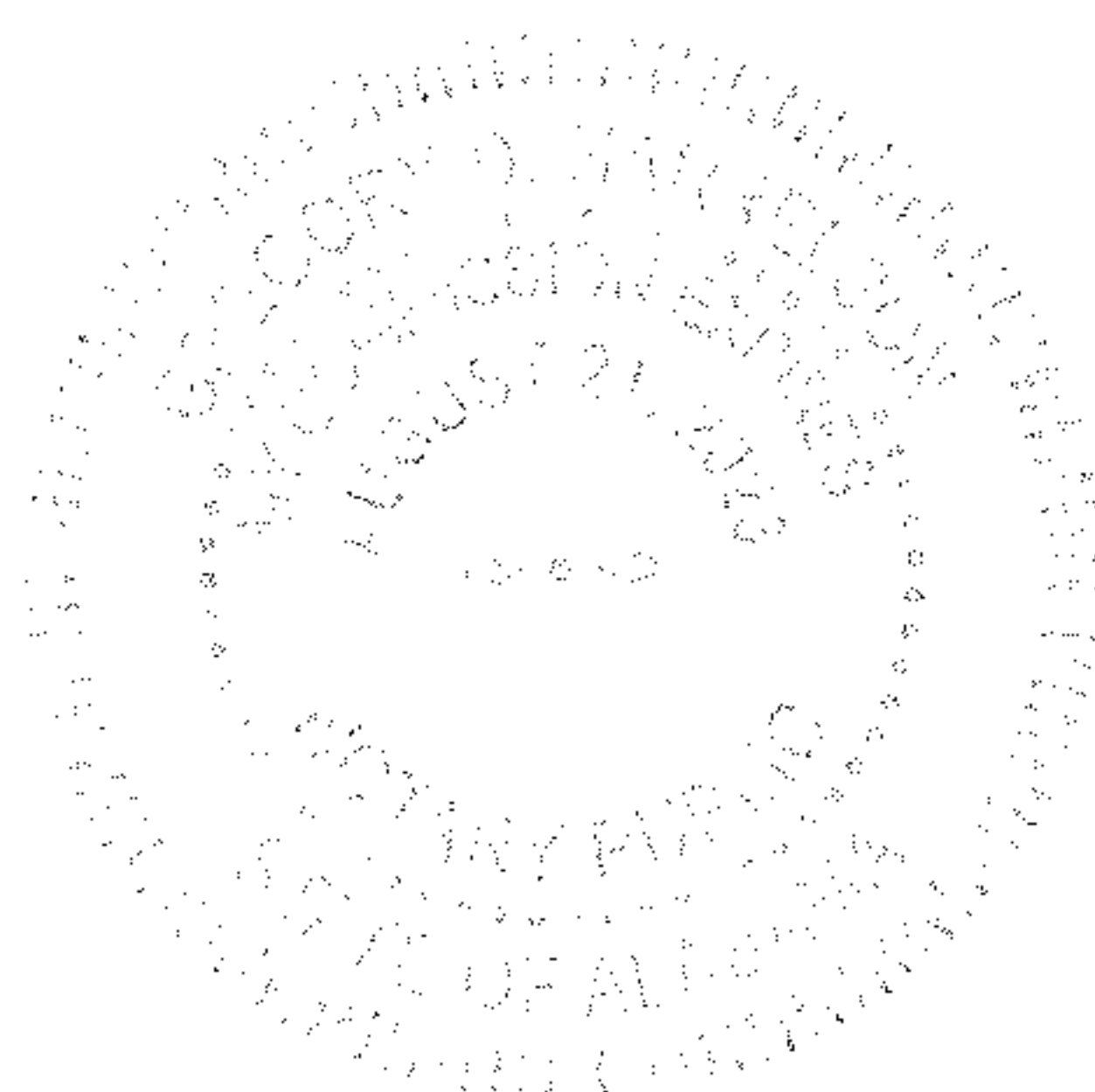
