That in consideration of **Two Hundred Ninety-Six Thousand Four Hundred and 00/100 (\$296,400.00)** Dollars and other good and valuable consideration paid in hand by the GRANTEE herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

**D.R. Horton, Inc. – Birmingham** (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

**Leydis Yohana Tejada Londono** (herein referred to as GRANTEE), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:



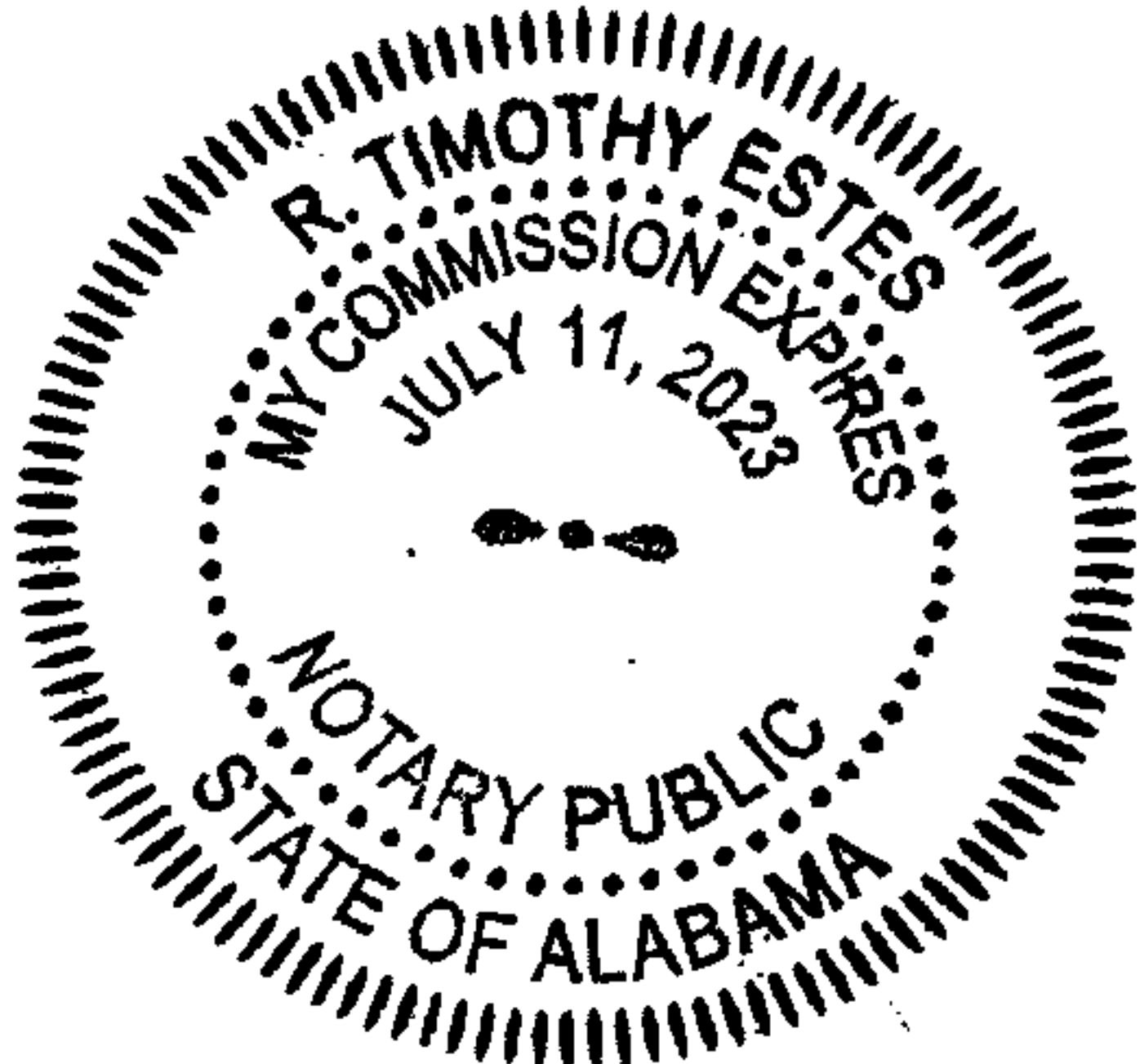

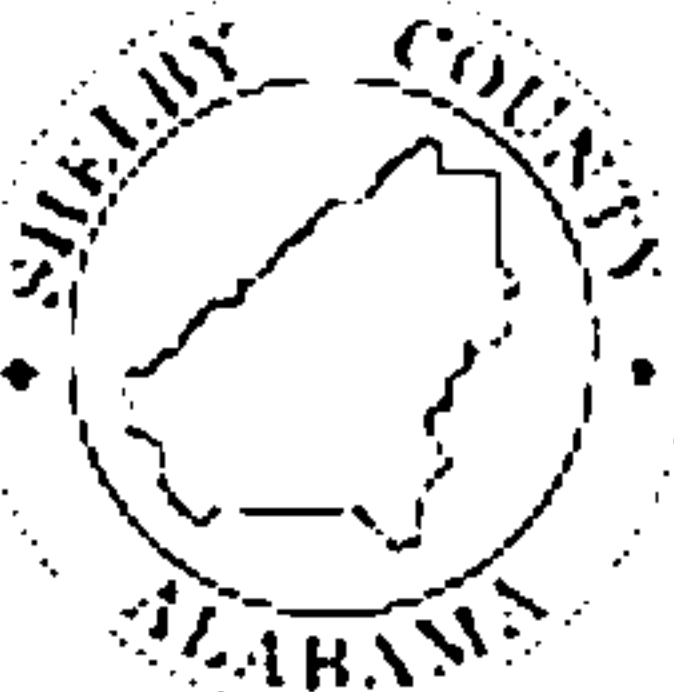
