That in consideration of **FOUR HUNDRED FIVE THOUSAND AND 00/100 DOLLARS (\$405,000.00)** to the undersigned grantor in hand paid by the grantee herein, the receipt whereof is hereby acknowledged, I,

Emily Renee Carroll, an unmarried woman and Anthony Michael Carroll, an unmarried man

(herein referred to as Grantor) does hereby grant, bargain, sell and convey unto,

Yugandhar Nimmagadda and Harshita Choudary

(herein referred to as Grantees), the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 11-24, according to the Survey of Chelsea Park 11th Sector, as recorded in Map Book 37, Page 95, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama. TOGETHER with the nonexclusive easement to use the Common Areas as more particularly described in the Declaration of Easements and Master Protective Covenants of Chelsea Park, a Residential Subdivision, executed by the Grantor and filed for record as Instrument No. 20041014000566950 in the Probate Office of Shelby County, Alabama and the Declaration of Covenants, Conditions and Restrictions for Chelsea Park 11th Sector executed by Grantor and Chelsea Park Residential Association, Inc. and recorded as Instrument No. 20070831000411450 (which together with all amendments thereto, are hereinafter collectively referred to as the "Declaration").

\$324,000.00 of the purchase price recited above has been paid from the proceeds of a mortgage loan closed simultaneously herewith.


TO HAVE AND TO HOLD unto the said grantees, as joint tenants, with right of survivorship, their heirs and assigns forever, it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do for ourselves and for our heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.


