WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this May 5, 2023, That for and in consideration of **TWO HUNDRED SEVENTY NINE THOUSAND AND NO/100 (\$279,000.00) DOLLARS,** and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **AJINKYA NALAWADE, a married person,** (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **JOHN G. FISHER III and BRENDA C. FISHER,** (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

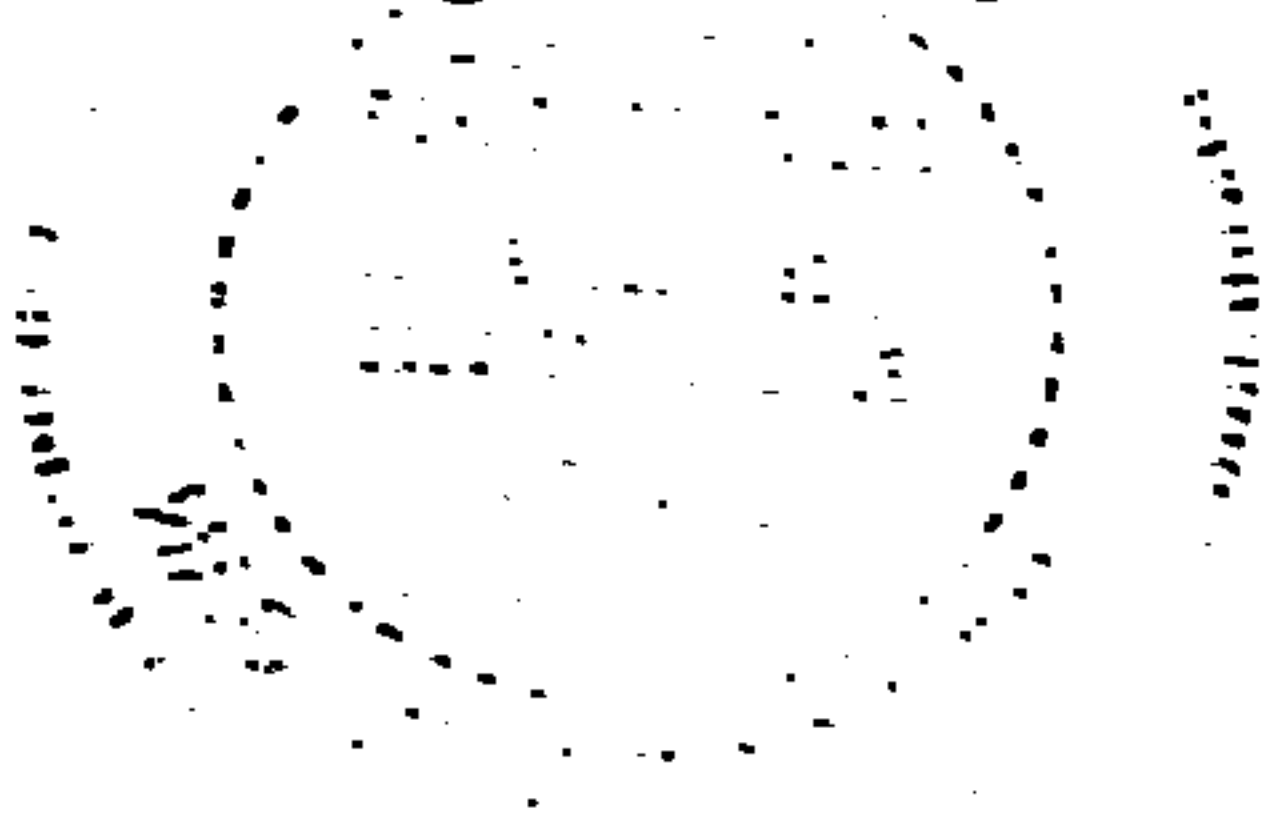

The property conveyed herein does not constitute the homestead of the grantor nor the homestead of the grantor's spouse.



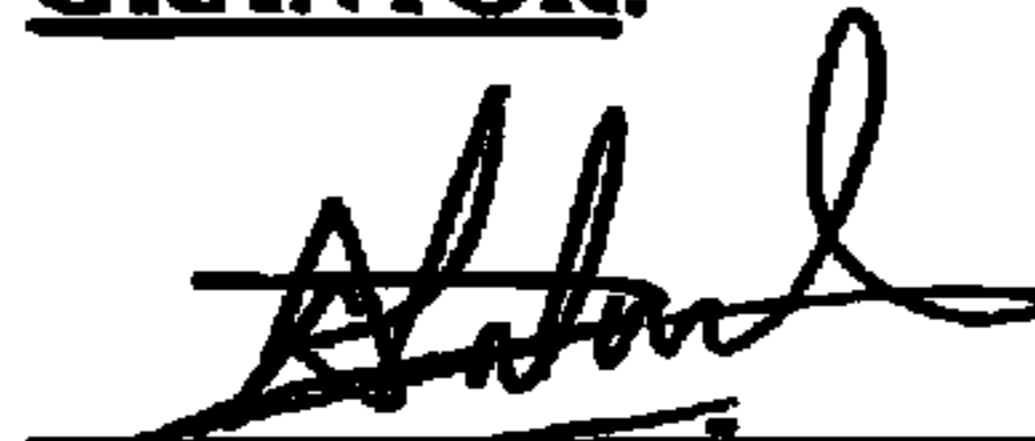

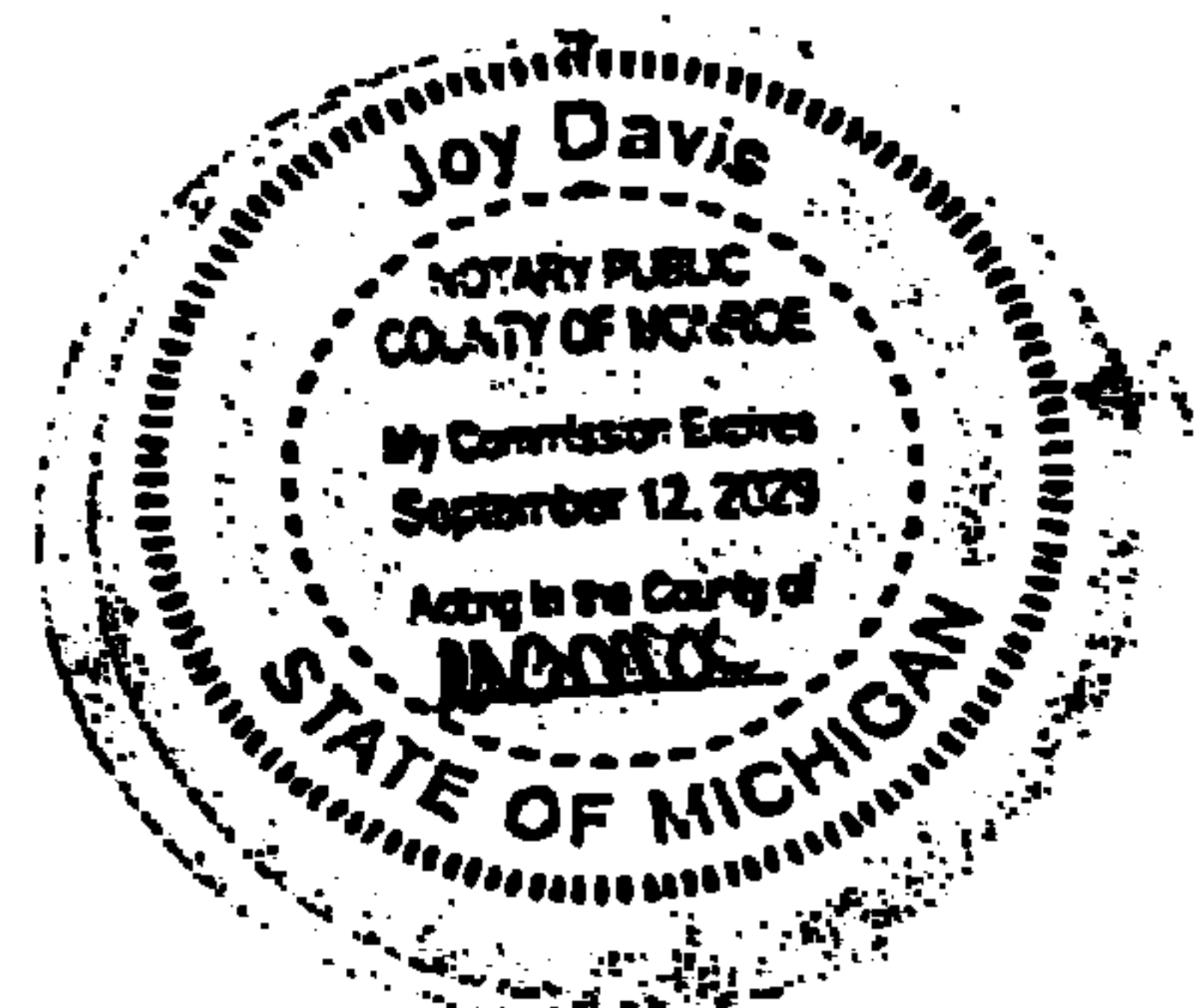
