LEGAL DESCRIPTION

Part of the NE 1/4 of the NE 1/4 of Section 23, Township 20 South, Range 3 West, lying in Shelby County, Alabama and being more particularly described as follows:

From the northeast comer of Section 23, Township 20 South, Range 3 West run west along the north boundary of said Section 23 for 258.56 feet, more or less, to a point on the west right of way line of the Atlantic Coast Line Railroad; thence turn an angle of 117 degrees 20 minutes to the left and run 433.20 feet to the point of beginning of the land herein described; thence turn an angle of 90 degrees 00 minutes to the right and run for 167.18 feet to a point of the east side of the Old Montgomery Highway; thence turn an angle of 98 degrees 48 minutes to the left and run for 149 .48 feet; thence turn an angle of 89 degrees 18 minutes to the left and run for a distance of 145.75 feet, more or less, to the west right of way line of the A.C.L. Railroad; thence turn an angle of 81 degrees 54 minutes to the left and run northwesterly along the west right of way line of the A.C.L. Railroad for 127.45 feet, more or less, to the point of beginning.
