STATUTORY WARRANTY DEED - Jointly for Life with Remainder to Survivor

That in consideration of **ONE MILLION TWO HUNDRED NINETY SIX THOUSAND TWO HUNDRED NINETY TWO AND 00/100 DOLLARS (\$1,296,292.00)** to the undersigned grantor, **Blackridge Partners, LLC, an Alabama Limited Liability Company**, (herein referred to as GRANTOR) in hand paid by the grantees herein, the receipt whereof is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto **Frank Griffith and Pamela D. Griffith**, (herein referred to as Grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

\$1,016,845.00 of the purchase price recited above has been paid from the proceeds of a mortgage loan closed simultaneously herewith.


SUBJECT TO ALL MATTERS OF RECORD



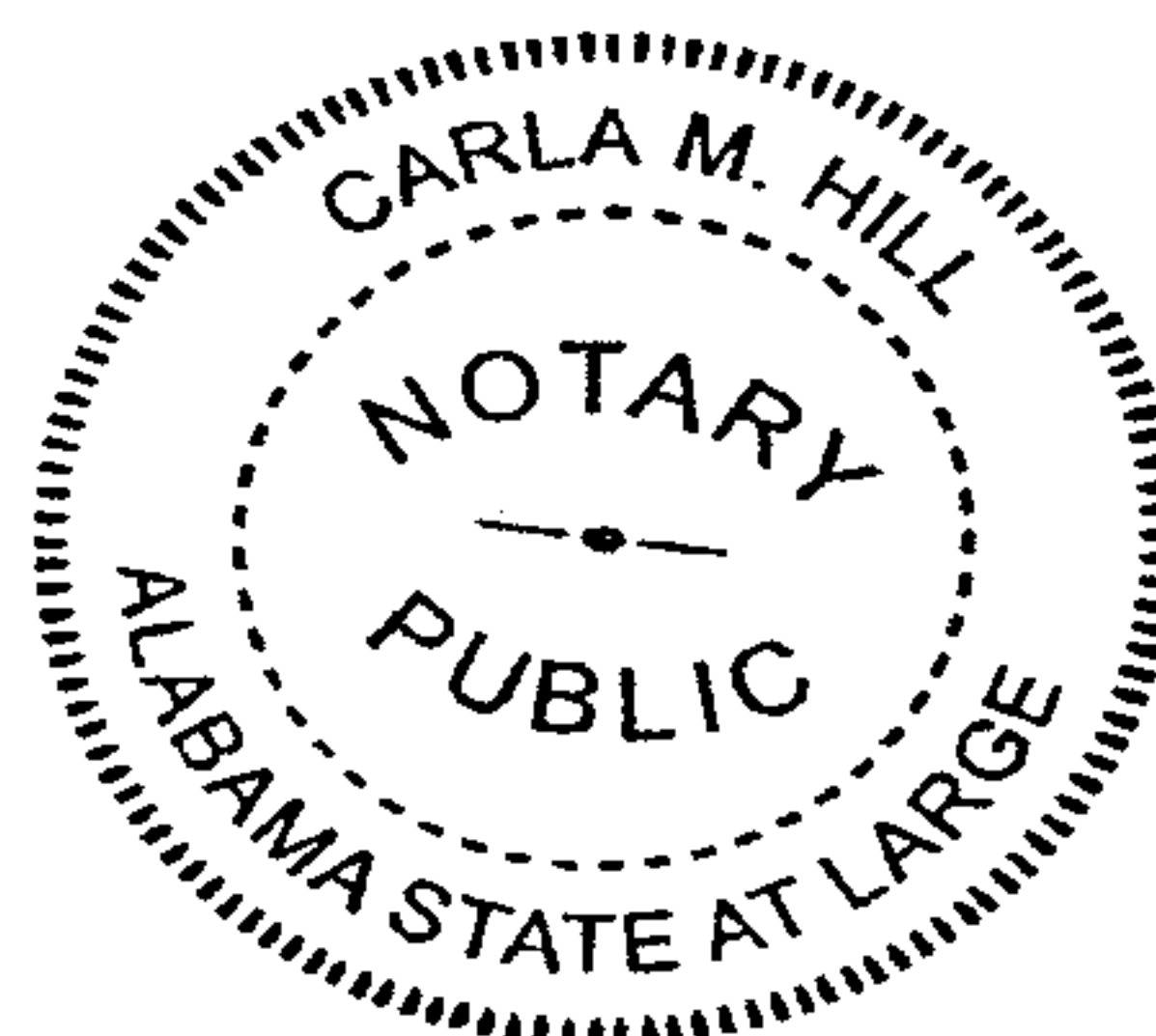
