Halka**, whose address is , (hereinafter "Grantee", whether one or more), the receipt and sufficiency of which are hereby acknowledged, Grantor does, by these presents, grant, bargain, sell, and convey unto Grantee **Joshua T. Halka and Caitlin T. Halka, as joint tenants with right of survivorship**, the following described real estate situated in Shelby County, Alabama, the address of which is **316 Crossbridge Road, Chelsea, AL 35043 to-wit:**

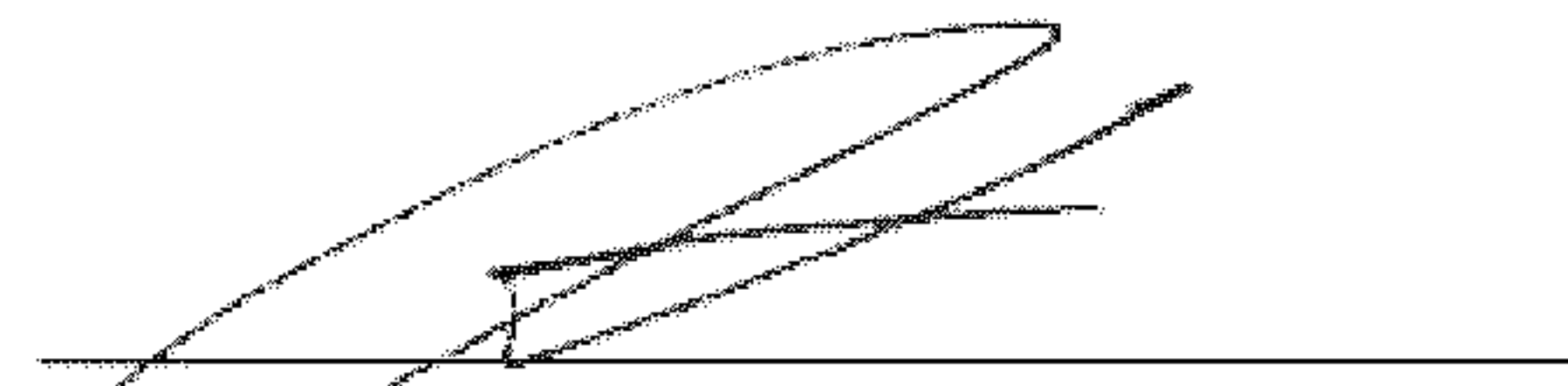

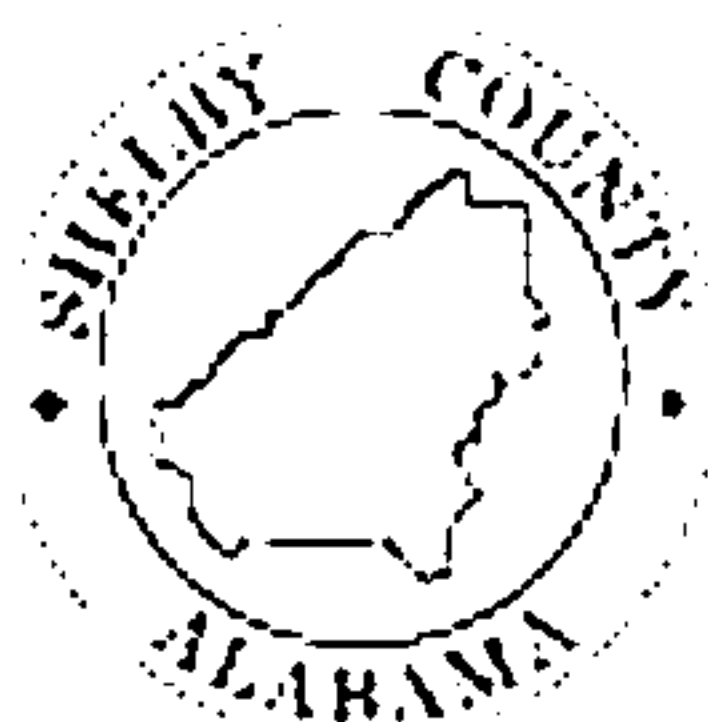
