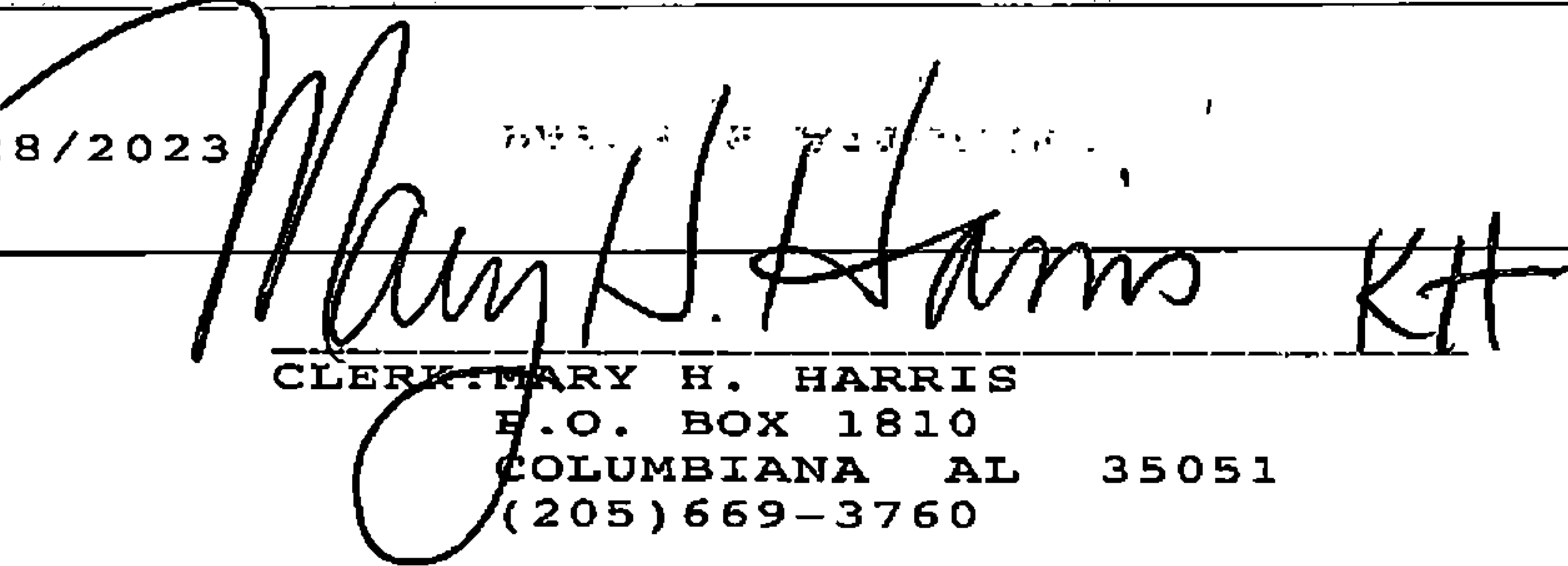

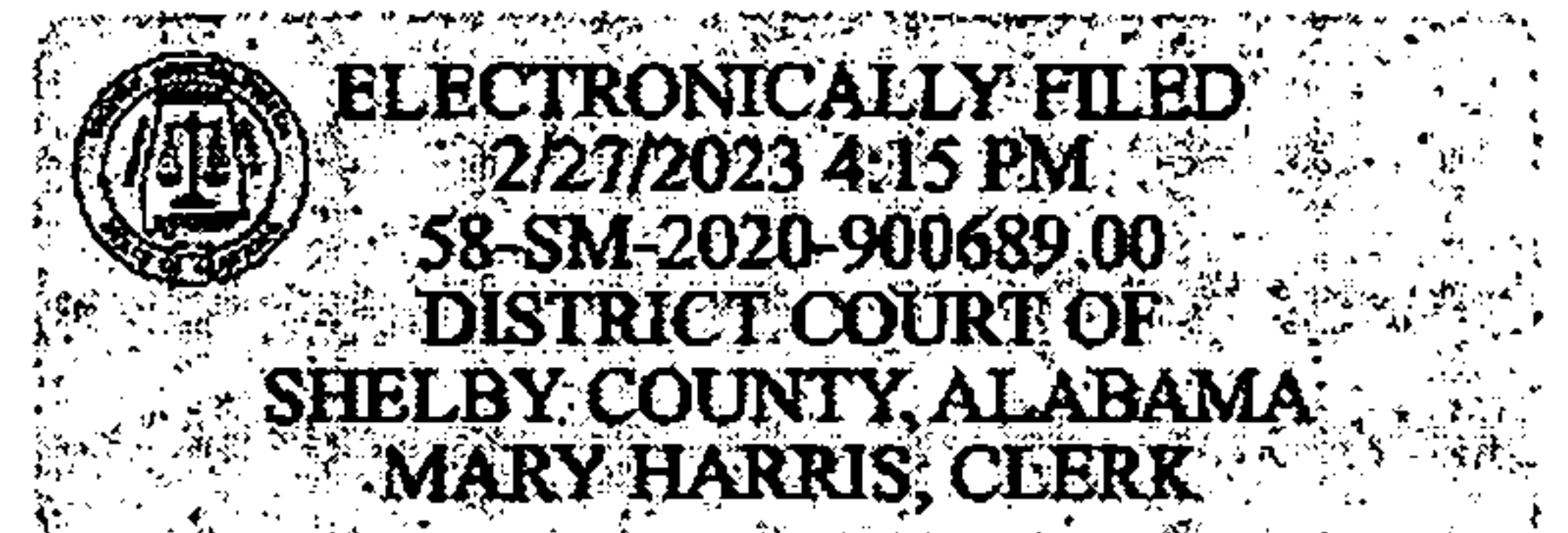

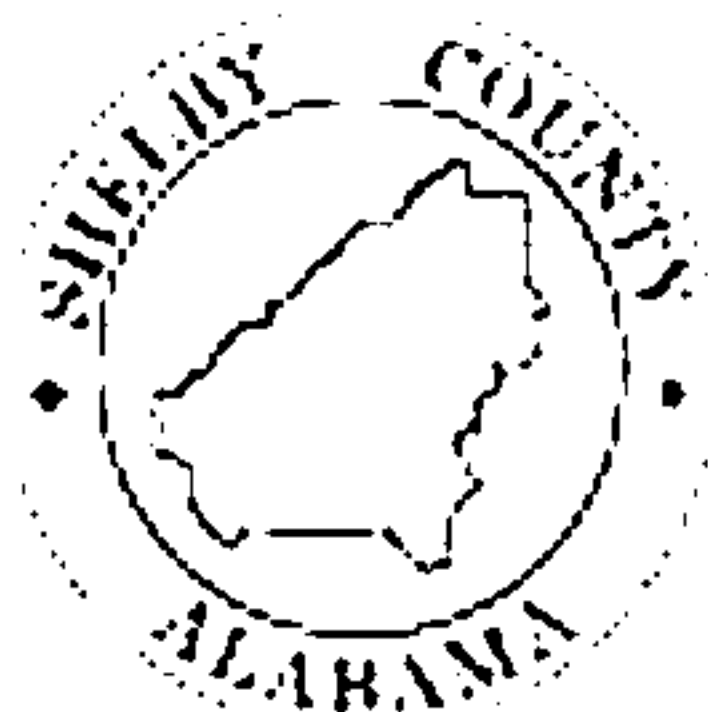
JUDGMENT ON TRIAL
