
Certificate of Trust

A copy of this Certificate of Trust shall be just as valid as the original.



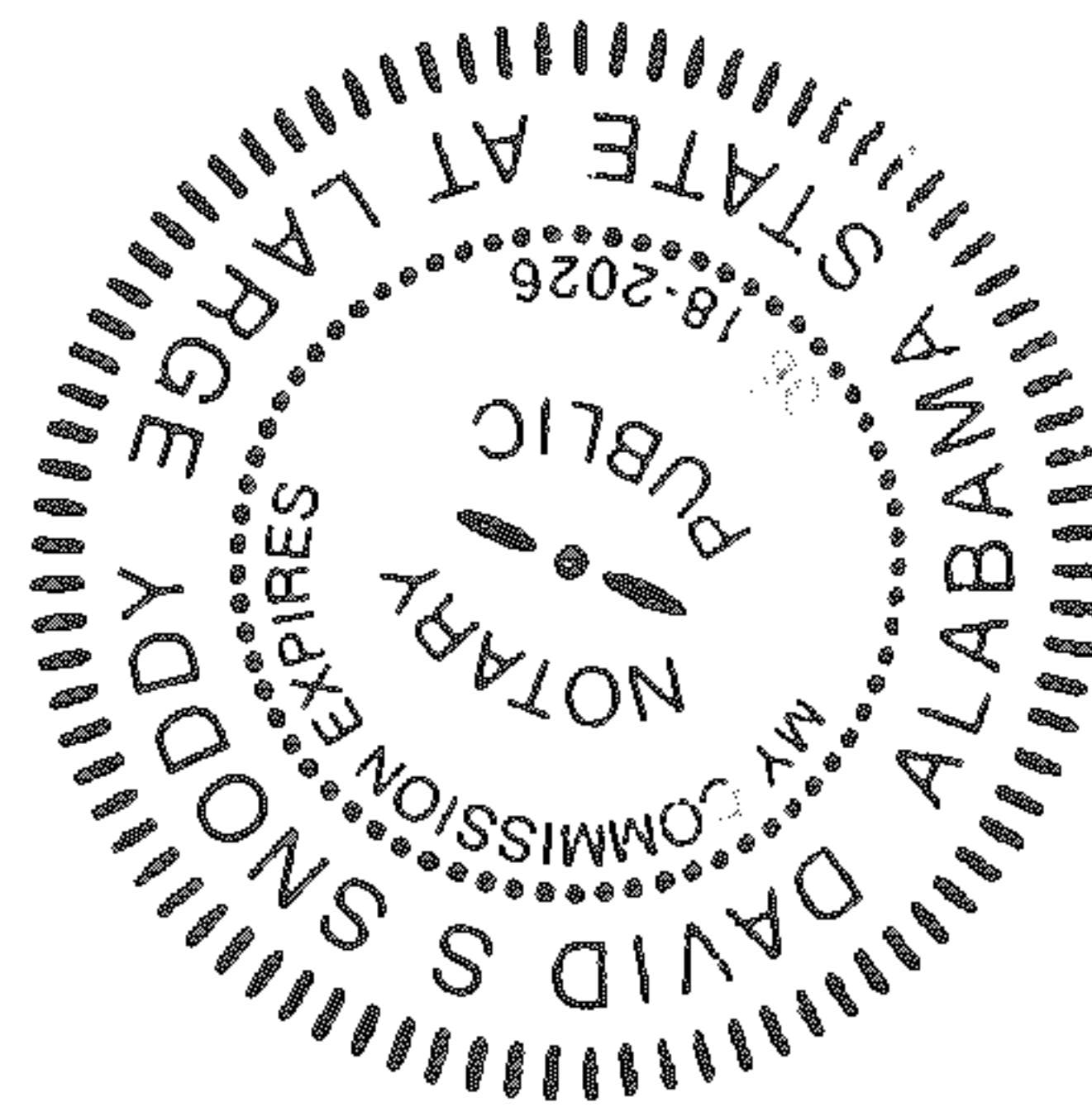
