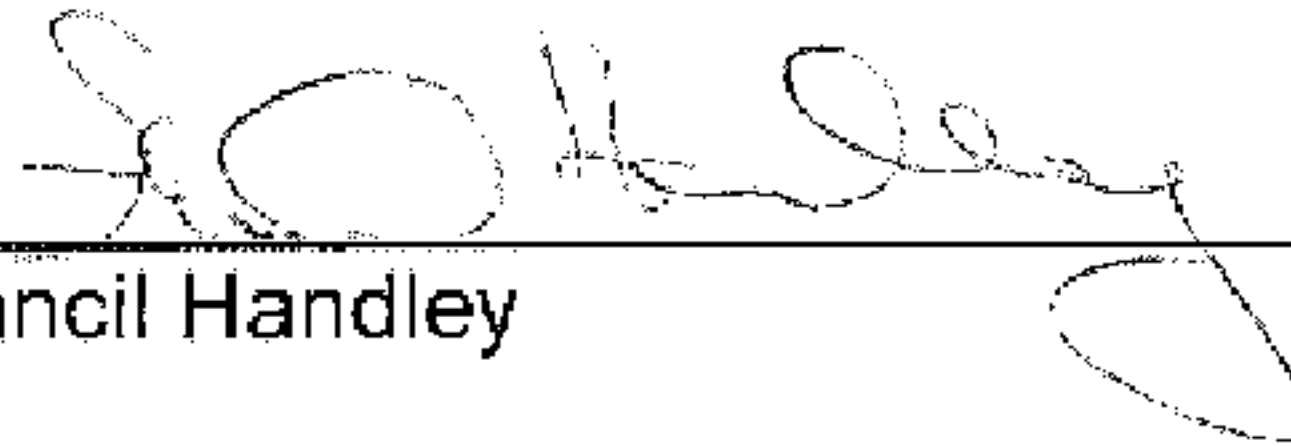

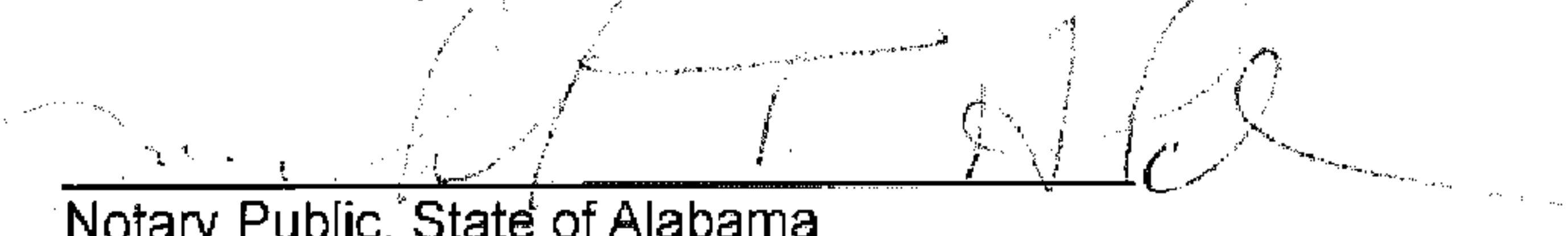

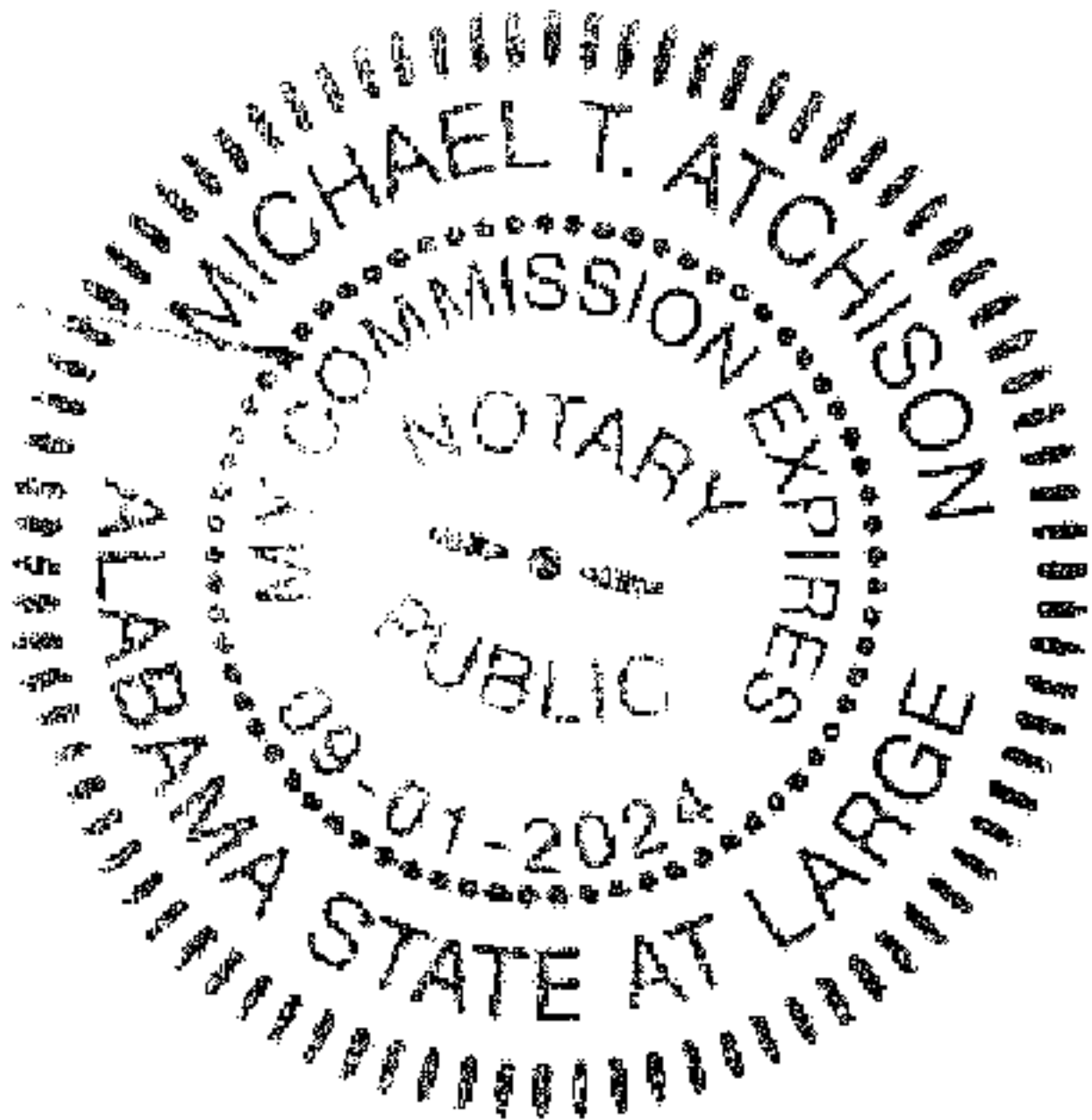

**LEGAL DESCRIPTION**

That certain tract or parcel of land in the town of Columbiana, Alabama, described as beginning at the intersection of the North line of Sterrett Street with the East line of Section 23, Township 21 South of Range 1 West , and run thence North along East line of said section 91 feet; thence run in a westerly direction at an included angle of 91 degrees 30 minutes 100 feet; thence in a southerly direction at an included angle of 88 degrees 49 minutes 93.6 feet to the North line of Sterrett Street; thence East along the North line of Sterrett Street 100 feet to the point of beginning.
