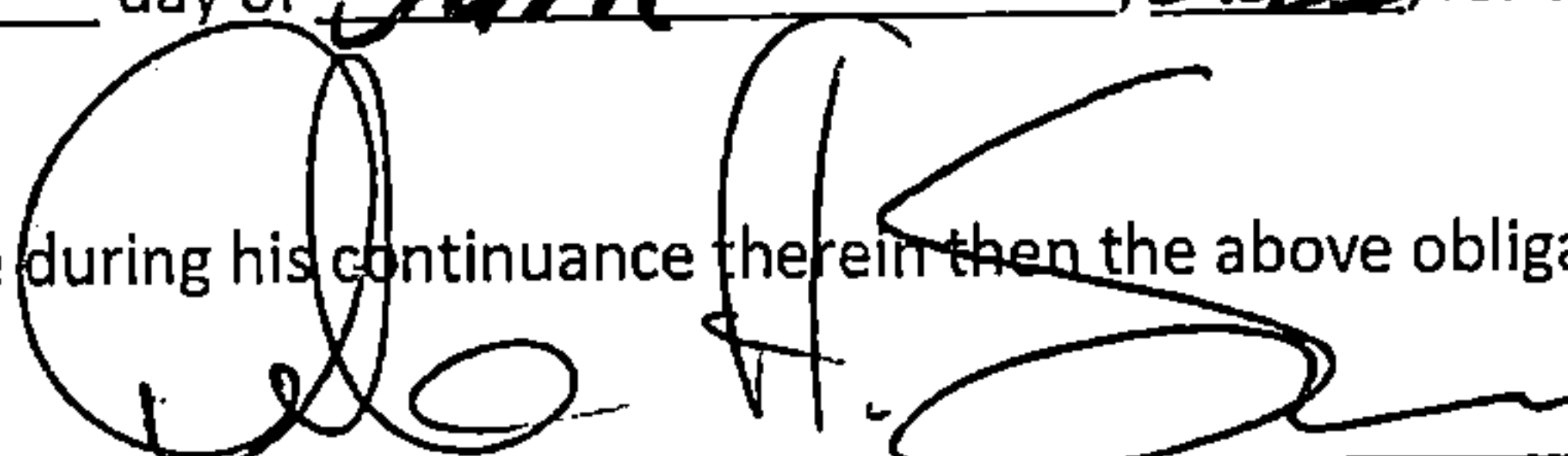

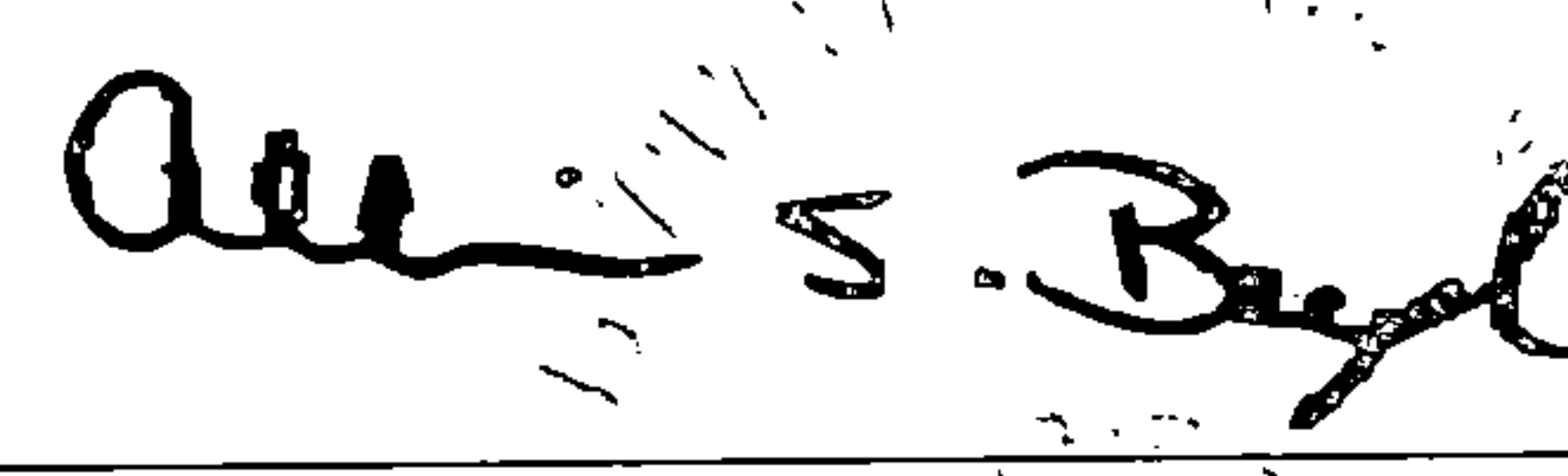

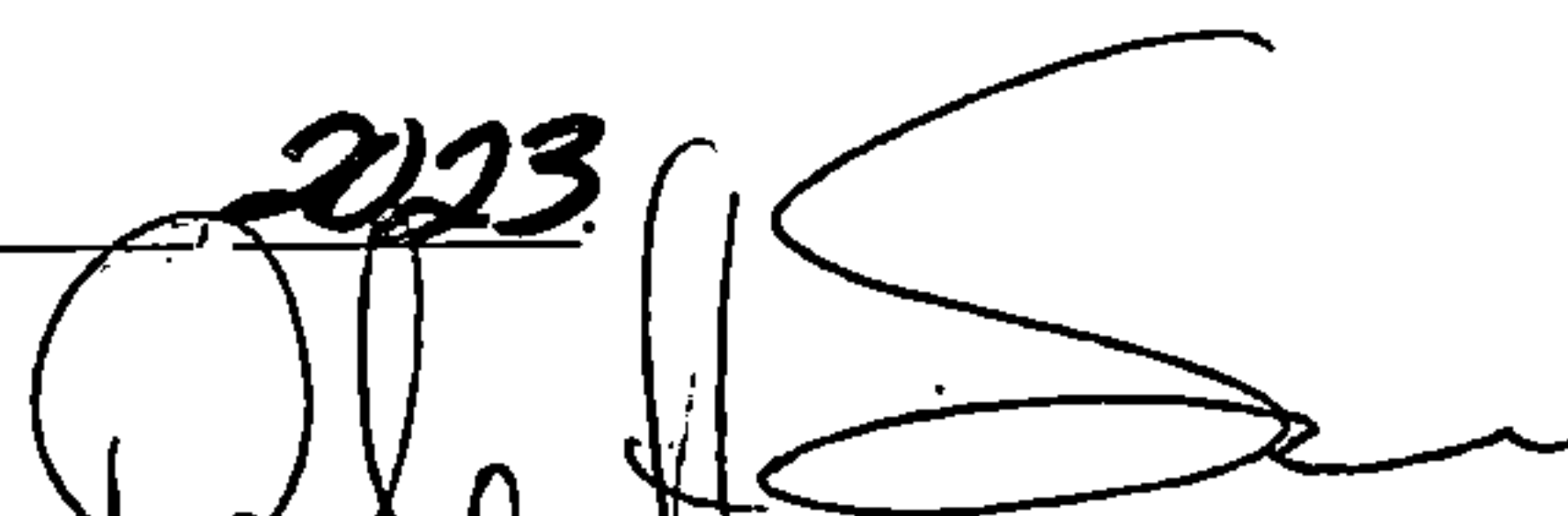

## OATH OF OFFICE

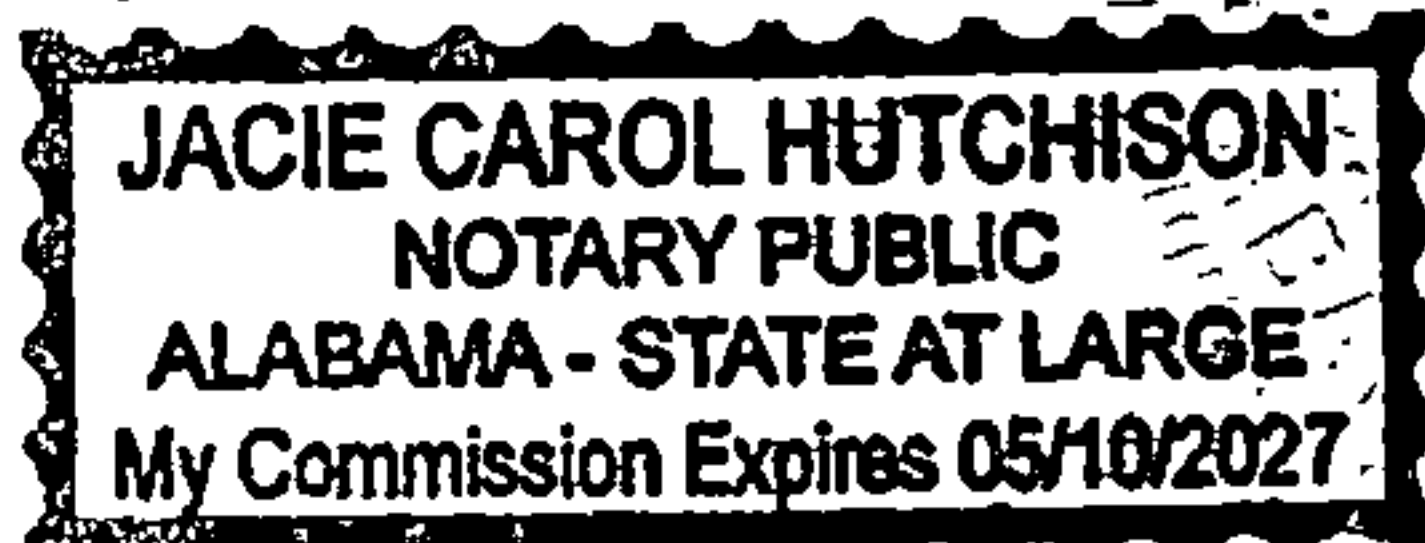

Does hereby constitute and appoint Niki Conway

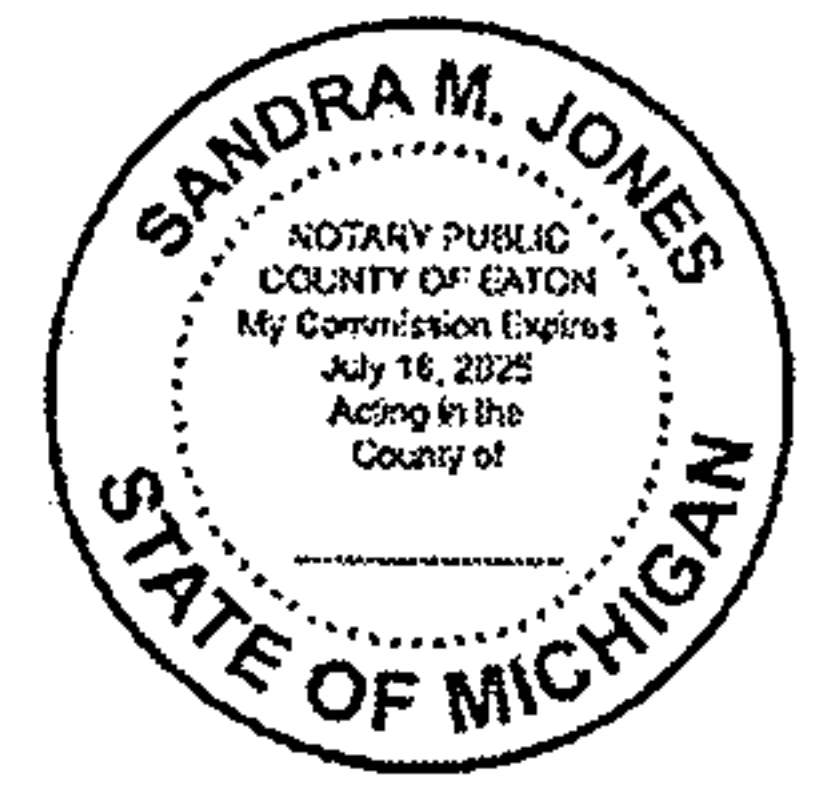

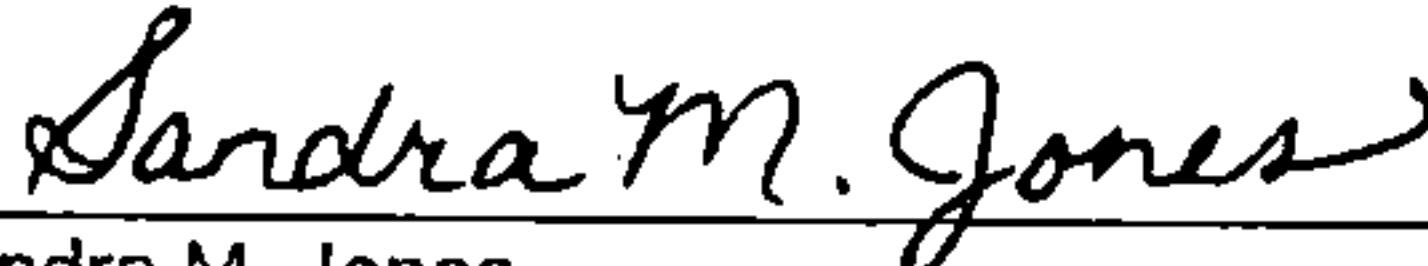

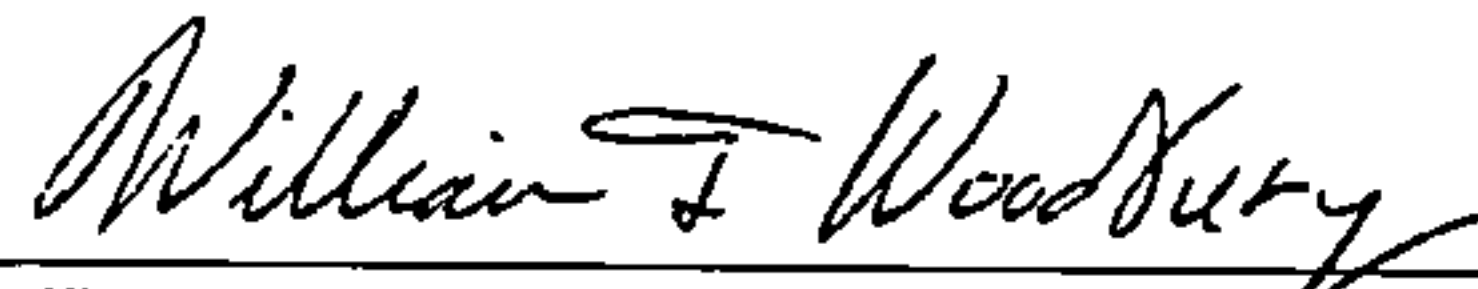
