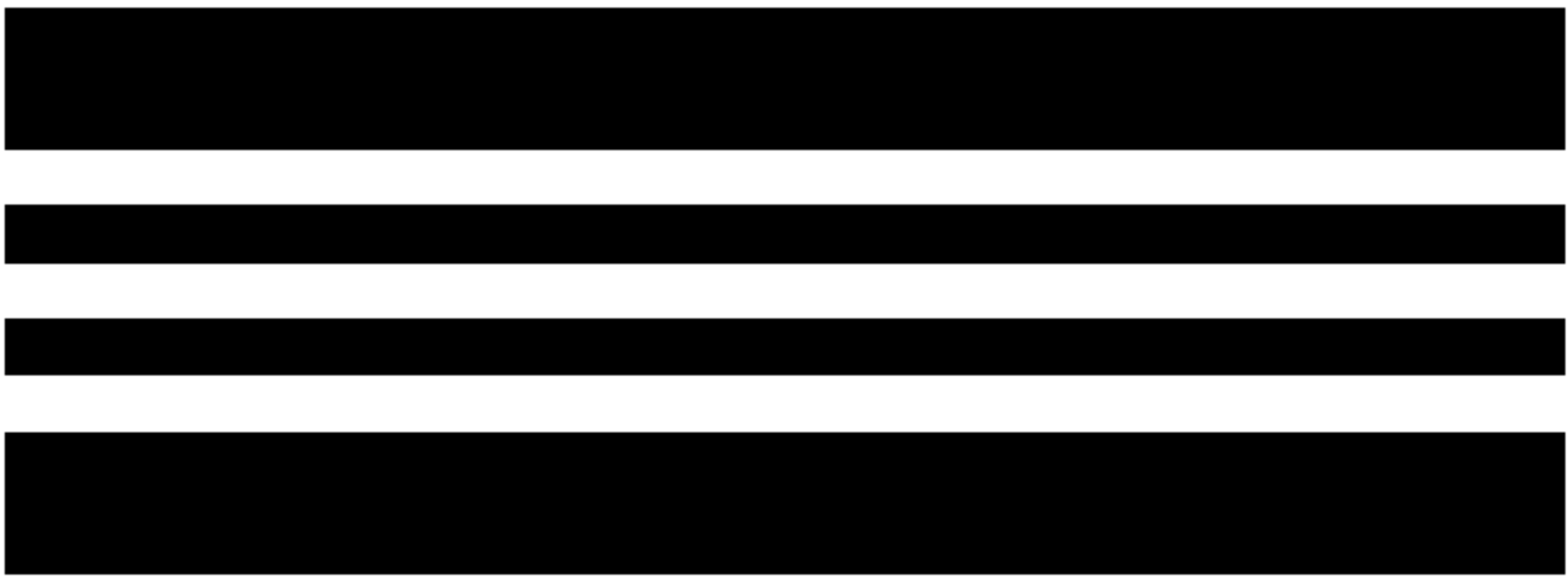

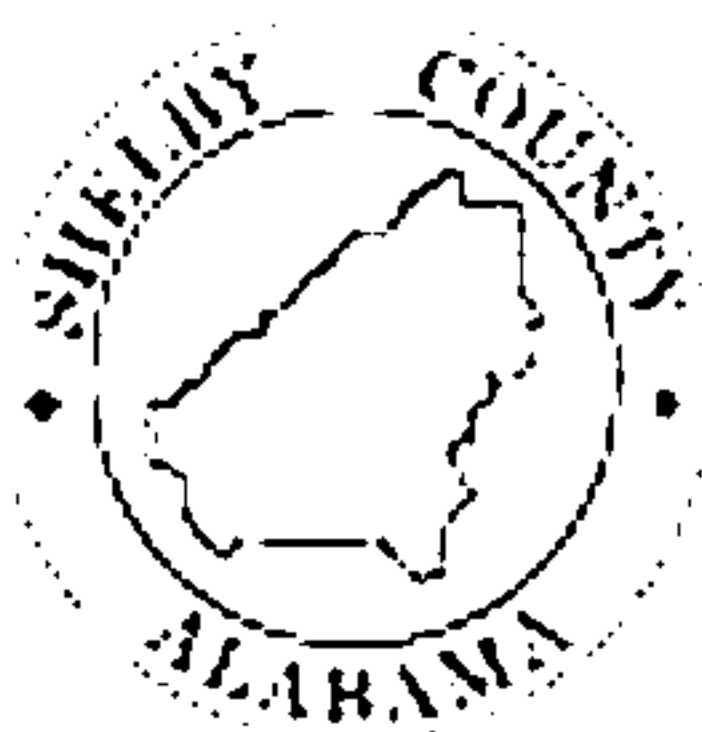
SCHEDULE 2**LEGAL DESCRIPTION**
