That in consideration of **Three Hundred Twenty-One Thousand Nine Hundred and 00/100 (\$321,900.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEE herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Ray P Richards (herein referred to as GRANTEE), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 107, as shown on the Chelsea Acres Sector 1, according to the map or plat thereof, recorded in Plat Book 57, Page 15, in the Office of the Judge of Probate of Shelby County, Alabama.

Mineral and mining rights excepted. Subject to: current taxes not yet due and payable, conditions, covenants, easements, exceptions, limitations, reservations, and restrictions of record.

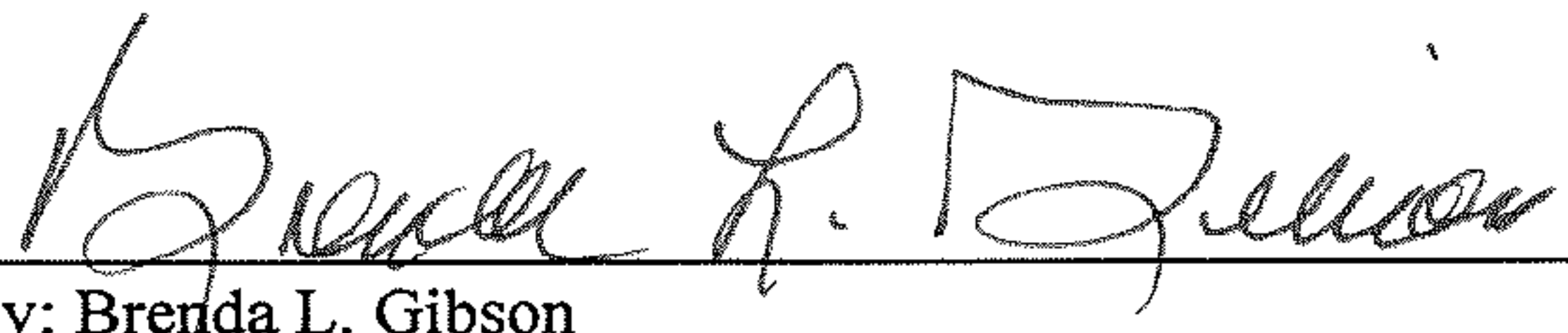

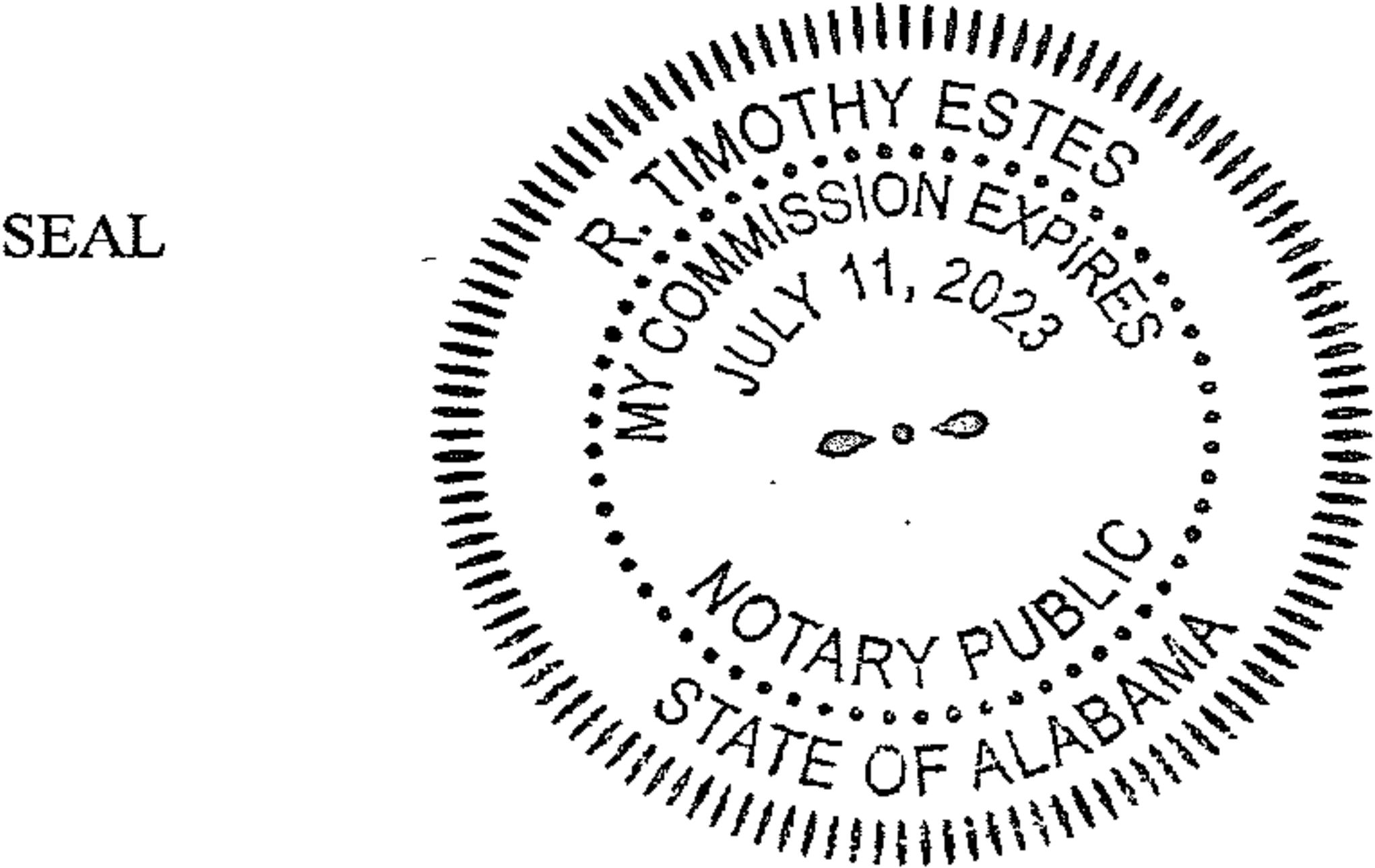
