4. **James W. Martin** died on or about November 10, 2010.

6. The SSN of either Trustor may be used as the Taxpayer Identification Number (TIN) or (EIN) for the Trust.
7. Unless otherwise provided in our Trust Agreement, when either one or both of us are serving as Trustee under our Trust, that one or either of us may conduct business and act on behalf of our Trust without the consent of any other Trustees.
8. With respect to real property, the Trustees are authorized under the Trust Agreement to:
 - hold/acquire title to real property in the name of and on behalf of the Trust.
 - sell/convey real property in the name of and on behalf of the Trust
 - encumber/mortgage real property in the name of and on behalf of the Trust
 - lease real property in the name of and on behalf of the Trust
 - otherwise deal with interests in real property in the name of and on behalf of the Trust
9. All powers of the Trustees are fully set forth in **Article 14** of the Trust Agreement which is attached hereto.
10. Our Trust is revocable, however our Trust has not been revoked and there have been no amendments limiting the powers of the Trustees over trust property.
11. No person or entity paying money to or delivering power to the Trustee(s) shall be required to see its application. All persons relying on this document regarding the Trustees and their respective powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A copy of this Certificate of Trust shall be just as valid as the original.

12. This Certification of Trust is being made to certify the powers of the Trust relating to real property. Statements herein are made as sworn statements and may violate state and federal law if falsely made.

13. The parties hereby certify that the Trust has not been revoked and the only amendments or modifications thereto which terminate, revoke, substitute or otherwise amend the Trustees named herein or otherwise limit the powers of the Trustees over trust property, is the death of James W. Martin.

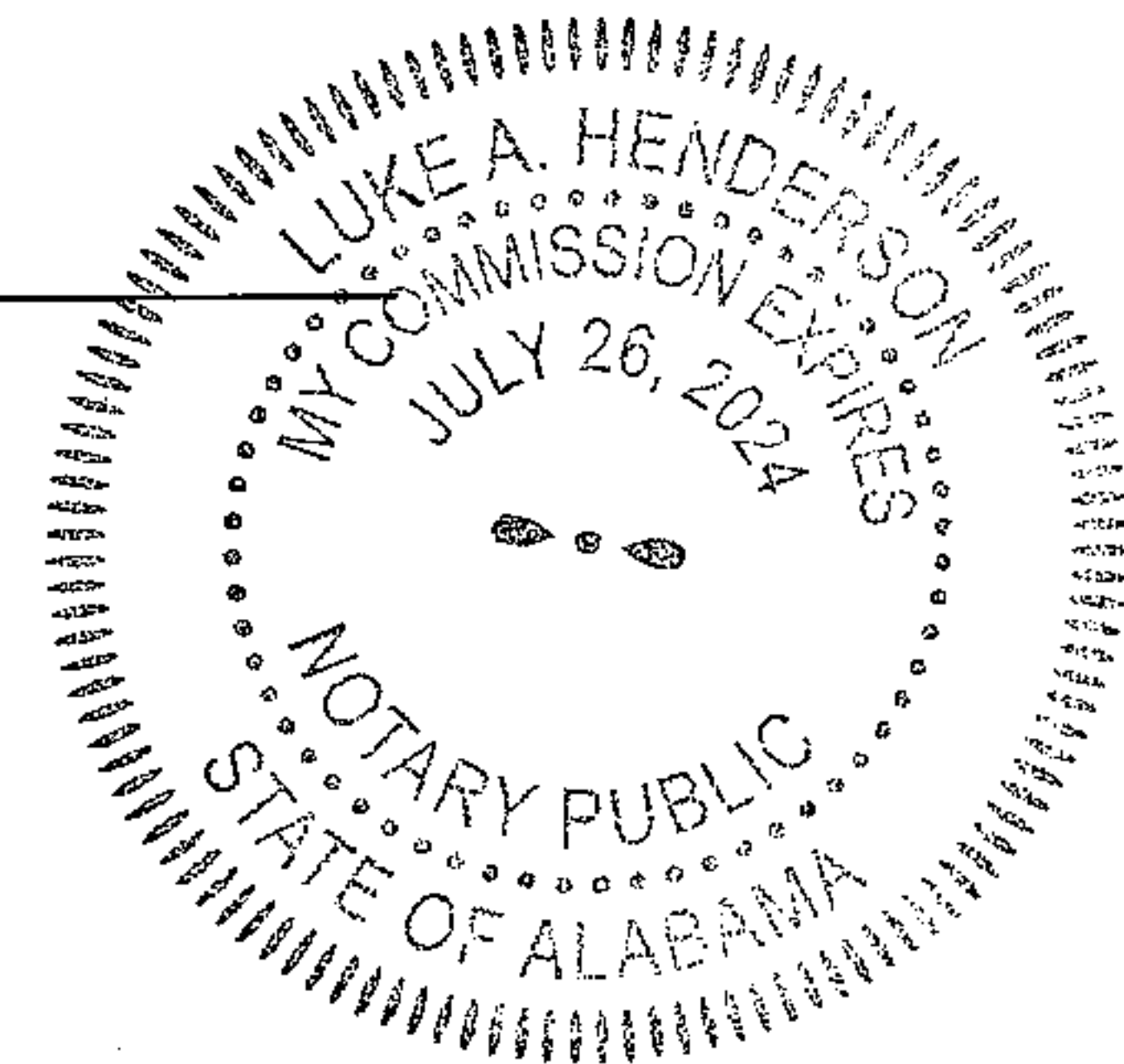

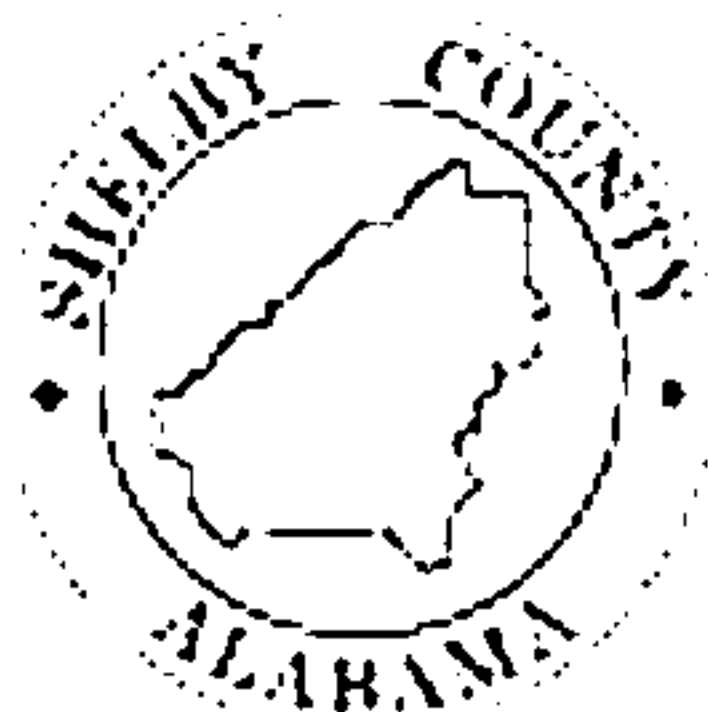
