Affiant further states that the Decedent, **Raymond Ellis Butler**, is the true owner of the above property and this affidavit is to be used to determine ownership of said real property.

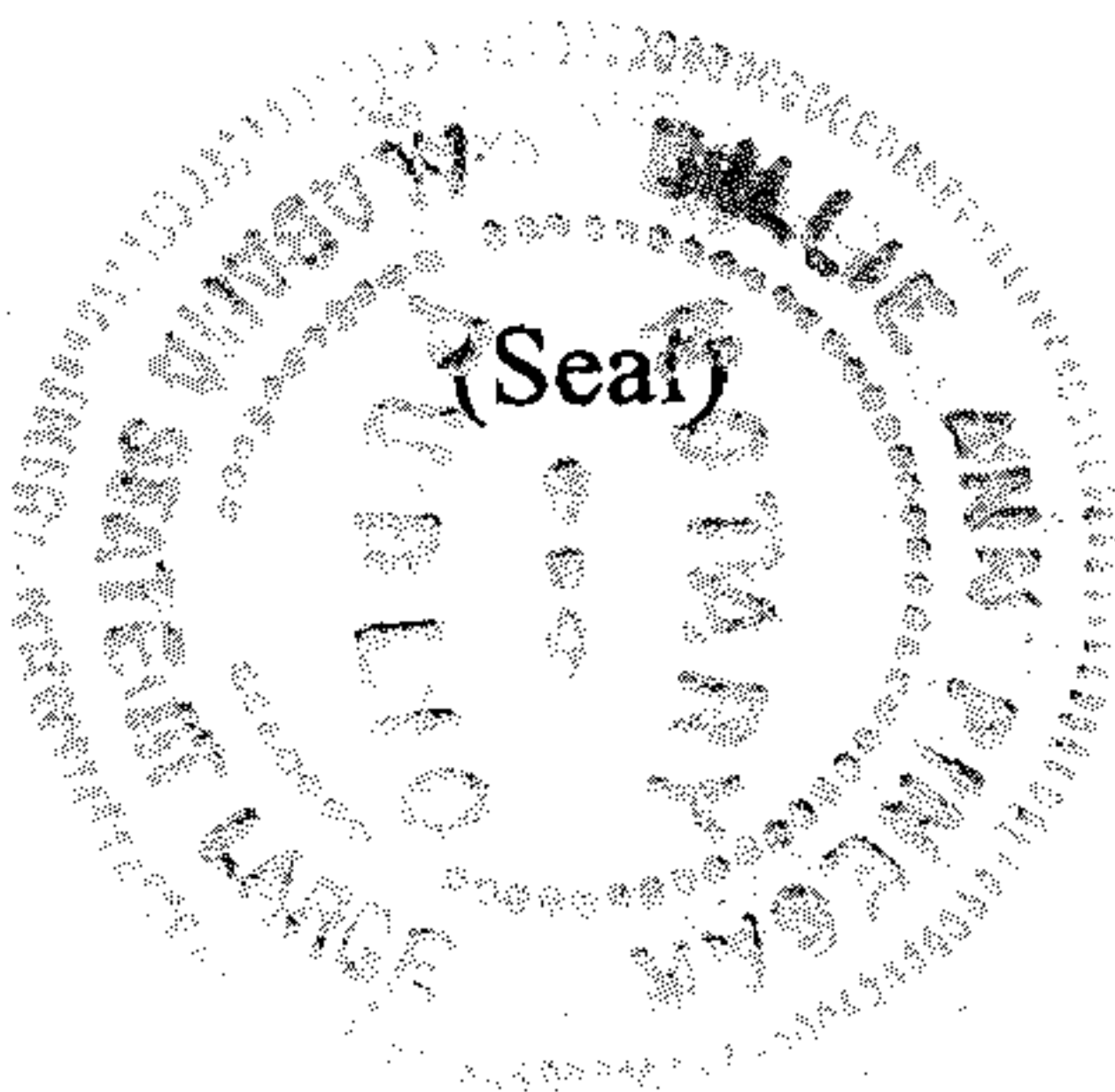
