That in consideration of **Three Hundred Forty-Five Thousand Nine Hundred and 00/100 (\$345,900.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEE herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Cleo Patricia Thomas (herein referred to as GRANTEE), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 160, as Shown on the Amended Final Plat of Koslin Farms Phase 1, according to the map or plat thereof, recorded in Plat Book 56, Page 51, in the Office of the Judge of Probate of Shelby County, Alabama.

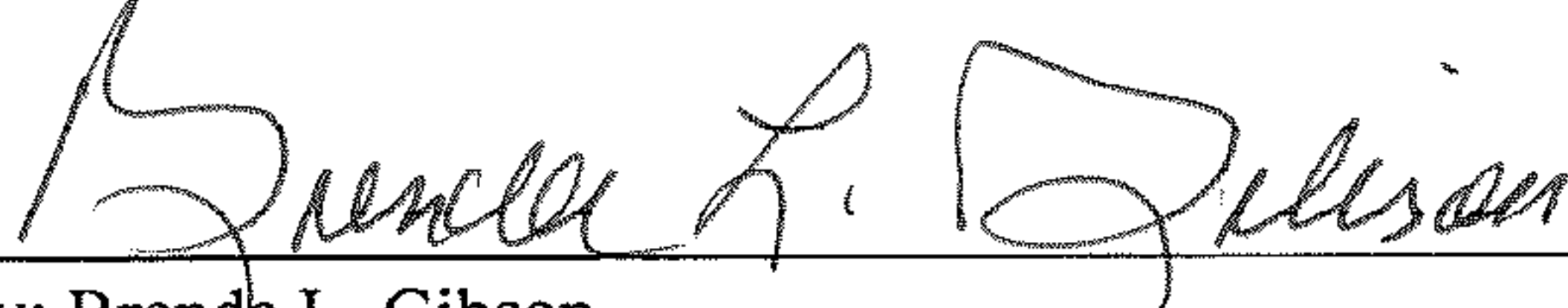

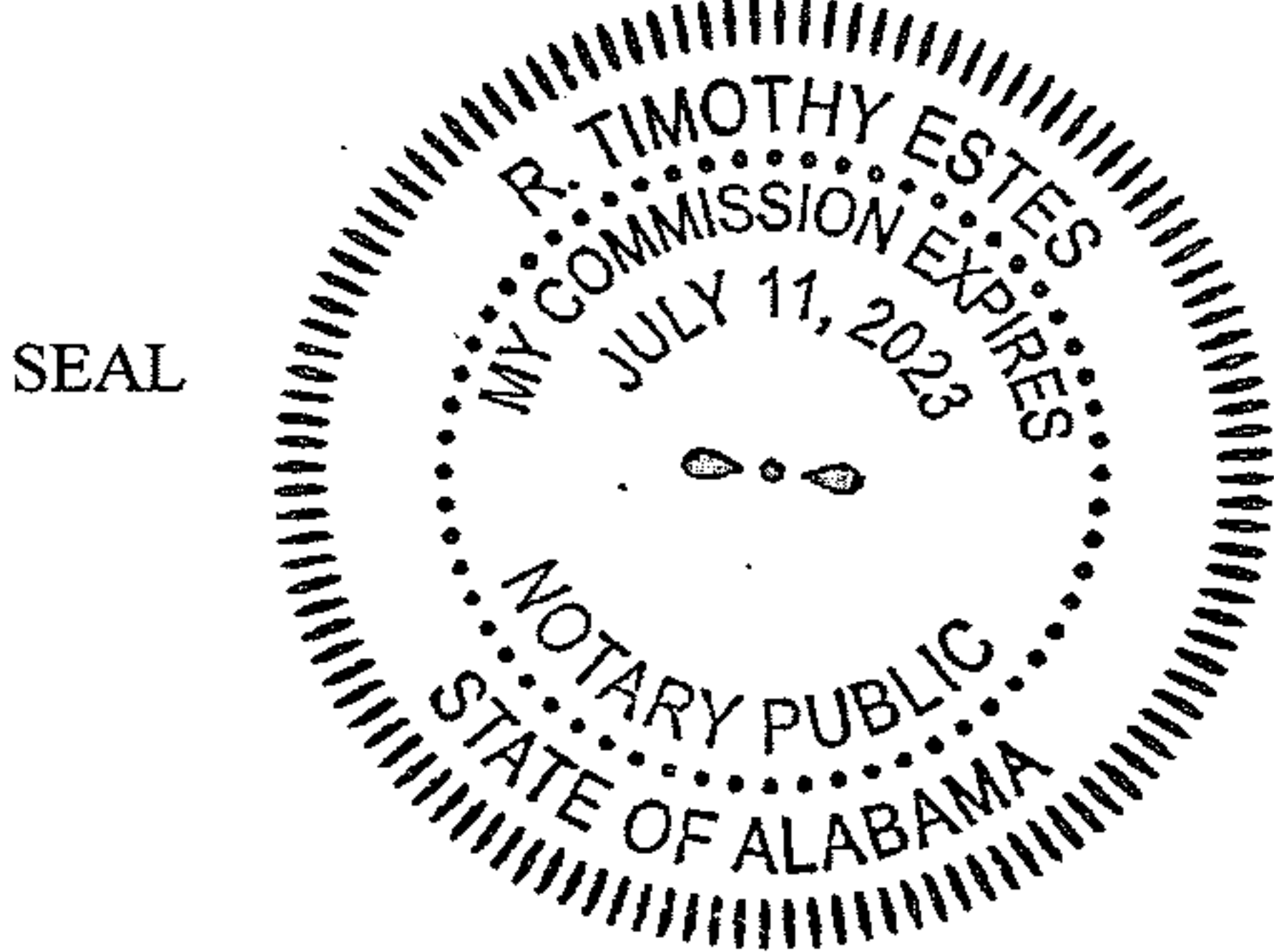

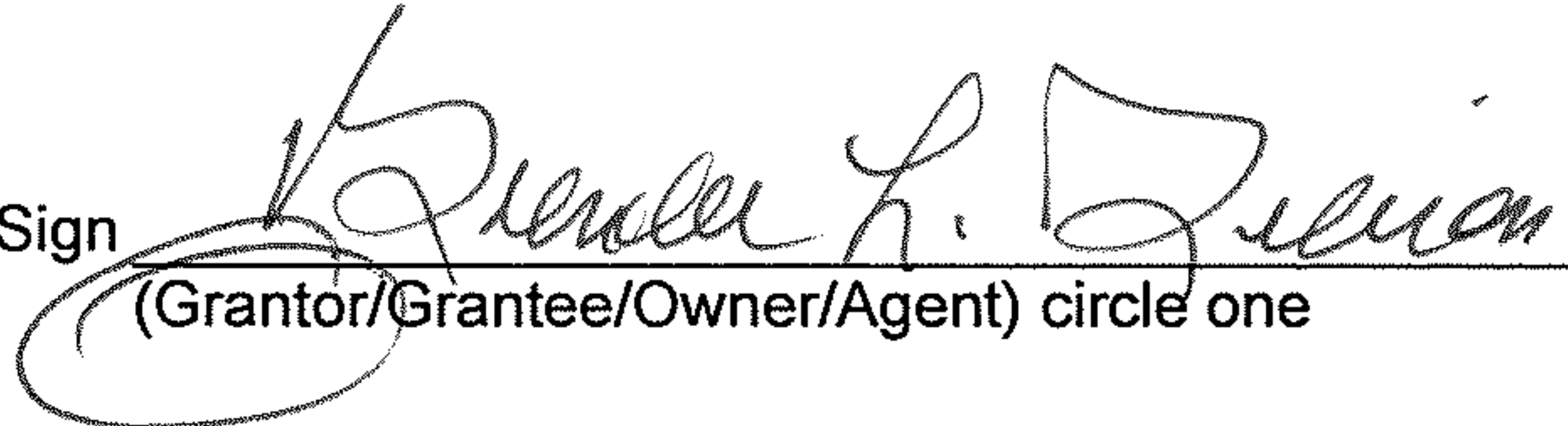
